

Oyster Growers Seek Cut In Minimum Size Of Fish

A motion requesting the department of Fisheries to reduce the legal size of marketable oysters to three inches from the present three and a quarter inches was approved at a meeting of the P.E.I. Oyster Growers Association held last evening in St. Eleanor's Hall and presided over by president Lorrie D. Beaton.

Much discussion centred on the present minimum market size of 3 1/4 inches which put into effect last year after a one-year try-out of the 3-inch size and a great deal of information on this subject was forthcoming from Messrs. R.H. Found and R.R. Logie of the Biological Station at Ellerslie.

Mr. Found said that the main reasons why the 3-inch size was originally adopted were that the Growers Association had requested a reduction from the then 3 1/4 inch market size, because it meant that oysters could be fished two years younger avoiding loss by sponge and also avoiding kill by winter ice. Mr. Found stated that at a meeting of the Fisheries Council of Canada at Ottawa he found the council was not too favourably disposed toward the 3-inch size and the limit was raised through their efforts to 3 1/4 inches. He said that if the growers had had a strong representation at the meeting, the results might have been different. He concluded stating he was happy to see the association being reorganized and every assistance possible from his department.

Mr. Logie said that from a biological standpoint, it is doubtful if reducing the size of marketable oysters would have any effect on their reproduction. He stated that many customers in the Montreal area didn't favour the 3-inch oyster and consequently neither did the restaurant owners and dealers. He said that these people made representation to the Fisheries Council and the size was increased to 3 1/4 inches. Mr. Logie concluded "I see no objection to the legal size being reduced to 3 inches."

Mr. Ray Hughes of the Fisheries

Federation, Charlottetown was present among the approximately 25 in attendance and although he stated he wasn't speaking on behalf of the federation, he suggested that the Growers Association consider affiliating with the Federation or the Fisheries Council in order to strengthen their voice when making requests to the Fisheries Department. A motion was approved by the meeting in which affiliation with the Federation will be investigated.

COMPLAINT HEARD

As a result of a strong complaint from an Enmore resident who stated that oyster bed leases have no protection from unlawful pickers who cut off bouys, tear down government signs and help themselves to the lessee's oysters, a motion was approved requesting the Department of Fisheries provide a warden for the general area between West Point and Percival River. In answer to a complaint that P.E.I. oysters are being shipped to New Brunswick and Nova Scotia for seedling purposes, Messrs. Found and Logie said that only sub-standard or non-marketable oysters have been shipped and these are being used to help seed areas where oysters have died out or have been killed. They pointed out that there is no evidence to show that by taking these sub-standard oysters to other parts of P.E.I. in any way, as all these areas have a plentiful supply of bi-valves. It was also pointed out that there is no worry from competition in the industry from New Brunswick as oyster fishing in that Province is at a very low
