Great Loss of Life and Property

THROUGHOUT GREAT BRITAIN—FATALITIES
ON THE COAST.

A London despatch says: The recent
gales throughout Great Britain were the
most destructive in years. Reports indi-
cate that many lives have been lost, and
an incalculable amount of property destroyed.
The barque Janet Crown has returned
to Plymouth. She reports that two of her
crew were washed overboard and drowned,
and many were injured.
The steamer Yorkshire, at Liverpool
from Baltimore, was flooded and her
bridges destroyed, and sustained other
damages. Three men were blown from the
rigging and two were drowned.
Menai Straits, in Wales, is rendered im-
passable by the fury of the gale. Many
sailors have been swept overboard and
drowned.
The parade ground at Sandgate is par-
tially destroyed.
The ship Irex, bound from Greenock for
Rio de Janeiro, was wrecked off the Need-
les. Several were drowned. The survivors
clung to the rigging all day Saturday and
part of Sunday. A life line was finally
shot across the vessel, and in this way the
men were safely landed.
Capt. McMicken, of the Cunarder Umbria,
from New York, reports that the vessel has
ever experienced. Several passengers were
injured by being thrown upon the decks,
and it was found necessary to issue an order
prohibiting the passengers from coming on
deck.
The damage to property is general.
Numberless houses have been unroofed.
The river Shannon, in Ireland, and a
number of rivers in Wales have overflowed
their banks, flooding adjacent property.

Sherwood Cemetery.

The annual meeting of the Sherwood Cem-
etry Company, which was held on Tuesday
evening in the Y. M. C. A. Building, was
well attended, and much interest was mani-
fested by those present in the proceedings.
The report for the past year was a very
satisfactory one, and the directors and sec-
retary received a most cordial vote of
thanks for their services gratuitously ren-
dered, and for the excellent showing they
had made for the year. The income de-
rived from burials, sales of plots and ar-
rears due on former sales, amounted to
\$155.50, as compared with \$52 the pre-
vious year. This amount, with \$81, being
the annual interest on their invested funds,
made the total income last year \$236.50.
In addition to this sum, the funds of the
company have been added to by a sub-
scription fund collected by Judge
Alley and Mr. F. S. Moore, from
which \$294 has been realized. The total
receipts for the year therefore aggregate
\$530.50. The expenditure for last year
amounted to \$216.23. Of this sum \$150
was paid to the keeper for his salary, the
balance of the outlay being incurred in pro-
viding him with utensils and implement
required to enable him to discharge his
duties. The sum of \$60.66 was also ex-
pended by the Directors in the discharge of
liabilities incurred before they assumed
office. The salary of \$50 hitherto annually
paid to a Secretary was saved to the Com-
pany last year, Mr. Henry Smith having
generously discharged the duties of that
office without remuneration. A new keeper
has been appointed, and the satisfactory
manner in which he has discharged his
duties is evidenced by the marked improve-
ment in the Cemetery grounds since he has
taken charge.

The Directors elected for the ensuing
year are: Judge Alley, and W. E. Dawson,
Chas. Palmer and R. R. Hodgson, Esqs.,
of Charlottetown, and Mr. Donald Mc-
Millan, of Central Railway. The last
named gentleman, living as he does near
the Cemetery, will be in a position to ren-
der valuable assistance to the other mem-
bers of the Board.

LETTERS TO THE EDITOR.

Tyrannical Tactics.

SIR,—Now that the smoke of the recent
battle has cleared away, we naturally look
around for the result and the means used
to attain it. You will, no doubt, be at a
loss to understand how it is that this, the
First District of Prince, should give an ad-
verse majority in the face of such encour-
aging reports as you received from us dur-
ing the campaign. But when you know
the disreputable means resorted to, to fur-
ther the interests of the Opposition, you
will marvel that the majority of Matheson
and McLellan is not even greater. The old
weapons—the ledgers of Myrick & Co.,
and Rogers and Matheson—were brought
to bear as they never were before; and
polling districts, known to be favorable to
the Government candidates, were made the
stomping grounds of the emissaries and
principals of the aforesaid concerns for
days before the elections, and their satel-
lites stood guard at the polling booths on
election day. Other means as potent, but,
if possible, more despicable, were exerted
in the western end to induce the electors to
vote for the Liberal candidates.

Why, Mr. Editor, discreditable as it may
seem, it is reported on good authority that
there were instances in which physical
force was used in this same western end
to compel electors to support the Grit
ticket, and that, too, by men from whom
you would expect better things, and whose
zeal was worthy of a better cause. We,
in this end of our district, have reason to be
thankful that we have shaken off the
thralldom of ledger influence which here, as
further west, once held such sway; and
although with us there yet remains a slight
vestige of its former greatness, as evidenced
by the vote, let us hope its evil influence
will soon be a thing of the past. Now, I
would ask you how long are the evils I have
enumerated to be allowed to continue.
Such tyranny is worthy of the Russian Em-
pire, but a disgrace to a civilized commu-
nity. It is plain to anyone that our so-called
representatives do not at all represent the
feelings of the district untrammelled by such
odious influences; and it would be blas-
phemy to apply to their election the Latin
quotation *Vox populi, vox Dei*.

assuredly the expression of an unmanly
electorate. All honor to King's! at pre-
sent our banner Conservative County, and
the pride of every patriot heart.
