A Horrible Story.
EIGHT PERSONS SUPPOSED TO HAVE BECOME
VICTIMS OF A WOMAN'S GREED FOR
MONEY.

The whole country of Lambton, Ont., is
stirred with excitement over a sensational
poisoning case, which, if evidence be given
to half the terrible stories told in connection
with it, will throw light upon a series
of the most terrible and unnatural murders
ever committed in that part of the pro-
vince. The arrest on Good Friday of Mrs.
Martha Jane Ryckman, on a charge of
poisoning her sister-in-law, Mrs. Hendricks,
has revived discussion of stories about the
suspected deaths of a number of persons,
relatives, which had previously been men-
tioned only with extreme caution. Mrs.
Ryckman is a widow, about sixty years of
age, who has lived at Theford for a number
of years with her children. It is a significant
fact that by the death of each of the
members of the Ryckman family, about
which there is the least suspicion of foul
play, Mrs. Martha Ryckman derive some
financial benefit. Eight persons in all are
supposed to have become victims of Mrs.
Ryckman's greed. Their names are as fol-
lows: Laura Ryckman, her daughter-in-
law, Mrs. Hendricks, an old lady who lived
on the farm near Theford, with her son
John Hendricks. Her death occurred last
week and was followed soon after by that
of Gray Ryckman, Mrs. Ryckman's son and
the husband of Laura. In 1876, Mrs. Ryckman's
husband was taken suddenly ill and
died. Three years later her son-in-
law, John Haskett, also died under
suspicious circumstances, leaving consid-
erable property to his wife, who was a
consumptive and did not long survive her
husband. Mrs. Haskett, when she died,
left property to prisoner to use for the
benefit of an eighteen months old girl she
(Mrs. Haskett) left. This child died about
eighteen months after her mother and Mrs.
Martha Ryckman came into the property.
Several bodies have been exhumed and
post-mortem examination has revealed
traces of strychnine and arsenic. Other
bodies are to be examined shortly. The
prisoner and all her family were widely
known in the country. They have been
well liked and looked upon as highly re-
spectable and well to-do people. The
prisoner is a member of the Methodist
church in Theford and generally took an
active part in church work. The prisoner
is said to be very much downcast since her
arrest.

The Fight against Coercion.

The London correspondent of the Mont-
real Star cables as follows on the 14th inst :
"The agitation against coercion is indeed
the people's battle. The number and en-
thusiasm of the meetings is marvellous. The
whole North country is up as in the hottest
days of the Bulgarian agitation. The meet-
ings, in the best sense of the word, are local
and spontaneous, for the great orators are
resting. The statement that a number of
English Radicals are about to conduct an
anti-coercion campaign in Ireland is without
foundation. After the second reading when
the bill goes into committee, the agitation
will become hotter than ever. Mr. Cham-
berlain, characteristically enough, has arranged
to be absent in Scotland, so as to escape vot-
ing for the second reading of the coercion bill
next Monday night. He strongly supports
the bill, of course, and would unhesitatingly
vote for it if he thought there was any chance
of the Government being beaten. This not
being the case, he desires to avoid all the
odium possible. A significant fact is that Mr.
Chamberlain's speech yesterday, for the first
time since he was made a member of the
Government, was summarized in a dozen leading English
papers, both Liberal and Tory, instead of
being reported fully. Mr. Gladstone's speech
on Monday night will deal with the whole
question of the Government proposals and
coercion. His speech at the Eighty Club, on
Tuesday night, will embody his latest revised
views on the Irish question generally. The
two orations will therefore give an exhaustive
presentation of his present attitude and the
authorized position of the Liberal party.
There is talk among Liberals of the advisi-
bility of intimating to the dissentient
Liberals that their faults in the past will be
overlooked if they vote against the coercion
bill, but this will be their last and only
chance of reconciliation with their party.
They are in a state of nervousness, knowing
that if the Government should be defeated
while they themselves are in their present
position the Liberal Union party would be
practically annihilated in another election.
Therefore such an offer, if responsibly made,
would be a powerful temptation.

A Dangerous Cargo.

The first nitro-glycerine that was ever
shipped from Europe to America was sent by
the way of Panama to San Francisco. It
came through safely. The nitro-glycerine
was rendered inoperative by being dissolved
in alcoholic ether, from which it could be
easily separated at any time by evaporation.
The only danger was that the air-tight pack-
age in which it was shipped might burst in
transportation, allowing the ether to evaporate.
This happened with the second shipment
in 1867, and the result was very disas-
trous. While shifting the cargo of the
steamer at Aspinwall, a box of caps was
dropped among a lot of leaking cases of nitro
glycerine. The resulting explosion shattered
the steamer to atoms and killed 100 natives
and many others.

During the session of Parliament, when
the representatives of the people are as-
sembled, there are constantly on duty
183 policemen and about the two
Houses. Of these there are 3 inspectors
and 8 sergeants. The cost would be £17,-
000 per annum if the House sat all the year
round. If the House took holiday for a
year, the cost would be £9,400.

The Lansdowne Evictions.

(Montreal Star.)
An attempt is being made to create a pre-
judice against the Governor-General on ac-
count of his dealings with his tenantry in Ire-
land. He is described as a merciless land-
lord who turns his poor tenants out of their
miserable hovels leaving them no shelter but
a hedge by the roadside, because in these poor
times when the price of farm produce is so
low, they are unable to pay their rents. But
when Canadian readers know the truth about
the evictions on Lord Lansdowne's estate they
will see that they are being imposed upon and
that their pity and their sympathy are thrown
away upon men who, according to Canadian
ideas, are deserving of neither the one nor the
other.

In the first place these evicted tenants are
not poor men or mere tenants at will. They
are well-to-do farmers holding under lease.
They live in comfortable houses and are in
the enjoyment not only of every comfort but
of luxuries that but few people even in this
country have the privilege of enjoying. This
is a description of the house and grounds of
one of these evicted tenants with whom Can-
adians are asked to sympathize: "His (Mr.
Dunne's) lodge is a two story building, which
would do credit to any hibernian park, and
the avenue up to the house leads through
some undulating grounds, charmingly wooded,
with a small piece of ornamental water lying
in a hollow. The house stands upon a
plateau with flower beds in front. It is a
large building with an excellent drawing
room and dining room and a conservatory
opening out into the latter. Upstairs there
are a number of excellent bedrooms and a
bath room and a lavatory with hot and cold
water turned on." The outhouses are all on
the same scale as the mansion, and the fine
old Irish gentleman who, until very lately,
lived in it is the owner of race horses, one of
which has the significant name of "Campeign."
The occupant of this handsome place was Mr.
J. W. Dunne, late Justice of the Peace. He
is the principal tenant on Lord Lansdowne's
Queen's County estate. His farm consisted of
1,281 acres of good land, and the rent which he
convenanted to pay was \$835. The landlord's
book shows that the owner had expended on
this property within the last twenty-five
years \$13,125. The property rented by Mr.
Dunne consists of five farms. Half a year's
rent of these, \$2435, was due in May.
When the sheriff was authorized to seque-
strate, and receive payment of one half
year's rent with an abatement of fifteen per
cent. The offer of the abatement was made
when the rent became due. The tenant re-
fused this offer more than once.

Mr. Kilbride, the other evicted tenant, oc-
cupied premises not so magnificent as those
of Mr. Dunne, but very comfortable. He has
two holdings under lease, making together 708
statute acres, the rent is \$3800. The house
he lived in is a large building of two stories,
containing several excellent rooms. There is
a tennis lawn near it for the amusement of the
family. He was offered an abatement of
twenty per cent. by Lord Lansdowne, but he
refused on the ground that the same terms
were not given to the tenants on the whole
estate.

If all the tenants in Ireland were like these
two gentlemen farmers on Lord Lansdowne's
Queen's County estate who refused to pay
their stipulated rent and reject the liberal
remission made by their landlord, very little
indeed would be heard of the Irish Land Que-
stion on this side of the Atlantic. If Mr.
Dunne and Mr. Kilbride had rented farms of
equal value on the Island of Montreal and had
refused to fulfil the conditions of their leases
they would have been proceeded against by
their landlord as a matter of course and no one
would have dreamt of reproaching him with
being harsh or exacting. Not only did these
gentlemen farmers refuse to pay what they
had agreed to pay, but they did their best to
persuade the other tenants on the estate to
withhold payment of their rent until the
landlord should agree to the terms which they
saw fit to propose.

The tenants on the Queen's County estate
adopted the Plan of Campaign because Lord
Lansdowne refused to allow a scale of
abatements identical with that allowed to his
tenants on the Kerry estate. But the tenants
on the two estates are in very different cir-
cumstances. Those on the Kerry estate are
almost, without exception, the occupants of
small holdings in mountainous country, who,
besides, have suffered exceptional losses. The
tenants on the Queen's County estate occupy
large farms and appear to be in much more
comfortable circumstances. In making a dis-
tinction in favor of the Kerry tenants, Lord
Lansdowne did what was considerate and
human, and, no doubt, if his Queen's County
tenants were in the same circumstances they
would have been treated with the same indul-
gence.

The Queen's County estate appears to be an
exceptionally valuable one, and one on which
large improvements have been made by the
landlord. Evidence was given before the
Royal Commission that during the past
twenty years Lord Lansdowne and his pre-
decessors have spent in improving it one hun-
dred thousand dollars. The addition made to
the rental on account of this expenditure, of
which the tenants have all the advantage, is
\$1500 a year, or only one and a half per cent.
of the outlay. This is certainly not extor-
sionist. The nature of the relations hereto-
fore subsisting between the tenants on the
Queen's County estate and their landlord may
be inferred from the fact that, previous to the
present agitation, there has been only one
eviction on that estate for non-payment of
rent during the last twelve years.

We think that when the facts connected
with the evictions on the Lansdowne estates
are generally known, the people of Canada
will come to the conclusion that the Govern-
ment is the reverse of a harsh and exacting
landlord. We believe, moreover, that those
who are endeavoring to lower His Excellency
in the estimation of Canadians on account of
his treatment of his Irish tenants, will do far
more to weaken their sympathy for the Irish
tenantry than they will to injure Lord Lan-
sdowne.
