The Subway.

It is pleasing to learn that the Dominion Government have been prompt to act on the suggestion of the Earl of Granville, and that—as reported some days ago—Vernon Smith, C. E., with his staff, is about to make a proper survey of the Strait between Capes Traverse and Tormentine.

Mr. Campbell and His Opponents.

The opponents of the Government are using means fair and means foul to secure the defeat of the Hon. Mr. Campbell. They cannot indulge in the hope of ousting either Mr. Sullivan or Mr. Ferguson, so they are concentrating their efforts in a vain endeavor to dislodge the Commissioner.

Mr. Campbell is fighting the battle pluckily. He proves beyond a doubt that the Government has done well. He claims that there are still amounts due the Province which should be collected before a tax is put on, and he shows that the men who have successfully exerted themselves to obtain an adjustment of our claims on the Dominion are the men to entrust with the fulfilment of the work.

Getting Excited.

The Cape Ann Advertiser says: "From reliable sources of information at Washington we are led to believe that now is the critical time, and it behooves the American Fishery Union, and all interested, to exercise the utmost vigilance. Free fisheries and free fish are much talked of in diplomatic circles in Washington, as the solution of the fishery difficulty. It is intimated that Secretary Bayard would be willing to make an arrangement of that sort with the British Ambassador, and the latter, it is well known, greatly favors such a settlement. This is what Canada wants, and has wanted, and for this she risked seizing our vessels, in hopes to drive us into it. For her, to secure free fish at the cost of free fisheries would be the great desideratum. What she wants is the American market free, and that gained she cares nothing about fishing grounds, fishing rights, headlands or bays. Let this be remembered. It is the same old game of England's over-reaching, and the State Department must be on its guard or the wily diplomat who represents Great Britain will again have his own way."

The Boston Journal correspondent writing on this subject concludes as follows: "The people of New England want to be put on their guard against any startling new departure which will seem to have gained something for Americans, when it will, in fact, be only a proposition to give Canada the market she so much desires under the cry of 'free fish.' Let the above caution be heeded and a protest at once be made against any such settlement."

The Advertiser and Journal are excited. But, no doubt, they represent truly inflated idea the people of the United States have of the importance of their markets to Canadians and the world. When the States caused the abrogation of the Reciprocity Treaty they imagined that the loss of their markets would force "the Colonies" to join the Republic on easy terms; but the result was Confederation under which "the Colonies" became one prosperous Dominion. They imagine now that they can obtain free access to the Canadian fisheries by simply giving a free market for the fish Canadians have to sell. They are mistaken. The right to fish in Canadian waters is worth far more than the right to sell in American markets; and while Canadians would be willing to give fair value for a relaxation of the prohibitory duties imposed by the Republic, they are not willing to give up their fisheries for the privilege of selling the surplus of their catch in the United States markets. In return for the fisheries, Canadians ought to have from the Americans, not a free market for fish only but a free market for potatoes, horses, butter, and other articles.

THE CAMPAIGN.

Rustico is reported solid for McKay and Bain. A large and (to Conservatives) very satisfactory meeting was held in New Glasgow Hall on the evening of the 17th inst. The current is moving strongly in favor of McKay and Bain.

THE OUTLOOK IN KING'S.

A King's County correspondent writes: "Murray Harbor District all right. Prowse and McLeod are sure to be elected. Premier Sullivan's election also sure. Intelligent Opposition men admit that he will be a long way ahead, with Underhay next, Georgetown sure. The prospects in Cardigan are excellent. McDonald and Shaw are two popular men, and will, it is confidently believed, be at the head of the poll on election day. The East Point District is strong for the Government candidates, McLean and McEachen. Men who voted for the latter last year, see no reason why they should not vote for him this year. A merchant and a farmer will make a desirable pair to represent the First District. McLean and McEachen are popular among the farmers in their section of the country, and are sure to defeat their opponents on the 30th."

Methodist Conference.

SACKVILLE, N. B., June 16.

FIRST DAY—AFTERNOON SESSION. The first part of the afternoon was occupied by a ministerial session for the examination of characters. The regular Conference session began at 4 p. m. Minutes of mornings read and confirmed. Rev. W. J. Kirby, secretary of nominating committee, presented report, which was received and in part adopted. Rev. James W. Taitte is to be received into full connection and ordained. The following probationers were reported: Revs. Robert W. J. Clements, G. F. Dawson, having travelled two years; Revs. Alonzo B. Calder, Allan P. Taylor, Neil McLaughlan, one year. Rev. A. C. Bell's name was reported; he having permission to attend Boston University for another year. The following were accepted as candidates: Messrs. Walter A. Taylor, B. A. William C. Matthews, George E. Lock, Frank Frizzle, Thomas R. Wright, of Seartown, P. E. I. On motion of secretary a telegram of greeting was ordered to be sent to the Nova Scotia Conference. Revs. R. W. Weddall, B. A., and G. B. Payson, were appointed a committee to arrange for a fraternal visit of the two Conferences.

MISSIONARY MEETING.

The Annual Conference Missionary Meeting was held in the evening, Dr. Williams presiding. There was a fairly large audience and good singing. After singing, Rev. H. Daniel led in prayer. Dr. Williams made a masterly address. He showed that the Methodist Church had been essentially Missionary from its inception. He spoke of the great changes that had been effected during the last few years, many of which were largely brought about by Missionary effort.

Rev. E. Evans, Secretary-Treasurer, gave the report. From this Conference the following amounts had been raised:—

Rev. R. W. Weddall read reports of Women's Missionary Societies of Sackville and St. Stephen.

Rev. Job Shenton spoke of an enthusiastic Missionary Meeting which he attended in England, when Owen Watkins, from South Africa, and Ebenezer Jenkins, lately returned from a tour in India and China, moved the vast audience by their thrilling accounts of Missionary wants. He made special mention of our rapid extension in these Provinces, and finished by advocating the inauguration of a Sustentation Fund. After the collection was taken up, Rev. John Read made an effective speech. He referred to the development of Methodism, from her little Societies to the Church that she now is. He urged the necessity of adaptation and progress.

After singing the Doxology, Rev. J. V. Jost pronounced the Benediction.

SECOND DAY—THURSDAY MORNING.

After singing the Secretary read the Scriptures, and Hon. W. G. Strong and Rev. J. A. Clarke, A. M., led in prayer. Minutes of last session read and confirmed. Dr. Stewart presiding, Conference then passed on to the order of the day in consideration of who were the Supernumeraries. The following names were reported: Rev. G. B. Payson, Henry Daniel, J. R. Naraway, A. M., H. Pope, D. D., S. W. Sprague, W. Tweedie, H. Pickard, D. D., J. Prince, C. W. Dutcher, J. V. Jost and F. Smallwood. The following supernumerary ministers return to full work: Thomas Allen and W. R. Pepper.

Before taking into consideration, "Who have died during the year," the Conference sang:

"Come, let us join our friends above Who have obtained the prize."

Rev. F. Smallwood and C. Comben led in prayer. Rev. A. R. B. Shrewsbury had died immediately after leaving last Conference. His death was triumphant. Rev. F. Smallwood, E. Price, Esq., Rev. J. Howie, J. Read and the President spoke about the work of the deceased.

The Rev. Edwin Mills had died on December 14th, 1885. Revs. J. Howie, F. Smallwood, L. S. Johnson and A. Lucas spoke in terms of approval of the character and work of the deceased. At the conclusion of this service the conference sang:

"This blessed word be mine Just as the port is gained."

The following were given permission to attend Mount Allison College: Revs. Robt. W. J. Clements, Wm. C. Matthews, G. F. Dawson and Neil McLaughlan. Rev. W. J. Kirby presented remarks of nominating committee.

Rev. E. Evans was elected the ministerial and W. E. Dawson, Esq., the lay members of the General Supernumerary committee. During the rest of the morning session a good deal of routine business was disposed of. After singing the doxology the Secretary pronounced the benediction.

The Suicide at Tracadie.

EVIDENCE AT THE INQUEST.

On Saturday afternoon Coroner McLeod held an inquest in the Schoolhouse at Grand Tracadie, on the body of Mrs. Joseph McAulay, the unfortunate woman who committed suicide by hanging on Saturday morning. The following is the evidence taken:—

JOSEPH MCAULAY (sworn).—I am the husband of the deceased. When I came home last night she appeared in her usual state of mind. She had been in an inmate of the Lunatic Asylum and came home from there about two years ago. She was pretty well when she came home, but about a month and a half ago, she became a little droll, and at times used to talk very foolishly. Last fall she left the house, and we thought she had made away with herself, but she came back of her own accord about one or two o'clock in the morning, and would not tell me where she had been while she was away. Since a month ago and before that she was always wishing she were dead and talking very foolishly. I often heard her say she would hang herself, and I always felt anxious lest she should do so. As my two daughters were at service, and I had to be away at work myself, my wife was often alone. I came home last night about eight o'clock, and my wife gave me my tea. She went to bed with the two children, then I fell asleep. I awoke before six o'clock this morning and called my wife. Getting no answer, I went down stairs and saw her hanging from the beam of the shed adjoining the porch. Before I left home yesterday morning there were no angry words between us, neither were there any when I came home at night. Two days ago I asked her to send the boy to buy molasses, and she told me I had better save my money to buy craps. Then I thought she was certainly getting worse. (Rope produced.) I missed this rope about a week ago, and asked my wife and the boys where it had gone to, but could not find out. I was then suspicious that she intended making away with herself. She was always more or less melancholy.

JOHN R. McDONALD (sworn).—I saw Mrs. McAulay about sundown yesterday evening. I went into her house. She told me that her husband was down at Mr. T. W. working, but said nothing about herself. She appeared to me to be about as sensible as ever I saw her, and talked quite rationally. I did not ask her how she felt.

WILLIAM MCLAUCHLIN (sworn).—I went to Joseph McAulay's about half-past six this morning in company with Angus McDonald. John Small McDonald was there when we arrived. When Michael Ready arrived he told us to cut her down. I raised her up and John Small McDonald cut the rope. I did not touch the body but took hold of her by the clothing. I could feel that she was cold through the clothing. Her head and face were covered with a cloth before we cut her down, and her feet were about three and a half feet from the floor.

JOHN SMALE McDONALD (sworn).—I arrived at Joseph McAulay's house before six o'clock this morning. I met McAulay a short distance from the house, and he told me that his wife had hanged herself. I went straight in to where she was not knowing but that life might be in her, but I found that she had been dead for some time.

EMILY WATTS (sworn).—I saw Mrs. McAulay yesterday, and she appeared very melancholy. She was lamenting a good deal, and seemed to be in despair about her future salvation. She thought there was no hope for her, and said it would be better for her if she were out of this world, as she was no use to herself or to those who were around her. I heard her talk in this way so often since she came home from the Asylum, that I did not pay any particular attention to her yesterday.

The deceased, Matilda McAulay, came to her death by hanging herself while suffering from insanity.

The exhibition of plain sewing, the work of the pupils, would reflect credit on more pretentious institutions. It was really delightful to see this fine display of needlework.
