

Juvenile is Arraigned In Magistrate's Court

SUMMERSIDE — A Summerside juvenile, Joseph Godfrey Souter, appeared in police court yesterday on a charge of intent to wound, causing bodily harm to LAC Keith Douglas Rysat.

The youth had been in juvenile court on Wednesday in connection with this charge, before Judge W. E. Darby, who ordered him transferred to town magistrate court for trial, where two other youths, George Clair Paynter, 16, of Summerside, and Richard Joseph McInnis, 15, of St. Eleonors were also awaiting trial on a similar charge in connection with the same incident.

The case of Souter was highlighted yesterday by strong objections on the part of his counsel, Neil MacLeod, against moving it from juvenile court to magistrate's court for trial.

Argument on the matter by Mr. MacLeod became so intensely argumentative that at one point Magistrate R. S. Hinton said he wanted the attorney putting words in the court's mouth, and warned against being in contempt of court.

Crown Prosecutor George R. McMahon made reference to legal precedents for the procedure used in moving the case to magistrate's court.

Police Chief Donald Wannamaker said the move had been suggested by Judge Darby and presented the judge's written decision for the transfer, which he held to be in the best interests of the accused and the court.

After considerable discussion the case was adjourned to Monday, July 29, at the request of Mr. MacLeod, who indicated he will seek a Supreme Court writ to have the case against his client returned to juvenile court.

The accused was remanded in the custody of his father. There are no facilities at Prince County Jail for the detention of juveniles.

TWO OTHERS

The two other youths facing the same charge, Paynter and McInnis, were also remanded to Monday, after Paynter had elected trial by judge without a jury, and the start of preliminary hearing in magistrate's court was set for July 29. He was remanded in custody with bail set at \$500.

McInnis, also remanded in custody, pleaded not guilty and elected summary trial before Magistrate Hinton.

The charges resulted from an incident on Notre Dame Street in Summerside early last Sunday morning when an airman from the Summerside RCAF Station, LAC Keith Douglas Rysat, is alleged to have been stabbed in the stomach when he declined to give cigarettes to a trio who approached and demanded them.

Rysat, bleeding profusely, collapsed on the street from where he was taken to Prince County Hospital, in Summerside, later transferred to the station hospital, and has since been released.

Then in Paris, President de Gaulle's government reaffirmed that it would not be bound by the agreement in its efforts to make France an independent nuclear power.

Communist China, striving to enter the nuclear club, had denounced the treaty in advance at the same time it was drawing farther away from its Communist world alignment with the Soviet Union.

In Washington, President Kennedy moved quickly to marshal American opinion behind the treaty to give impetus to the "administrative" drive to win the two-thirds support in the Senate necessary for ratification.

PRESIDENT WILL SPEAK

The White House announced the president will speak Friday night on the agreement.

Right up to the installing, it had been feared negotiations might founder on Russian demands that the treaty be associated in some way with a non-aggression pact between the North Atlantic Treaty Organization and the Communist Warsaw pact nations.

The U.S. and British delegations opposed the Russian stance. They insisted that they would need the consent of all 15 NATO nations for a non-aggression pact and this would delay—if not make impossible—a partial test ban accord.

The initial ceremony was held up for four hours while the delegations argued, presumably over this issue. But finally the treaty was initiated independently.

Then 100 reporters and photographers who had been waiting outside Spiridonovka Palace were invited to witness the closing ceremonies. Gromyko set the tone by telling them: "Let us consider this as a basis for further steps."

LIVED TOGETHER

Ward admitted Miss Keeler, 41, lived with him.

"I admired Christine," he said. "She was cheerful company."

But he said her behavior that he induced her to procure girls for him were not true.

"Like most people, she tells a story often enough and she seems to believe it," he said.

Ward openly questioned Christine's testimony that she shared her favors with Soviet naval attaché Yevgeny Ivanov while she was going with Profumo.

It was this situation that originally jolted Prime Minister Macmillan's government, led to Profumo's resignation, and prompted a committee of inquiry that still is in progress.

James Burge, counsel for Ward, referred to "the impetuous Russian called Ivanov, who apparently had intercourse with Christine on one occasion."

"I have only Miss Keeler's word for it," Ward said. "She told me she would like to have intercourse with him. I have always believed she never did."

Ward said Mandy, 18, also lived with him at the time.

DENIES TESTIMONY

HAIL TREATY

NOT MENTIONED

The agreement omits underground tests, but makes no mention of inspection or controls.

As for underground tests, the three powers agreed that nothing in the treaty should prejudice "conclusion of a treaty resulting in the permanent banning of all nuclear test explosions, including all such explosions underground, of this treaty, they seek to achieve."
