OUR WINTER BUTTER OUTPUT.

We learn that 1,564 pounds of butter were made at the Central Creamery yesterday. One thousand lbs. of this was put up in six pound cans, made air tight, nicely labelled and packed for shipment south. The output this week will be about 5,000 pounds. It is being sold as quickly as it is made at 20 cents per pound. This should be an inducement to our farmers who have milk to send their milk to the creamery or separating station and encourage all dairymen to feed and care well for their milk cows. In another column we give the Toronto and London, Ont., market reports for butter and cheese.

AN OUTRAGEOUS PROCEEDING.

The railway authorities are able to deal with charges of wrong-doing in office brought against officials of the Government railways. It is their duty to do so, they are paid to do so, and discipline requires that they shall do so. Under the late administration the railway authorities tried and disposed of the charge of offensive partisanship brought against a prominent official doing duty in this Province. But the present government have taken the trial of similar charges out of their hands and have appointed certain lawyers, friends and relatives of the Ministers and those stand at the Ministers' back, to be a kind of roving commission to go up and down the Intercolonial Railway and investigate the charges preferred against railway officials by those who want to get their places! Of course, the cost of the commission must come out of the pockets of the taxpayers. But, then, "Business is business," and the Minister's legal friends must be provided with fat jobs at the public expense.

GOVERNMENT RAILWAY EXTENSION.

It is announced that the Government have purchased eighty miles of the Baie des Chaleurs Railway, notorious in connection with the "Big Steal." But silence is maintained concerning the amount of the purchase money and the prospects for traffic. We venture the opinion that an additional burden has been placed upon the taxpayers of the province. "Business is business" it is also quite possible that those who managed the sale have taken care to get back at least some part of the \$200,000 which the gentle Pacaud has been condemned to refund to the Government of Quebec.

MR. SHAW'S LETTER.

MR. CYRUS SHAW, in the letter published by THE EXAMINER of to-day, gives expression to the popular voice in respect to the lamentable condition of our public finances and the scandalous violation of the pre-election promises of the Government. But he is not in agreement with Mr. Stewart as to the course to be pursued for the rescue of the Province from financial ruin. He thinks that the cost of education must continue to be drawn, for the most part, out of the public treasury, and that the standard of education must be maintained so that our youth may be fitted for the race of life wherever they may live. In this regard Mr. Shaw represents, without doubt, the major part of our population. We all appreciate the advantages of good education for the people at large. Still as a man who is compelled to reduce his establishment has usually to make retrenchments in respect to matters which are dear to his heart, so the people of this Province may be compelled to relieve the public treasury of expenses which they would much sooner see maintained. The whole matter of Provincial reform and economy ought to be carefully thought over and discussed not alone by our politicians but by the people at large. Then, a convention of the people's delegates ought to be held, and a plan, policy, platform, call it what you will, adopted and carried out.

FEARFUL OF NEMESIS.

HAVING by means of sectarian agitation and a successful attack upon the constitution of this country obtained control of the Federal Government, the Liberals are now very anxious about "peace and harmony." The Globe has expressed the opinion that "there ought to be an end of sectarian agitation not only as regards Manitoba but as regards Ontario," etc. "We are in no way so let's have peace; don't you see now let it be settled into us as we have meted out to others,"—this is the present prayer of the ministers and those connected with them. But the Globe has been thrown into a state of trepidation by the Hamilton Spectator which says: "We would respectfully remind the Toronto Globe that if the basis of settlement in the Manitoba school question is as it has often been declared—'satisfactory to all sensible people,' the Separate School system in Ontario cannot be satisfactory to sensible people."

We believe the people are no more desirous of an agitation against Separate Schools here than of an agitation for the restoration of Separate Schools in Manitoba."

WEST PRINCE CONTENTED ELECTION.

W. Sharp Larkin vs. Edward Hackett. His case was opened on Tuesday before His Lordship Chief Justice Sullivan and Mr. Justice Fitzgerald. Messrs. A. Peter and H. C. Macdonald appeared for the plaintiff and Mr. W. S. Stewart, Q. C. and Neil McQuarrie, Q. C., for the respondent. S. F. Perry, Acting Inspector of Fisheries, was present taking notes for the Toronto Globe. The courtroom was crowded to the very doors, standing room not being afforded even for half those present. Hundreds could not gain admittance. John Gaffney, Esq., High Sheriff, and Frothingham Longworth are present in their official capacity and Hon. Sewar Ferguson, P. C., and A. McQuarrie, Esq., Superintendent P. E. I. R., on service. The leading men of both political parties are out in force. Tuesday was a holiday in the Catholic Church and the large congregation attending Sacred Heart Church swelled the numbers at the court very considerably. In the afternoon Father Burke occupied a seat within the rail.

THE RESPONDENT IS CHIEF.

The respondent is chief of the petitioners with forty-five distinct offences against the law, either personally or by agents committed. Only two were disposed of on Tuesday—two of the heaviest, but certainly nothing to void the seat. The examination demonstrated the fact that at least many of the charges are shots in the air. The interesting question of agency was argued by Mr. Stewart and Mr. Peter in the second case in which Wm. P. Callaghan was said to be an agent of respondents. This was disproved and the case dismissed. A great deal of time is being taken up with the examination of witnesses and arguments of counsel. The Chief Justice made several attempts to curtail this, but it went on about the same. Nobody expects to see the end of the trial this week. Making the Farm Home Attractive.

Town life has many attractions that cannot be enjoyed in isolated farm life under present conditions. Hence many persons living in the country long to remove to the town, and do so upon the first opportunity. The country resident leaves the pure air, nature's beauties, the open fields and freedom of farm life for a pent-up residence in the thickly settled town, where he can scarcely breathe or step without interfering with his fellow mortals; where high walls confine his vision and stagnate the air, and the innumerable marts greet his sense of smell and disorder his system. Why this town attraction? It is the loneliness of country life! It settled down like a dreary fog upon the boy, upon the girl, upon the mother, and upon the father. If, in some manner, this condition of loneliness can be changed you solve the problem of the trend of life to the city. The attractions of the country life are many, but the isolation from congenial associations robs it of much pleasure that the people desire to enjoy. Some things may be done that will, in a great measure, relieve the country life of much of its loneliness. One of the first remedies suggested is the advent of good roads. This makes the access from neighbor to neighbor and from town to town easier, and affords a visit, or on business, would be a pleasant change. The town friend would frequently call on his country acquaintance in a social way or on business. Thus the meeting of our kind would be the much more frequent occurrence than at present. But this is not all. The moving of farm products would be facilitated and cheapened and made much more pleasurable. The farm would also enhance in value. Then, above all, would come the free gathering and delivering of daily mail. Already this has been tried successfully in parts of the United States. In this way the farmer would get in touch with the world by correspondence, and the daily paper into his home. Before he went to his couch at night, he could put himself in the movements of the whole world. The stay-at-home would know what his fellow man was doing, and keep in touch with the world's progress. His business and conveniences would be greatly facilitated by the daily receipt and despatch of enquiries and answers, by the daily forwarding and receipt of letters, market reports, etc.
