I consider this statement rather a failure, because it does not go further back than the year 1873—not a long while ago—although I quite agree with him in his conclusion that the city has an undoubted right to the roadway either inside or outside shore front as the corporation may think proper, but I consider that the city has an undoubted right not only to the shore front but also to the farm and grounds of the Government House. Many persons hold the opinion that because the Government have held these lands so long that it gives them an undoubted right of possession. I say that they are wrong. Possession by holding twenty years does give title to the holder in relation to the claim of private persons. It is different with the public. No time of possession can bar the public from a public right, no matter how long that right may have been in abeyance.

It is necessary for me, in order to establish my opinion, to refer to that part of the history of Government Farm, &c., prior to the time quoted by your contemporary the Guardian. When the site of Charlottetown was fixed on for the capital of the Island, and laid off agreeably to the royal mandate by Colonel Holland, the land now claimed by the Province was not an obstruction on the sidewalk. While I will not undertake to pronounce a positive opinion on this much vexed question, I will advance some reasons and facts to show that an opposite view to that held by these gentlemen may be correct.

First, we must decide with certainty what is the shore. Webster gives as the legal definition of the word, "The space between high water and low water mark." It will be generally admitted that the front of the shore is that looking towards the sea, and that the bank is back of the shore. It follows that the shore front given by the legislature is 100 feet of land between high and low water mark. Had the legislature intended to give a part of the former, they would not have said "100 feet running along the outside of the existing bank," but "100 feet running along the inside of the existing bank." It will be remembered by those who heard this matter discussed in the House, that it was intended that a breastwork should be built to preserve from encroachment by the sea the present bank. I think that the intention was to give the citizen the right, instead of petitioning the Council to spend thousands of dollars in appealing to the Supreme Court of Canada, they had petitioned the Legislature to grant time sufficient to build a breastwork and make a roadway.
