about increasing Chinese Communist arm shipments to the Indo-China theatre. Dulles and Lord Salisbury "noted with great satisfaction" the new proposals made by the French government to the three Indo-Chinese states which are aimed "toward completing their sovereignty and independence."

South Korea's armed forces also came in for kind words from foreign ministers. In their final communique, the ministers proposed that the Big Four foreign ministers arrange nation-wide elections in divided Germany, set up a single government there and conclude an Austrian peace settlement.

American officials said written invitations would be sent to Moscow within two or three days suggesting that the conference be held in late September or October.

President Eisenhower, they indicated, might agree afterward to meet with Russia's premier, Georgi Malenkov, and British and French leaders if the foreign ministers first succeeded in settling the German and Austrian problems.

Coldwell, C.C.F. national leader, was resumed after this meeting but was further adjourned without having reached a decision as to the selection of a candidate, although all members present at the meeting indicated a desire to have a C. C. F. standard in the contest.

Police Report At Council Meeting

At the regular meeting of the Summerside Town Council held on Monday evening, the report of the Police Department was submitted by Councillor Clarence Steele as follows: Intoxicated condition, arrests 51 (convictions 51); ability to drive impaired 6 (convictions 6); theft 1 (dismissed 1); speeding 1 (conviction 1); vagrancy 1 (conviction 1); assault, 2 (convictions 1, dismissed 1); total fines and costs collected \$1,061.00; dog licenses \$30.00; miscellaneous \$928.00; building permits \$38.00; parking meters collected \$562.00.

Councillor Sheen reported that a recommendation had been received from the Chief of Police Peter R. White that hospital authorities had suggested that posters be placed in the hospital section asking all parties driving in that vicinity to make as little noise as possible.

The Chief of Police also informed the council that all the prisoners who had been giving the police so much trouble during past months had been sentenced to terms in the Dorchester Penitentiary.

True Bill

adjourned to the next sitting of the Supreme Court in November. The appeal of Seymour O'Brien, Georgetown Royalty, charged with selling intoxicating liquor, was also heard. The conviction was upheld, but the sentence was amended to a fine of \$300.00 and costs, or three months in jail. Mr. Hestian appeared for the Crown, Mr. J. O'Donnell for the accused.

At the opening of the court, the Grand Jury was called, and after it had selected its foreman, it was sworn as follows: Foreman, Joseph Campbell, Poplar Point; Winston Birt, St. Peter's; Frank Coyle, Montague; Stewart McEwen, St. Peter's; C. A. Shaw, Montague; Harold Coffin, Cherry Hill; Hugh MacPhee, Canavay; Angus Matheson, Glen William; Albert Acorn, Dundas; Wilbur Webster, Marie; Ernest Rossiter, Morell; Earl MacDonald, Gardigan.

The following is a synopsis of the charge to the jury: In charging the Grand Jury Mr. Justice MacGuigan pointed out that the great object of the institution of the Grand Jury was to prevent persons being called to answer alleged crimes without reasonable grounds to believe that the proceedings of the Grand Jury are conducted in private so that a suspected person may not, without reasonable proof of guilt, suffer the mortification of public trial.

The function of a Grand Jury is to investigate all charges of indictable offenses, and if satisfied that a prima facie case exists, to make a formal accusation known as the indictment.

After charging the Grand Jury on their general duties the court read the sheriff's report: A total of 101 cases in King's County Court: murder, 1; wounding, 1; theft, 5; causing a disturbance, 2; obstructing police officer, 4; vagrancy, 6; reckless driving, 1; selling intoxicating liquor, 1; operating a motor vehicle while impaired, 20; intoxicated in a public place, 60.

His Lordship then presented to the jury two bills of indictment. On these charges, he said, "you will bring in a true bill or the bill." He explained that it was the duty of the jury to examine witnesses. If sufficient evidence was presented, a true bill was to be brought in. If, on the other hand, after examining all the witnesses whose names were submitted, not sufficient evidence was presented, a "no bill" might be brought in.

He warned the jury that they were not trying the case, but were merely to determine whether there

Health Plan Foremost Plank In CCF Program

Mr. M. J. Coldwell, national leader of the C. C. F. Party, told a public meeting held in Summerside last evening that a comprehensive national health plan to take care of the needs of the Canadian people was foremost in the program supported by the C. C. F.

He said there is no single measure that will aid the Canadian people more than the introduction of this "long needed health plan financed on the basis of ability to pay."

He referred to C.C.F. efforts towards this end and reviewed the progress made in the field of health, medical and hospital care, by the C. C. F. provincial government in Saskatchewan. He said all parties had now followed the lead of the C.C.F. in their support of a national health program and that it would surely be implemented by the next Federal Parliament.

He said this was a position the other parties had to take for the purpose of securing votes, "but he added, "that's all right with us, as long as we get the national health protection for the Canadian people, we don't care very much who takes the credit for it."

Speaking in support of forward prices for stability in agriculture and the effect of freight rates on Maritime economy, he said that freight rates had advanced 98 per cent since 1947. He referred also to C.C.F. efforts to have the Canadian Government recover the British market for agricultural produce.

He stressed the lasting importance of agriculture in the Canadian economy and said that while other national resources are depleted with time, the soil, when well cared for and conserved, is the one inexhaustible asset.

Referring to transportation, Mr. Coldwell said we should adopt a policy whereby transportation is looked upon as of national importance and that the government should go beyond fifty per cent on the Trans Canada Highway construction costs.

Mr. Coldwell said the C.C.F. had no criticism of making expenditures on defence in view of the world situation and the party has supported defence appropriations while insisting that they should be economically spent. But he added, "such was not always the case."

Speaking of the role played by the C.C.F. in Canadian politics, he said the party's efforts have been very worthwhile in laying the foundations for public health and social security now enjoyed by the Canadian people. He concluded with the opinion that sooner or later there will be a democratic socialist government in this country, and that that government will build on the basis of the educational work that C.C.F. supporters have done.

During his Northumberland Strait crossing on the ferry Abegweit, the 64-year-old leader strolled about the deck in brilliant sunshine and ate generous helpings of cold, shelled Prince Edward Island lobsters in the ship's dining room.

He leaves by train today for Halifax on the third day of his federal election campaign in the Maritimes.

When Mr. Coldwell and his male secretary boarded the train at Moncton, his two seatmates were discussing politics.

"I see Coldwell spoke in Moncton last night and is heading for Summerside today. He'll have to do some talking to make some headway over there," said one of the conversation continued.

Mr. Coldwell and his secretary began laughing with the two, both apparently die-hard Progressive Conservatives.

One fellow then said to Mr. Coldwell: "You're not a politician are you?" His secretary replied: "Yes, this is Mr. Coldwell."

They shook his hand and quickly changed the conversation.
