Legislative Council Elections.

CANDIDATES for seats in the Legislative Council were duly nominated in the three Counties to-day. Their names, together with those of their movers and seconders, will be found in another column of THE EXAMINER. They are, in our opinion, each and all, men worthy the confidence and support of the Legislative Council Electorate. Every one of them bears a high moral character. Every one of them is well informed respecting the public affairs of the Province. Every one of them is himself an owner of real property—and is fitted to represent the property owners of the Province.

And we are pleased to learn that the prospects of securing their election are good. The most cheering reports come from all parts of the country, and in the town the feeling of confidence pervades the Liberal Conservative Party.

Editorial Notes.

The Toronto Mail's Ottawa correspondent confirms the statement that the Government have not considered the subject of the general elections.

Financial arrangements have been made for securing a complete water supply for the city of Winnipeg. And Winnipeg is not twenty years old!

Riel and his people are not yet avenged," says L'Etendard. Upon which the Toronto Mail remarks that "the Rielite force backed by Mr. Blake and such Ontario assistance as he can secure, are to be directed against the Dominion Government, with a view to punishing the men who refused to allow a criminal to escape."

The candidature of Henry George has not proved acceptable to the people of New York. Probably the New Yorkers who are striving to amass wealth do not like the ideas about the division of property which have been propounded by this exceedingly clever man. At any rate the majority of his opponents in the contest for the mayoralty was about 23,000.

Each of the political parties of Great Britain seems just now to be under a kind of double leadership. Mr. Gladstone has announced that his share in parliamentary affairs is to be confined to the Irish Question; and it is reported that the other leaders of the Liberal Party will be Mr. John Morley and Sir William Harcourt. On the other hand the Marquis of Salisbury permits his more active lieutenant, Lord Randolph Churchill, to indicate to the country the policy of the Conservatives, and, in other ways, to take the position before the people which is usually filled by the Leader of the Government.

Another amendment has been made in the specifications of the new contract for the Canadian Atlantic mail service. The new-basis service is to begin on April 1, 1888, instead of in 1887; the time for sending in tenders is extended to December 31st next; the new contract is to be for ten years instead of five; the voyage between Montreal and Rimouski is to be done within 154 hours, instead of 192 hours; that between Montreal and Halifax is to be done within 147 hours, instead of 216; and, lastly, four distinct tenders may be sent in as to the speed of vessels to be engaged in the service, viz., 15, 16, 17 and 18 knots an hour. These are most material modifications, and in the right direction.

The Episcopal Church of the United States has taken up the important practical question of marriage and divorce. At the Church Convention lately held in Chicago, the following resolution was passed and the proposed committee appointed:—

Resolved, Toward restoration of American civilization, decaying already at its root; for the promotion of stability in Church and State; for the protection of social purity and order; for the sake of natural good morals; in advancement of the glory of our Lord Christ, who is head over all things to His Body, which is the Church; that this house will not abandon the subject of marriage and divorce until legislation upon it is effected in accordance with the law of God, as set forth in nature and revealed in the Word, and that it appoint a committee, to consist of three Presbyters—of whom its president shall be one—and two laymen, to sit during the next three years, take into consideration the whole subject, and report to the next general convention, as early as possible in its session.

A resolution that a committee be appointed to memorialize Congress on the subject of collecting statistics on the subject of marriage and divorce was carried and the committee appointed.

Meeting of the School Board.

The usual monthly meeting of the School Board was held last evening at half-past seven. There was a full attendance; the Chairman, W. E. Dawson, presiding. Mr. John D. Wickham, vice-Principal of the Davies School, Summerside, has been appointed Principal of the Queen Square School, in place of Mr. Gaul, resigned. Mrs. Fields, widow of the late janitor, has been appointed janitor of the Upper Prince Street School. She has held the position since the death of her husband and has given satisfaction.

After the transaction of other business, chiefly of a routine character, the meeting adjourned at half-past nine.

LETTERS TO THE EDITOR.

Legislative Council Election.

Sir,—As the Council Election takes place on the 11th inst., it is time that electors should decide upon the candidate they are going to vote for. We have two gentlemen running in this district—Charles McEachen and Thomas Kickham, Esquires. They are both on the same side of politics, so far as I know, although, indeed, Mr. Kickham is represented in the papers as being a Grit. I know he canvassed me as a Conservative, remarking at the time that I ought to know myself what he was—a strong supporter of the Sullivan Government; and on these representations I promised to vote for him. Since then I have been informed that he is the nominee of the Grit party, proposed and backed up by such men as James R. McLean, Fred Morrow and Dr. McIntyre. If this is the case, I do not consider that I am bound by my promise, as it was obtained under false pretences. I see that Mr. McEachen has published a Card to the electors, telling them exactly what he is in politics. Indeed, this was hardly necessary for Mr. McEachen, as mostly everybody knows has been a consistent Conservative all his life. But Mr. Kickham is quite a different sort of politician. It appears he belongs to both parties, and I for one would like to see a Card from him, stating his politics and his motives for trying to get into the Legislature just now. He is a trader and a very successful one, and I don't believe it is altogether for the good of the country that he is so anxious to get into the Council. It is urged by his friends that he is a great boon to the farmers here, always buying cattle, pigs, sheep and poultry, and on this account should be supported. I do not agree with his friends in this, for he only buys this stock for his own benefit. Again, I have never heard that he paid much for anything he bought. It is clearly a matter of trade with him, and I have no much faith in his business tact to believe that he would go into any speculation to lose money. No, I cannot see that Mr. Kickham is entitled to any votes on this account. I sometimes think it is a pity he should bother with politics, for he cannot know much about that sort of business. He has always been too busy in trade to read up politics; and besides, I don't think he is sufficiently educated for a statesman. It is all nonsense to think that every Tom, Dick and Harry that gets comfortably well off in this world must be a statesman. It requires a certain amount of character and ability for that business, and I am afraid Mr. Thomas is hardly able to fill the bill. However, when he publishes his card, we can tell more about it. If I find him a Conservative on election day I'll vote for him as I promised; if not, I must vote against him, as I understand a great many others are going to do.

Murdered on a Nova Scotian Bark.

A cool-blooded murder has just been perpetrated in Colombo, again showing the great necessity which exists for harbor police in that port. The incident occurred on board the bark Strathay, of Maitland, N. S., which arrived in Colombo, from Java, on the 6th September, in ballast. Early that morning, about 9.30 o'clock, the second mate of the vessel, W. C. Thompson, of St. John, accosted a seaman, named A. Smith, who complained of his inability to perform his work through sickness, and told him he did not believe in his illness. "Oh! you are humbugging," said the mate, "you can do your work fast enough." This appears to have angered the man greatly, and an altercation ensued between the two with regard to the pay of the seaman Smith. On the second mate turning away, the latter lifted a hand-spike which lay handy and struck the mate a terrible blow on the back of the head, which immediately felled him to the deck. The captain of the vessel and the other hands seeing what had occurred, immediately rushed in and seized the man Smith, and he was then and there put in irons. An examination of the second mate showed that he was quite dead, his skull having been fractured and the brain protruding. The port surgeon and the police authorities were at once sent for, and Dr. Garvin went off immediately, only to verify the fact that the man was dead. The police were, however, not able to board the vessel and apprehend any one without first obtaining a warrant, so Mr. Inspector Moore proceeded to lay the information before Captain Donnan, the port magistrate, from whom the necessary warrants were obtained. When Inspector Moore boarded the Strathay he took the seaman Smith in charge, informing him of the charge made against him, which seemed to startle the man a good deal, for he had hitherto been unaware that the mate was dead. He will be brought before the magistrate at once. The prisoner, we believe, a native of Canada, a tall, powerful man of over six feet, bearing, it is said, a very bad character on board.—Ceylon Times, Sept. 11.

A Curious Law Suit.

A case that calls to memory some of the ever famous incidents in the Guibord affair, has been entered in court in Montreal. Some years ago, a young lady named Fortier, married Joseph Vermette, of Cote St. Louis. Before his marriage, the latter purchased a lot in Cote des Neiges cemetery, and when, about four years after their union, he died, he was buried there. Two years later his widow was once more united in the bonds of matrimony, this time to a well-to-do gentleman, also of Cote St. Louis, named Mark Charbonneau. When her first husband died she entered into possession of a portion of his estate, but there was no mention made of the cemetery lot in the testament. Last October she allowed the dead child of a Montreal relative named Alexis Ratelle, to be buried in the lot that had belonged to her husband, and in which the latter was interred. This greatly displeased two children she had given birth to with her first husband, and they are now suing their mother, her husband, Alexis Ratelle, and the fabricator of Notre Dame, to force them to remove the dead body of the child Ratelle from beside that of their father. It is the first time in the annals of the bar that an action of this nature has been started into court.

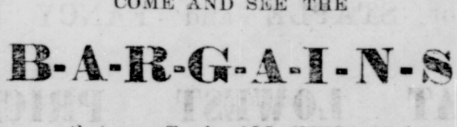
