A curious piece of literary history is re-  
lated by the Boston Courier. Mr. Em-  
erson's early works, the first volumes of  
essays, "Nature," and his first poems,  
were printed by the old publishing house of  
Monroe & Co. After the author's return  
from England he became acquainted with  
the head of the firm of Phillips & Sampson,  
who asked that he should be allowed to  
publish Mr. Emerson's next volume. "I  
am very willing," was, in substance, Em-  
erson's reply, but "I wish to own the plates  
myself." And so it was arranged. Em-  
erson had at this time been before the public  
for a number of years, had published three  
volumes of essays and a volume of poems;  
the Dial had lived and died, and the writ-  
ings of the Sage of Concord were read, or  
at least talked about, on each side of the  
Atlantic, so that the sale of any book from  
his pen was in a manner assured before-  
hand. Some time after the appearance of  
"Representative Men," Mr. Phillips sent  
Mr. Emerson a cheque for a considerable  
sum of money—about \$600. Mr. Emerson  
went immediately to see his publisher.  
"You do not understand," he said; "be-  
fore I receive any money I wish to pay for  
the plates." "If you have examined the  
statements I sent you," was the publisher's  
answer, "you would have seen you have  
already paid for the plates." "And the  
copies that are on your hands," inquired  
Emerson, "who owns them?" "You,"  
was the reply, "subject, of course, to our  
commission." "And this cheque is mine  
also?" "Certainly; that covers the balance  
due you." "Well," observed Mr. Em-  
erson, "with all your publishing, that is the  
first money I ever received from one of my  
books."
