LETTERS TO THE EDITOR.

A Liquor Law.

Sir.—Charlottetownians have got back to their original freedom as regards the sale of liquors. This is one of two possible states under the Scott Act, and although, as compared with the only alternative as experienced here for the past ten years, certainly not without advantages, it is to be feared that this liberty, as it always has been so it will be now—abused by unscrupulous men.

Therefore, and in view of the early meeting of our legislators, it is for us to say whether the traffic shall remain free and open to all, or whether he who wishes to engage in it shall be obliged to take out a license and give bonds for his good behavior, and be allowed to sell only subject to such restrictions as may be imposed by law.

No one can get rid of his responsibility by saying that such a bad thing as a saloon should not be licensed. The phrase "license law" is misleading at best; some people make a blind of it. We are now under a "free license law"—the Scott Act reversed: What is proposed by a proper liquor law is to take away most of those free licenses and impose strict rules to govern the license-holders that remain.

Let it be borne in mind by those who would have prohibition, and will hear of nothing else, that, while no doubt they are the people and the salt of the earth, there are some of a different way of thinking,—quite a number, in fact, the majority,—and that it has been said by a great man, perhaps with some truth, that much the larger part of the suffering endured by the world has been inflicted by its best people trying to accomplish a great good in an impossible way.

I have made an abridgment of an article on saloons from the pen of Dr. Howard Crosby, published in the Homeopathic Review for February last, which may be of interest to reformers, and annex it to this letter.

ON WHAT LINE MAY ALL THE ENEMIES OF THE SALOON DO BATTLE? DIGEST OF AN ARTICLE BY HOWARD CROSBY, D. D.

The entire destruction of the saloon at a blow is an impossibility, simply because public opinion is overwhelmingly against such action. Whatever the reason may be, the great bulk of the community in our great cities is decidedly opposed to a system of prohibition.

Those who see and feel the evils of the saloon must adopt some other line of action if they would reduce those evils. They must abandon theory and adopt the practical mode in which to attack the evils of the saloon rather than the saloon itself. If some say that the two are synonymous, they must remember that others do not think so, and it is those others that we want to enlist on our side. We must repress our own differences while we fight the common enemy.

Prohibition being impossible, systematic restriction is the only alternative, and in this we shall have the support of all good men. Whatever their differences on theories, all such agree that there are gigantic evils in the saloons, and that they ought to be cut-rid. If a reasonable plan is proposed, they will willingly give their aid.

One feature in such a plan would be reduction in the number of saloons. This would lessen the number of the temptations; and this, whilst it would not save the habitual drunkard, would save many an inexperienced youth. It would also put the comparatively few saloons under close police supervision. Such reduction can best be obtained by a high license fee.

A second feature would be entire closing of the bar-room on all holidays, and during the night from 11 p. m. until 6 a. m.

A third feature would be heavy bonds given by both the liquor-dealer and the owner or landlord of the premises where such dangerous trade is conducted, which bonds would be a guarantee against disorder within the saloon.

A fourth feature would be severe penalties for every infraction of the excise laws.

A fifth feature would be the complete prohibition of any side door or entrance, and of any screen, by which means the law is so constantly evaded.

A sixth feature would be the meting of policemen who allowed a saloon to be open after hours.

A seventh feature would be the forbidding of any lounging about the saloon.

An eighth feature would forbid any woman or child from entering a saloon on any pretence whatever.

These provisions would meet the views of all who desire reform, and would destroy one-half the existing evils of the saloon. The law should clearly define the difference between a saloon and a restaurant (an eating place without a bar). To prevent a man at such a restaurant or at an hotel from having his glass of wine would be considered, the world over, as an act of tyranny, and certainly could not be endured in our country. Hotel bars should be dealt with as saloons.

Now if anyone should say that when we have all this we have not obtained all we wish, our answer is that we have taken the first step, and a great one, and the necessary step to the second one in the matter of reform. The road indicated is the only one on which progress can be made. It invites us to further and further reform. It will lead public opinion in the right way, and will harmonize such opinion in all rational efforts at destroying the saloon evil.

And it is that harmony which we need. We shall never get it by insisting on prohibition. We shall in that way only make wider and wider the separation of good men, and more thoroughly intract the common enemy. Do any ask "What will be the second step on this line of reform?" We reply that when public sentiment is educated by the results of

the first step, it will be ready to insist that no liquor shall be drunk on the premises where it is sold, except in restaurants and hotels. This will be the end of saloons. The obnoxious idea of prohibition will not be carried out, and the liberty to drink what a man pleases at his regular meal, and in his temporary home, will be guarded, a liberty which every American will insist upon, while at the same time the evils of the saloon will be completely destroyed under the acceptable idea of restriction.

Hundreds Crushed.

THE WALLS OF A SYNAGOGUE FALL IN WHILE THE PLACE IS CROWDED.

A despatch from Tunis gives an account of a dreadful disaster which lately occurred at a place called Mansel, in the vicinity of Cabos.

A children's service was in progress in the synagogue at that time, when, without warning, the walls of the building collapsed and the roof fell to the floor with a crash that was heard all over town.

Hundreds of people hastened to the spot to find that the whole congregation had been buried beneath the fallen walls and roof. The shrieks of the struggling victims, held fast by heavy beams, stones, etc., horrified the spectators, rendering them powerless, for the moment to do anything towards rescuing the injured from their terrible position. A few cool headed ones, however, took the lead, and the work of extricating the victims began.

Within a short time fifty maimed and bleeding men, women and children were taken out and cared for, and four dead bodies, crushed out of all semblance to humanity, were removed to the dead house.

The number of killed cannot be even approximately estimated. It is known that the building was crowded with people, and hundreds of dead bodies must still be buried beneath the tons of debris not yet removed.

How to Dress the Hair

ALWAYS ARRANGE TO SUIT THE SHAPE OF YOUR FACE.

How to wear one's hair is really a most important question, for on its being becoming or not depends so much, says the Ladies' Home Journal. A low arrangement of the hair is given the preference for daytime, although the woman who does not find this suited to the shape of her face should not permit herself to wear it under any circumstances.

This is heeded, the tress of hair is laid between, the iron closed and the hair when taken out is in a beautiful, natural looking wave, to which the epithet of "fuzzy" could never be applied. However, one would have to get some obliging sister to do this, inasmuch as the iron is rather difficult to manage by one's self, and a burned set of tresses is not desirable.

However, as the oval face is much more general in this than any other country, the low arrangement is possible to almost all. Smooth waves are very much liked, and these waves are produced, not by putting the hair up in pins, but by using an iron specially made for that purpose.

The woman who can part her hair in the centre, wave it and draw it back over the tips of her ears, and then coil it in a loose knot low in the back, is a woman who really has her hair arranged in the most fashionable manner.

Pictures of Mrs. Kendall or Jane Hading show this arrangement so perfectly that a deft fingered woman can easily adjust her coiffure after them.

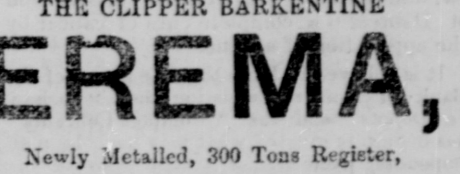
