

Excise Case Set Over In Georgetown Court

MONTAGUE BUREAU OF THE GUARDIAN
A heavy docket faced King's County Stipendiary Magistrate, James B. Johnston, when he held court at Georgetown on yesterday.

The case of Louis Allen Joseph Acorn, Lower Montague, charged under the Excise Act and who had previously pleaded not guilty, and in whose case crown evidence was heard at an earlier hearing, had his case continued. His counsel, John P. Nicholson, made a motion for dismissal on the grounds that no "voir dire" or trial within a trial, had been held on the admissibility of statements made by the accused which were admitted in evidence and to which Mr. Nicholson had objected at the time.

It was agreed with the consent of Mevin J. McQuaid acting for the Revenue Department, and by Mr. Nicholson, that the case be adjourned for two weeks, and Mr. Nicholson promised to provide. The magistrate and Mr. McQuaid cited cases in support of his motion.

TWO CHARGES
Russell William MacIntyre, M.L. Stewart, charged with driving while intoxicated—pleaded not guilty, when the crown refused to accept a plea of guilty to the lesser charge of impaired driving.

The accused was represented by Lester P. O'Donnell and the case was adjourned for two weeks. The same party pleaded guilty to a hit-and-run charge. This case was also adjourned for two weeks with the consent of G. R. Foster, Crown prosecutor and Mr. O'Donnell.

Robert Joseph Goodwin of Peakes Road, charged with having possession of a sawed-off rifle with a barrel less than 20 inches in length, elected trial by judge and jury and pleaded not guilty to the charge. The case was proceeded with by way of preliminary hearing.

TRIAL WITHIN TRIAL
The accused was represented by J. P. Nicholson. Evidence of Const. Douglas J. Hender was taken. A trial within a trial was held as to the admissibility of statements of the accused.

Following the completion of the crown's evidence, the accused made a statement to the court and his attorney addressed the court. The case was taken under consideration and was adjourned for two weeks.

Raymond Griffin of Montague pleaded not guilty to driving while intoxicated. Const. James Dunn gave evidence for the crown. The case was adjourned for two weeks to allow the hearing of evidence for the defence. J. P. Nicholson represented the accused.

George Sextus MacPhee of St. Georges, charged with having the care and control of a motor vehicle while impaired, had his case adjourned for two weeks. A plea of not guilty had previously been entered by the accused represented by J.P. Nicholson.

A resident of Glen Martin had an assault charge against him withdrawn by the informant. Raymond Benjamin McKeenan of Point Pleasant, charged with driving while impaired, had his case adjourned for two weeks. He was represented by J.P. Nicholson.

Wendell Paynter of Souris, who previously pleaded guilty to a hit and run charge, had his case further adjourned for one week.

Home And School Groups Arousing Public Interest

"If the same pathway were worn to the doorway of the minister of education as there is to that of the minister of highways the government would wake up to the education needs of this province." K. A. Parker, superintendent of city schools remarked yesterday.

In company with Dr. M. E. LaZerte, who is making a survey of education here for the provincial government, Mr. Parker was answering a question directed at both regarding where leadership in education should come from.

The consensus was that it is now coming from home and school association and teachers federations with the feeling that government was being forced to take action. Particularly in this province did the speakers feel the educational drive was being spearheaded by the home and school association.

people dropping "far behind" when they leave here for other places. He is not too enthusiastic about the "junior" high school systems which he says was copied from that of the United States in non-enclosure only while forgetting to take in the better features of the selective system provided there.

While noting that other provinces had adapted schools to individual needs, he believes they have fallen down in the matter of providing "options". Too many of the latter venture too far from the academic field.

He thinks the secondary schools today are not "solid" enough in the basic sciences and mathematics, but believes the impact of Russian emphasis on them is bound to be felt to such an extent that changes will be mandatory.

INCREDIBLE SITUATION
Dr. LaZerte thinks it incredible that there are so many primary schools in this province with no few pupils in each as he noted there is one school for every 2.1 square miles. He is a firm believer in the larger administrative and school units for the great value to the student both in improved educational facilities and services offered.

Mr. Parker remarked that factors involved in educational conditions here were in part due to annual loss through the "traditional emigration" of youth seeking opportunity elsewhere resulting in the loss of many of top level future citizens.

He also said perhaps to much emphasis was placed in relating success stories of former Islanders elsewhere which resulted in complacency here and the feeling that the Island educational system "must be pretty good".

But Dr. LaZerte pointed out that these exceptions only proved that with poorer facilities outstanding students here did better than such students did elsewhere. Mr. Parker termed this "an exaggerated case of survival of the fittest."

It was also remarked that there are no municipal levels here which thus created an unusual relationship between the provincial government and rural citizenship where contacts between them are on a first-name plane.

BACKS LARGER UNITS
Discounting difficulties in handling the larger school units, Dr. LaZerte pointed to the fact that the entire area of this province would only be the same as one of the school units in Alberta where serious efforts to improve educational conditions are underway.

He believes that fewer schools would result in better teachers and favors licensing and salary on university training and merit. School taxes here he thinks are at a low level compared to other areas of Canada while also noting that personal incomes are also considerably lower.
