Newfoundland---South-East Coast. LIGHTS AT CAPE RACE AND CAPE PINE.

WITH reference to Notices to Mariners, Nos. 28 and 5, issued from this office on the 12th day of June, 1865, and the 1st day of February, 1866, respectively, relative to the proposed alterations of the lights at Cape Race and Cape Pine, mariners are hereby informed, that the contemplated changes will take place on the 21st day of August, 1866.

The fixed light at Cape Race will be altered to a *revolving* white light, attaining its greatest brilliancy every *half-minute*.

The revolving light at Cape Pine will be altered to a *fixed* white light.

IN pursuance of an Act of the General Assembly of this Island, made and passed in the Twenty-fourth year of the reign of Her Majesty Queen Victoria, intituled "An Act relating to the Land Assessment at present imposed by Law on the Town and Royalty of Princetown," and also of an Act made and passed in the Twenty-seventh year of the same reign, intituled, "An Act to consolidate and amend the several Laws imposing an Assessment on all Lands in this Colony and for the encouragement of Education."
