## Aylmer Bought Out By Del Monte Firm

HAMILTON (CP)—A special general meeting of Canadian Canners Ltd. Thursday approved sale of a two-thirds interest in the company to California Packing Corporation for a total payment to shareholders of \$4,041,110. Canners, however, retains its present identity and structure as a Canadian company. Its products are sold under the trade name Aylmer and those of California Packing under Del Monte. Under the proposal each existing common share will be split into one class A common and two class B common and California Packing will buy from shareholders their class B shares at \$15 a share.

## Atlantic Sugar Opens Warehouse

SAINT JOHN, N.B. (CP)—Alex E. Hill of Toronto, president of Atlantic Sugar Refineries Ltd., opened a new \$2,000,000 warehouse here today and said it was concrete evidence of the company's faith in the Maritime future. Mr. Hill presided at ceremonies opening the refined sugar warehouse, part of a multi-million dollar expansion program under way at the company plant here. He told 2,700 employees and their families that "one year from today" new dock facilities will go into use, stimulating the growth of bulk and heavy cargo shipping through this port.

## Mersey Paper Shares On Montreal Market

MONTREAL (CP)—Preferred shares of Mersey Paper Co. Ltd. will be admitted to trading on the Montreal stock exchange Oct. 29, the exchange announced Thursday. The listing covers 200,000 shares of 5 1/2 per cent cumulative redeemable \$50 per share stock. An offering of \$10,000,000 of these shares was made recently at \$49.50 to yield 5.55 per cent and the offering was oversubscribed. The present Mersey Paper Co. is a member of the Bowtar Organization and was formed following the acquisition of the assets of a predecessor with a similar name. The likenesses of four American presidents carved in Mount Rushmore in Dakota's Black Hills can be seen for 60 miles.
