## LETTERS TO THE EDITOR.

### Exhibitions at the West.

Sir,—The Government have at length defused their policy with regard to exhibitions, and we of the far west, at least, are disappointed. Centralization may be the very thing to suit certain parties of influence; but for us it means absolute exclusion from the benefits of these fairs—benefits we have a strong claim to and which we relinquish under protest. The new arrangement may meet the wishes of Queen's County. I don't see why it shouldn't. King's may be fairly served by a show held at Georgetown, a point somewhat central in the county, although Mr. McLean says the eastern end demands it in turn. One thing is certain, however, and the sooner our legislators make their minds up to it the better.—Western Prince County will never, because she can never be satisfied with an exhibition held every year at Summerside; and convinced that her demand for it every alternate year at Alberton is unmistakably within her rights, she is not disposed to flinch before the enemy, nor listen to other propositions until her just demand is heard and satisfied. If our legislators knew anything of the feeling aroused in the county, they would have given her claims a little more attention; but we are not done asking, and by the time we are they will understand the wants of the county better and feel better disposed to satisfy them. We say, and we speak advisedly, that to us the Summerside Exhibition is of as much service as that held yearly at Three Rivers; and, therefore, we oppose an increase in the county grant under the present arrangement. Simply, we cannot go to Summerside; it is too far; the fares are too high; the exhibition is managed for the few who do not farm for a living, but for pleasure, and who have gobbled up everything in the past, and seem to be of unlimited capacity for the business; the management, (such as it has been of late years) is shameful; the visitor or exhibitor is subjected to the inconvenience and danger of packed and disorderly cars; his stock cannot turn out so good-looking after 80 miles of roading. And these are only a few of our grievances. Are they not worth considering? Are they not worth redressing? Until such time as our public men decide in favor of the political graves of those who disregard them. The war is now declared, and we'll certainly carry it into Africa, if needs be. The people are properly aroused, and like the Spartans of old, will come home with their shield or on it. There is no sham about the movement; it is earnest, it is honest. Mr. McLellan may imagine himself well informed when he says the people up west, in his own district, don't want County shows, and will be satisfied with one general exhibition at Charlottetown. He will know better before he is much older, and if he doesn't know better now, his want of knowledge is anything but creditable to himself, in the face of the fact that throughout his district a series of meetings has been held at which resolutions were passed calling upon the Government to acknowledge the right of western Prince Co. to the County Fair every other year. These resolutions, and the petitions accompanying them, are now in the Premier's desk in Parliament and Mr. McLellan knows it. One of these meetings—a large and enthusiastic gathering of farmers—was held at his very door, which asked, in the plainest terms, for a Western Fair. Still he, their representative, forsooth, stands up and says they don't know what they are talking about; they really want to go to Charlottetown. He must know that few, if any, of them could go there at all unless these visits to the capital, like his own, were paid out of the public purse. And while Mr. McLellan talks without a knowledge of the facts, Mr. Matheson is mute, and the interests of the farmers they represent are sacrificed. Pretty far, indeed! But there certainly will be a great awakening; and, in the meantime, although somewhat disgusted, the people of western Prince County will prepare to do valiant battle for their rights, full of faith in the claim they put forth, and hope in their ultimate realization.

### BOSTON PRICES.

From Hatheway's official report of the 11th, we extract the following:  
EGGS.—Receipts for the week 58 boxes, 837 bbls., 13,192 cases; last week 48 boxes, 408 bbls., 14,622 cases. There was an improved demand early in the week, and receipts were enabled to advance prices a little on the best marks, but receipts have been liberal for the past day or two, and this morning the feeling is not quite so firm. The best western are generally selling at 11c. with some extra Michigan at 12c. Eastern extras in light supply, and at the close are generally held at 13c.  
POTATOES.—Receipts past six days 49,000 bush.; previous six days, 63,500 bush. The market has been very quiet, and although receipts are moderate, the supply is still in excess of the demand, and prices for most kinds are ruling easier than a week ago. Northern stock of all kinds is particularly dull. Fancy Houton Rose and Hebron hold fairly steady. P. E. Island Chenagones are quiet at 65 to 68c. New Brunswick Rosa dull at 50 to 55c.

### HALIFAX PRICES.

Says the Halifax Chronicle: There was a considerable fall during the past week on all grades of flour except choice pastry, the present quotations on other grades showing a reduction of from 10 cents to 20 cents per barrel. Cornmeal fell 10 to 20 cents a barrel, and oatmeal and rolled oats are selling at prices 20 and 25 cents a barrel lower than a week ago. The grain markets are reported to be unsettled and dull. P. E. Island oats have gone down two cents per bushel, and Island potatoes five cents a bushel.  
SUGAR.—Says the Halifax Herald: For the past month the price of sugar has been steadily advancing, and within the past few days the Halifax refinery is said to have advanced the price a cent and an eighth per lb. The crop in Cuba and other islands is 40 or 50 per cent. below the average yield, the cane not having ripened properly. The Redpath Refinery, Montreal, is said to have used up all its stock, and is now shut down, refusing to sell the manufactured product in anticipation of a still further rise in prices. The Halifax refinery is running and refining sugar purchased before the rise. A later number of the same paper says: Another advance has been made in refined sugars, refinery prices on Saturday being 6½¢ for yellow, 6¢ for standard, and 8½¢ for granulated in round lots.

In his wake followed a young woman with whom he had been keeping company for some time, and who, it is alleged, was to marry him if he could in any way get rid of his wife. At least this is the story told by the Halifax Mail.

MEASLES AND THE TEMPERANCE SPIRIT.—A Nova Scotia rural paper says: The measles have raged to such an extent in Middleton this winter, that it has been a struggle to keep up the temperance spirit. But now the crisis is past, and we are weekly gaining in numbers and enthusiasm. A week or two ago, amongst other items on the programme for the evening, was a paper on the effect of measles on the mind and mind on the measles.

HE IS WISE NOW.—Two strangers visited Daniel Keller, a well known farmer of Shamokin, Pa., one day last week, and, after proposing to purchase his farm, engaged the old man in a game of cards. Keller became interested, and put up \$4,500 as stakes. The money was seized by a stranger, and Keller was covered with a revolver, while they moved off. One of them had represented himself as a son of an old friend of Keller's.

AN INSANE ACT.—The Halifax Herald says: Among the steerage passengers on the S. S. Samia from Liverpool, was a single man named George Williams, 43 years of age, booked for Quebec. He came on deck at seven o'clock last Thursday morning, threw his hat and coat on the deck, sprang on the rail of the steamer and deliberately jumped into the ocean. It was quite rough at the time, but the steamer was stopped and a boat launched. No trace, however, was found of the unfortunate fellow.

THE WIDOW GOT DAMAGES.—An interesting case under the Civil Damage Act was decided in the County Court at St. Albans, Vt., one day last week. The plaintiff, a widow named Richards, brought suit to recover for the death of her husband several years ago, while intoxicated, on the ground that defendant, Moore, who keeps a hotel at East Berkshire, had sold him liquor, the drinking of which brought about the accident which resulted in Richards' death. The case has been in court some 17 terms, and before a jury four times. And now a special jury has returned a verdict for \$1,400 in favor of the plaintiff, and a motion for a close jail execution has been filed. The case has excited much interest.
