A P. E. Islander Charged with Murder.

MARRIED IN HASTE AND THE FATAL CONSEQUENCES THAT RESULTED FROM IT—MARRIED IN NOVEMBER AND MURDERED IN MAY.

The *St. John Globe* publishes the following particulars of the marriage of McNeill who murdered Rosalie Hilton, his wife at Albany, a short time ago. At Mr. G. A. Noble's boot store the *Globe* reporter learned that McNeill had been engaged as a shoemaker, for about three months of last year. He told Mr. Noble that he belonged to P. E. Island, and had acquired his trade there. He was about thirty-five years of age. He had been living in the United States for several years, and had been married at Albany, N. Y., at which place his wife was divorced from him. He had two children with him, one a little boy, about nine years of age, and the other a little girl, about two years of age. He was of a very excitable temper, and was continually boasting of his exploits. He also took a great pride in displaying his divorce papers. He drank pretty heavy while at Mr. Noble's, but not sufficient to prevent him from working. Mr. Noble, however, took a dislike to him, on account of his always importuning him for money in advance and discharged him. He did not tell his employer of his marriage until the evening after it had taken place. The Clarence House, on Wellington Row, kept by Mr. M. Daley, was the next place visited. Mrs. Daley stated to the reporter that Miss Hilton had been in her employ for about two years. She came from Kingsbury, Me., where her parents are still living. After coming to this city she went to live with Mrs. Daley on the Straight Shore. On their removing to Dorchester street, she engaged as cook, and remained there until the removal of the establishment to Wellington Row, when the name of the Dorchester House was changed to Clarence House. She was about 30 years of age, and had always conducted herself in a modest and respectable manner. Mrs. Daley was acquainted with her for some years previous to her coming to St. John. McNeill, who had been boarding at the Union House, on Union street, took up his quarters at the Clarence House about the latter part of October, and here it was that the intimacy sprang up between the two, which ended so fatally. Miss Hilton's regard for McNeill amounted almost to an infatuation, and she was ever ready to defend him when any aspersions were cast upon his character. To Mrs. Daley, McNeill also showed his divorce papers, and he explained to her that his wife had obtained the divorce because she believed him to be on rather intimate terms with some of the servants in a boarding-house that he kept in Albany. He was continually talking about a man that he had shot and the manner in which he had escaped from the law. His landlady never held a high opinion of him, and fearing that she might object to the marriage, Miss Hilton never told her anything about it until after it had taken place. To Mrs. Daley he stated that he had seven children by his first marriage, and that five of them were dead. The boy stayed in St. John for a month or so, and was sent back to Boston. The little girl lived with her father, and he appeared to have a great affection for her. She became so troublesome about the house, however, that Mrs. Daley refused to keep her any longer, and McNeill went back again to the Union House. Miss Hilton took umbrage at Mrs. Daley's action, left the Clarence House and went to live in the Union House. A day or two after going there the marriage took place at Rev. Dr. Macleod's. They had only been acquainted about three weeks, and she knew nothing whatever of his previous history except what he was pleased to tell himself. On the first of Jan. last he returned to the States, his wife going back to the Clarence House, where she remained until the 29th of that month, when her husband sent for her. She directed that any letters that should come herefor her should be addressed to 144 Court street, South Boston. Mrs. Daley received no word from her since leaving this city. Some of the boarders in the Union House told the reporter that McNeill was a very talkative man, particularly when in his cups, which was very often. At such periods he would take particular delight in narrating the manner in which he had killed the man. He said he was keeping a bar-room in New York at the time, and that a man named O'Brien entered his place and commenced destroying the articles in it. He refused to desist and he (McNeill) shot him through the head. For this he was tried and found guilty of manslaughter. He was let out on bail, however, and at once departed for the Provinces. It is stated that he sent nearly all his wages to his bondsmen while here.

The Princess Louise and Prince Leopold attended Vespers in the Roman Catholic Church, Toronto, last Sunday afternoon. They were received by Archbishop Lynch and his clergy. The services were of an interesting kind, being in connection with the feast of Corpus Christi.

Very gratifying reports of the state of the spring crops have been received from all parts of the Ottawa valley, and prospects of a good harvest were never better at this season of the year.

The Peters' Lock.

The *Moncton Times* says:—The Peters' Lock appears to be meeting with great favor in the United States. The *Boston Globe* and the *United States Trades Journal* have lately given very complimentary notices of the invention. The Massachusetts detective force, some time ago certified to the superiority of the lock over any other invention. Private letters, also, are very complimentary. In fact, the indications, wherever the lock has been introduced, are that the sales will be very large this season, and that the promoters of the enterprise, who have spent a large amount of money and labor in perfecting the locks, and in getting up the different patterns will be well repaid. It might be mentioned that the company has recently established a branch office in Boston, and has contracted for the manufacture of 50,000 locks.

A Horrible Crime.

A FAITHLESS WIFE SEEKS TO KILL HER HUSBAND BY POISON.

A case of infidelity and attempted poisoning has lately come to light in Montreal. It appears that for some time past Policeman Biggess has been ailing in health, wearing away almost to a skeleton. He took ill in October last, and is now almost a shadow of his former self. He had spasmodic attacks at different times, and daily grew worse. On the night of May 19th he got his supper from his wife, Marie Louise Brazeau, as usual, and as he ate his meat his teeth grated against something. He found it neither bitter nor sweet, but it aroused his suspicions, and, saving a portion of his supper, he carried it to Dr. Baker Edward for analysis. The scientist found traces of tartar emetic. This afternoon the policeman, having received the astounding intelligence, informed the chief of police, who at once gave the necessary orders for the arrest of the female monster. It then turned out that another man had been cohabiting with the would-be Borgia, and had visited the house continually during Biggess' absence. Mother-in-law Brazeau had another daughter, who also resided with the betrayed policeman, always played the part of sentinels while the introducing rascal was in the house. They were arrested as parties to the poisoning plot, and the police are looking for the man in the case, whose name they withheld.

The victories of the sons of Canada are not confined to any particular field. Only the other day we took pleasure in chronicling the success of Canadian muscle in the very capital of the great United States, and to-day we take equal pleasure in referring to a Canadian's well-earned victory in the field of letters against the rising poets and authors of France. Some years ago it would have been considered almost presumption for a Canadian to aspire to be crowned by the French Academy, a distinction which only one competitor can obtain during the year, but this distinction has nevertheless been won this year by M. Frchette, who deserves and will receive the congratulations of his countrymen on the result. His fame as an author and a poet has not been restricted hitherto to the borders of Canada, but this crowning victory will do much to bring his writings into greater prominence wherever the French language is read.

Though Mr. Gladstone, as Prime Minister, must be the leader of the House of Commons, it has been arranged, says the *London World*, that he shall be relieved, as far as possible, of the more fatiguing and laborious duties of the position. The most trying part of a leader's duties is the constant attendance at the House which it involves. Mr. Gladstone is getting up in years, and he has stipulated that a portion of the duties of leadership should be taken by Lord Hartington. In consequence of this arrangement, Mr. Gladstone will not, as a rule, remain late in the House; and, after the dinner hour, the duties of the leadership will be performed by Lord Hartington. Of course on very great occasions the Premier will remain till the close of the sitting; but his services may easily be dispensed with on five nights out of six. To a man of Mr. Gladstone's age it will be a great gain to be relieved from the tedious duty of sitting in the House of Commons till the early hours of the morning.

"Affairs of honor" have got beyond a mere mania, apparently, in France, within the past week. There appears to be a perfect rage for blood to appease the wronged or insulted spirits of politicians and journalists. There is at least one duel a day between prominent persons. When all the pride-ridden fools shall have been killed off by each other, it is to be hoped that a new stamp of public men and editors will come to the front in France, whose sense of honor will be aroused at the sight of oppression of the weak or defenseless, rather than at fancied failures on the part of others to acknowledge their dignity, or pay homage to their self importance. But how impossible such an event seems, in view of the false estimate of honor which is being cultivated in the mind of young France to-day.
