We are pleased to learn that a Convention of influential delegates, which met to-day, nominated JAMES JOHNSTON, Esquire, of Crapaud, to be the Liberal Conservative standard bearer in the First Legislative Council District of Queen's County. Mr. Balderston, it is true, declares our present Legislature to be unnecessarily large and burdensome to the taxpayers. But his actions, during the past eight years, declare in language louder and more decisive than words, that he will do nothing towards a reduction of the Legislature. Mr. Johnston holds decided opinions upon the question, and given the opportunity, we feel sure that, while providing amply for the protection of property-holders, he will make short work about such a reduction of the Legislature as will consist the best interests of the Province.

Editorial Notes.

Mr. Gladstone has announced that the Government will demand from Egypt a contribution to defray the expenses of the British army of occupation.

The eviction, by no less a personage than the Irish Land League Leader, Mr. Parnell, of three tenants who were four years in arrears, has been strongly criticised. There is no question but the "Irish Tenants Friend" had a right to act as he has done; but the act is hardly consistent with his many declamatory speeches.

The Patriot's attack on the ability of Mr. Nicholson is having precisely the effect we anticipated. Mr. Nicholson's friends have been roused; and are the more determined that the honest champion of the true interests of the country shall be elected. The Patriot's explanatory paragraph was well; but the occasion for it should never have been given.

Nihilism and Socialism (under another name) seems to be as rampant in Republican France as in Despotic Russia. At Lyons a few days ago seven anarchists were arrested on a charge of murder, and two were arrested on a charge of manufacturing dynamite. Several carboys of nitric acid, a number of empty shells, dynamite fuses and other explosive material have been found near the garden of one of the prisoners.

It may be well to state that, before it was abolished, the Legislative Council of Ontario was, just like our own Legislative Council, an elective body. The people grew tired of the frequent tiresome elections, and disgusted with the solemn farce of electing over and over again the members of an utterly useless and very expensive body. They abolished their Legislative Council; and they are not only sater but happier now. Shall we not do likewise?

The New York Herald says:—The great educational reform of admitting women to participation in the management of the public schools is making substantial progress in many of the states of the Union. This subject was recently considered at a meeting of the Ohio Teachers' Association, and was the text of an interesting address by one of the delegates who attended the Convention. Women are now eligible as school officers in Illinois, Iowa, Kansas, Virginia, Massachusetts, Michigan, Minnesota, New York, Pennsylvania, Vermont, Wyoming, and "to any office in Wisconsin except that of State Superintendent." In Mississippi the law requires that at least one woman shall be a member of the State Board of Education." It is to be hoped that Canada will soon fall into line on this great and important question.

Every taxpayer in this Province must know and feel that our roads, bridges and wharves require constant repair, and that in many important places new bridges and wharves are much required for the public accommodation; and yet in the face of such public requirements, calling loudly for the expenditure of Government money, we find Grits and obstructionists doing all in their power to retain a useless branch of the Legislature, at an annual cost to the taxpayers of many thousands of dollars. These obstructionists tell us that the public works are starting for want of a larger expenditure of money, and yet they would continue to burden the people with a cumbersome Legislative Council, the existence of which does not confer one dollar's worth of good upon the people.

PRAIRIE FIRES are quite prevalent through the Province of Manitoba at present. A big fire, extending several miles, was burning briskly to the east of the turf club track yesterday, and the sky was brightly illuminated by it last night. A despatch from Westbourne says: Prairie fires have been raging for some days. Considerable hay has been destroyed. The inhabitants were compelled, for safety, to burn a large tract of prairie outside the settlement.—Winnipeg Times

The British Government is taking active steps to give effect to the emigration clauses of the Arrivals for Rent Act, by publishing regulations under which impoverished ones can borrow money to supplement government grants. Emigrants to North America will be aided at New York, Boston, Quebec or Halifax. A male and female agent will be appointed at each of those ports to keep the authorities advised as to the progress of the employment of emigrants.

A Musical Sect.

The genius of the age is analytic. There is hardly anything on earth which our great modern geniuses have not done something towards analyzing. Modern painters, musicians, poets and scientific men have all shown the greatest disposition to probe and explore the hidden mysteries of thought and feeling to arrange and rearrange the insoluble problems of life, which never seemed so insoluble as now; to trace emotion through all its intricate windings; to describe and give expression to the yearnings of the soul, from its most fiery heats down to its most glacial intensities.

At this time, when general culture has spread itself, and has toned down individual traits, the emotional wants of man, and his passionate self-consciousness demand refreshment and repose. These he finds in music.

Does he possess the golden key to these emotions—the EAR for music—then the hurry and rush of modern life are soothed and elevated by this spiritual power. Melodious thunder and the sweetness of rolling waters,—a pitch of intensity like the sudden blaze of vivid lightning,—swiftness of thought and emotion like the trailing fire of the falling stars,—variety like woodlands smitten by the first frost of autumn, or the coming night wooing the setting sun,—all these emotions are excited by the medium of music. The heart receives messages too subtle for words, filling it with joy, driving it wild with terror, or calming it with hushing whispers of imperishable consolation.

In the struggle and yearning of the age for what is best and noblest, we are not surprised that teachers of morality are looking towards music as a faithful exponent of, and true minister to, the higher aspirations of man. Singing is that natural method by which thoughts are reduced to feelings. Listening, our hearts seem to be loosened. Singing, the whole soul and passion will rise, and be articulated. In the effort, you realize truths and feelings you never had before, and a yearning comes for higher aims and a brighter life.

Let us picture one scene. A poor, lonely girl sits listening to some melodious masterpiece. The lines of hardship and suffering traced on the face seem less stern as the half-closed eyes show that her heart is far away. She dreams her dream of peace—but she cannot find that peace. The angel of music seems to have been near and listened to the sorrows of her heart, restless, unsatisfied, longing. For one moment the lovely music fills her cup of life to the brim. The flood of emotions is too much for the fragile soul, and the heavy heart breaks in a rain of tears. But the sighs scatter the storm, the sky is clearer than before, and the deep blue heaven of the soul is seen. Freshness is thus brought to the tired life, and buoyancy to the heavy heart. Who will dare say that he is not the better for it?

Seeing, then, what a great part of the needful solace and recreation of man's higher life can be derived from music, it is not to be wondered at, that last Sunday found a Church started with music as the leading spiritual power. In the great city of London, Mr. Dumbor has purchased one of the largest buildings attainable, formerly known as the "Portland Bazaar." The building is capable of seating about 8000 persons. The gentleman names the edifice the "Church of the Holy Apostles," and proposes to make music the leading feature of the services. Here on a scale more magnificent and more gorgeous than ever known before, services will be held. He intends to have sixty surpliced choristers singing the most elaborate services. These will be first class soloists. The surpliced choir will be assisted by another choir of 100 voices, and by a full brass band, string, drum and harp. The body of the large building will be lighted by an enormous silver-gilt cross with four arms, the extremities of each arm containing a red-colored lantern, illuminated by the electric light. Costly pictures adorn the walls—one of these pictures being an enormous "Nativity" by Paul Veronese. Thus, the first Sunday in November finds started what may be called a natural outcome of the growing culture and aestheticism of the age. The contemporary analyst will watch the movement with interest, as it is one wholly disconnected with any church or sect.—a movement started simply for the purpose of giving what is the highest and best in the region of devotional musical art.

Bradaldane Notes.

The Railway track west of Elliott's Station, is now being laid with steel rails.

Several young men belonging to this place have returned from different parts of the Dominion, where they have been seeking their fortunes; among whom we notice in particular our friend Peter Dunn, who has lately returned from a tour through New Brunswick.

Missionary Services.

Missionary Sermons, according to advertisement, were preached in the Methodist Churches of this city on Sunday last. The pulpit of the Second Church was occupied by the Rev. Prof. Burwash in the morning, and by the Rev. S. S. Teed, of Tryon, in the evening. Both of these sermons were masterly productions, and worthy of the theme which prompted their fervid and eloquent utterance. The Church on Prince Street was favored with two remarkable discourses from the lips of the Rev. Dr. Young, Superintendent of Methodist Missions in the Northwest. These sermons together formed a full and able exposition of the Missionary enterprise—its nature, its workers, and their requirements. Dr. Young is one of the most graceful pulpit orators we have ever heard. His power of logic and pathos, combined with a glowing enthusiasm, place him in the front rank of public speakers. It is, however, on the platform the Reverend gentleman excels. His description of pioneer life and missionary labor in the Northwest, are said, by those who have had the pleasure of hearing him to be intensely interesting. Dr. Young acted a prominent part in the Red River trouble, and gives a thrilling account of the celebrated Scott tragedy, of which he was an eye-witness. Those who desire an opportunity of hearing this widely experienced missionary should avail themselves of the Missionary Meeting to be held in the Prince Street Brick Church to-night, to commence at half-past seven.

Political Meeting.

A meeting was held at Whim Road Cross, school house on Thursday evening, 2d inst., for the purpose of considering the propriety of doing away with the Legislative Council.

Mr. McDonald, the anti-abolition candidate, spoke first giving the grounds upon which he sought the suffrages of the people, and stating that if he were returned he should endeavor to sustain the Council.

Mr. Clow, the abolition candidate, also addressed the meeting. He stated that in his opinion, the usefulness of the Legislative Council was passing, and that the time had come when the people should do away with all unnecessary show and expense. After giving his platform and the reasons therefor, he said if elected he would go square for the abolition.

Hon. Samuel Prowse, Dr. Robertson, Manoh Doe, Angus Finlayson, Campbell, and F. J. Hoyt addressed the meeting.

Considering that this is the stronghold of the anti-abolitionists and judging from this meeting we think Mr. McDonald's chances not very flattering, and believe that Mr. Clow will be returned—as he ought to be—with an overwhelming majority.—Com.

Meeting at Peake's Station.

NOMINATION OF MR. BOLGER ENDORSED.

A meeting of the electors of the First Electoral District of King's County was held at Peake's Station, on Saturday, Nov. 4th. Mr. Patrick O'Donnell was unanimously elected chairman, and the undersigned secretary.

Hon. Mr. Bolger first addressed the meeting. He reviewed his past career to some extent, and advocated the same as he did eight years ago, and laid the same platform before them as he had done then.

Dr. Fraser next addressed the meeting. He replied briefly to some remarks made by Mr. Bolger.

Mr. Hooper, M. P. P., then addressed the electors. He said, although not opposed to Mr. Bolger's views in regard to economy in legislation, still, as Mr. Bolger did all in his power against him during the local campaign, he would try and pay him back in his own coin.

The meeting was also addressed by Mr. McLachlin and Mr. H. Mooney. Mr. Bolger was proposed by Mr. Henry Mooney and seconded by Mr. John Dougan and Mr. H. Mooney, and carried almost unanimously, there being only one dissenting voice.

After a vote of thanks to the chairman the meeting adjourned.
