little cupboard the poor widow possessed.

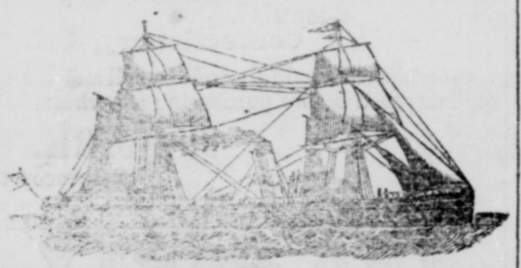
And why did she go to the cup-

with all the pride of worldly sophistry

ne desires, poor Mother Hubbard,
the widow, whom many thoughtless
worldlings would despise, in that she
only owned one cupboard, perceive—
or I might even say, saw—at once the
relentless logic of the situation, and
yielded to it with all the heroism of that
nature which had enabled her without
deviation to reach the barren cupboard.
She did not attempt, like the stiff necked
scuffers of this generation, to war
against the inevitable; she did not try,
like the scalled men of science, to
explain what she did not understand.
She did nothing. "The poor dog had
none?" And then at this point, our
information ceases. But do we not
know sufficient? Are we not cognizant
of enough?

Who would dare to pierce the veil
that shrouds the ulterior fate of old
'Mother Hubbard,' her poor dog, the
cupboard, or the bone that was not
there? Must we imagine her still
standing at the open cupboard door;
depict to ourselves the dog still drop-
ping his disappointed tail upon the floor;
the sought for bone still remaining
somewhere else? Ah, no, my dear
brethren; we are not so permitted to
attempt to read the future. And should
we, like her, ever be left a hungry dog
and an empty cupboard, may future
chronicles be able to write also of us,
