

Interesting Talk On Experiences In Far East

Last evening Rev. Cornelius Pineau, S.J., who recently returned to his home in Rustico for a rest from his labours in the mission field in China, gave a very interesting talk on his experiences in the Far East to a large audience in Queen Square School auditorium.

This gifted speaker, who has already appeared before several groups here, was sponsored last night in a public appearance by the Charlottetown council of the Knights of Columbus.

After describing the mission field centred around Suchow, with which he was identified, Father Pineau by the aid of a blackboard demonstrated the written characters of the language. He quoted many instances of Chinese customs which drew a vivid picture of the difference between the Occidental and Oriental mind.

"Our work at the Mission was beset with success and peace until 1937 when the Japanese invaded China," said the speaker, and for the three years following we were tolerated by the invaders. However, when the Allies inflicted the first major reverse on the Japanese, their attitude stiffened, largely due to the troops getting out of hand, resulting in the shooting and pillaging of foreigners."

This was followed shortly by the Japanese high command ordering all missionaries to concentration camps. Eventually, with the defeat of the Japanese, Father Pineau and his associates were enabled to return to Suchow to gather up the threads of their work.

When the Communists came in during December 1948, they proclaimed that all missionaries, Catholic and Protestant, would be protected. This only lasted about a month when the new familiar pattern of infiltration became evident.

"The Communists' main purpose is to establish a materialistic regime," said Father Pineau, "which requires as a first move, the entire obliteration of religion." He commended the strong moral fibre of the Chinese Christian students in resisting the efforts of the Reds to divert them from their accepted course.

"The complete, unselfish devotion and sacrifice to the cause of world Communism by every Red can only be met and turned back by a spiritual and moral re-dedication of the free people of the world," he concluded.

Forty-five minutes of sound film followed the address of Rev. Father Pineau. This film was produced to show the artistic concepts of three large cities, Nanking, Peking and Shanghai, and was the work of American Jesuits previous to the Communists' invasion and uprising.

The meeting was presided over by Mr. Leo Callaghan, of the staff of Queen Square School.

Keen enthusiasm made up for lack of experience when Charlottetown Little Theatre Guild opened their season last night.

Three Canadian one-act plays, a psychological drama, a Biblical piece, and a comedy, played to a near-capacity audience at the Empire Theatre.

The best play in the opinion of the adjudicator, Mrs. Barbara Roper, assisted by a committee, was "To What Purpose", directed by Coelia Blatch. Eleanor Hughes, who played Hester Warren in "Still Stands The House" was the best actress and Diok Turpin as Jim Cripps in "A Point Of View" was the best actor.

"Still Stands The House", the psychological drama directed by Bert Foster, played against the stark, stormy prairie setting. The house itself plays an important part—"once it held the warm surge of life; even now against the violent storms of nature and human emotion—still stands the house." The excellent settings and sound effects did much to create the realistic atmosphere of the Gwen Pharis Ringwood drama.

Eleanor Hughes as Hester Warren, the stern, austere, unhappy, neurotic old maid, fully deserved the commendation of the adjudicator. Fine support was given by Nell Hansen as the young husband, Louisa Rositer as the pretty, lively wife, and J. T. Place, as the real estate agent.

Costumes were especially notable in "To What Purpose", a drama written by Lorette Boesonneault and Bernice Chapman, based on an incident in the New Testament. Let him without sin cast the first stone was the theme illustrating the conversion of the hard, mercenary shopkeeper played by Marion Younker.

A fine interpretation of a crippled, ragged beggar-woman was given by Etta Bell. Alta Prowse was charming as the young ex-dancing girl, Liria. The gossiping wealthy customer, Jassa, by June Ekoud, and Phara as the penitent woman of the streets by June Dickson, were well done.

High point of the evening was Dick Turpin's interpretation of the burglar Jim Cripps in the comedy "Point of View", also directed by Mr. Turpin. Lloyd Yeo played the innocent gullible husband, Eric McGregor as Sir Robin Lowther, the "would-be" home wrecker and Gladys MacMillan as the shallow selfish wife. The play was written by Marion Osborne.

In general, the adjudicator and her assistants felt the plays were well done with their chief criticism being that there was too much blocking during the scenes, a fault common to less-experienced players, and easily overcome through continued practice. The audience enjoyed an evening of interesting entertainment "at the theatre."

Death Found Due To Natural Causes

"That Edward Berrigan came to his death on Saturday evening, November 14, 1953, at the City Police station from natural causes," was the verdict reached by a coroner's jury after hearing evidence submitted before Coroner Dr. L. E. Prowse at city hall last evening.

Miss Freda Gallant employed at King Cafe gave evidence that the deceased showed symptoms of being in distress while eating supper in the cafe and put in a call to police headquarters. Const. Russell Downie testified that he brought the deceased to the police station and called Dr. Rachman within 15 minutes. Dr. Rachman gave evidence as to arrival at the police station, when upon examination he pronounced the patient dead.

Mr. William MacDonald, time keeper at city hall gave evidence of having talked with the deceased shortly after noon when he appeared to be normal.

Dr. J. H. Shaw who performed the autopsy gave evidence as to the presence of alcohol in the circulating blood and concluded by saying: "The cause of death was considered to be due to myocardial failure due to acute alcoholic poisoning." Questioned as to whether this could be due to acute indigestion, he replied in the affirmative.

The jurors then retired and after brief deliberation brought in the above verdict. Jurors were Messrs. Thomas White (foreman), Holly Archer, William Brown, Hawley Crockett, Ernest Sailer, Harry Hardy and Gerard McInnis. Mr. J. P. Nicholson represented the Crown.
