PROVINCIAL LEGISLATURE.

HOUSE OF ASSEMBLY.

WEDNESDAY, June 24.
AFTERNOON SESSION.

House met at 3.30. Dr. Jenkins presented a bill entitled, "An Act amending the City of Charlottetown Incorporation Act," which was read a first time and made the order of the day for second reading to-morrow.

THURSDAY, June 25.
FORENOON SESSION.

House met at 11.30. An Act incorporating the Minister and Trustees of the Presbyterian Church of Tryon and Bonshaw was read a first time. An Act incorporating the Charlottetown Woolen Mills Company was referred to the Private Bills Committee.

The Act amending the City of Charlottetown Incorporation Act was read a second time in Committee, Mr. Gordon in the chair.

Dr. Jenkins, who has charge of the Bill, explained its provisions. He said it provided that the number of City Councillors shall be reduced from 10 to 8—that Wards 1 and 2 shall have one representative each, Ward 4, two, and Ward 5, three. This, he thought, would, as nearly as possible give representation by population.

Mr. A. J. Macdonald said he did not think the new bill was any improvement on the present arrangement. He wanted to know if there was any special reason for reducing the number of Councillors.

Dr. Jenkins said he did not know of any particular reason for making a reduction in the number of councillors, but he thought eight was quite enough.

Mr. Arsenault thought they were beginning wrong end first—that the House had no time to spend over a bill that might not become law after it was passed by the House. The wishes of the people should first have been ascertained.

Mr. Warburton spoke in favor of the bill, and said he thought the desire of the people for a change was made manifest when they elected Dr. Jenkins.

The Leader of the Opposition thought there was no doubt as to the feeling of the people on the subject, as their action in electing Dr. Jenkins showed that they desired a change. He did not think it made any material difference whether there were eight councillors or ten. He, however, had his doubts about the qualifications of the electors when the bill is submitted for the approval of the people. He thought that all who have become qualified to vote since the last election for mayor should be allowed to vote as well as those who voted on that occasion.

Dr. Jenkins said he thought that all who paid their taxes would be allowed to vote as usual.

The Leader of the Government spoke in favor of the principle of the bill. Its object was to give representation by population as nearly as possible, and it would not become law until approved by the people at the polls.

Mr. Rogers spoke against wards and ward politicians. He thought that under the proposed arrangement the representatives of Wards 4 and 5 could outvote the representatives of the other three Wards—the wards in which almost all the business of the city was transacted.

After some further discussion, progress was reported and the House adjourned.

AFTERNOON SESSION.

House in Committee passed the bill relating to the City of Charlottetown, with amendments.

Mr. Bell asked the Provincial Secretary to lay on the table of the House

1. A copy of the contract (if any) entered into by the Government of this Province with the Charlottetown Driving Park and Exhibition Association, relative to the holding of Provincial Exhibitions.

2. Copies of any contract or contracts (if any) entered into by the Government of this Province with any body, corporate or association relative to the holding of the annual County Exhibitions in King's and Prince Counties.

3. Copies of the returns filed with the Clerk of the Executive Council, specifying in detail an account of the receipts and expenditure of the several exhibitions of last year, so far as relates to the Government subsidies.

Hon. Mr. McMillan replied that the papers would be placed upon the table at an early date.

Mr. McKay asked the Commissioner of Public Works whether the Government had entered into any contract for the packet service between Charlottetown, New London and Rustico, and that the contract be laid upon the table.

Hon. Mr. McLean said that the lowest tender had been taken. The papers would be laid upon the table at an early date.

Mr. Bentley asked the Commissioner of Public Works what steps have already been taken towards opening a new road leading from Sea Cow Head Road towards Hard's Point Wharf, Lot 26, and whether it is their intention to proceed any further with the opening of the road this season?

Hon. Mr. McLean replied that an investigation had been held, and the Government will endeavor, if possible, to have the work completed.

Mr. Rogers asked the Commissioner of Public Works if the Supervisor of Roads for Township No. 17, Prince County (Mr. B. S. Mills), has been dismissed, and if so, for what cause, and who has been appointed in his place?

Hon. Mr. McLean replied that he was not aware that there is a Supervisor for Township No. 17.

Mr. Rogers said Township No. 17, Prince County, District No. 11?

Hon. Mr. McLean evaded the question. Mr. H. C. McDonald asked the Commissioner of Public Works if the contract of J. W. McDonald, at Dixon's, Lot 58, has been completed? If the same has been

completed what was the total amount paid for such work, and to whom? Hon. Mr. McLean replied that the contract is not finished. The sum of \$200 has been withheld by the Government.

Mr. Rogers asked the Commissioner of Public Works if the Inspector appointed to superintend the building of Mink River Bridge (Mr. R. Keefe) had been dismissed, and if so, the reason of his dismissal. Hon. Mr. McLean replied that the reason was that the Inspector had been hand in glove with the contractor—which is not desirable.

Mr. McKay presented a petition from Jas. Arthur, John Rolling, Charles Dickson, Wm. J. Simpson and other tenants of that portion of the estate of the late John Hodges Winstable now held by Mrs. S. W. Smith, praying that the Government take such measures as will place the tenants on this portion of said estate in the same position as other holders of land in this Province.

Mr. Peters objected that the petition should first be handed to the Government.

Mr. McKay said that he wished to call the attention of the Legislature to this important matter at the earliest possible moment. House adjourned.

Ottawa Correspondence.

Although privileged to be an eye witness of some and a participant in other of the scenes of the past few weeks, destined as they are to constitute an important page in Canadian history, your readers were already so fully conversant with the story of the last illness, the death and burial of Sir John Macdonald, that I forebore inflicting myself upon them last week.

Despite the predictions, the hopes and fears of the grits, it did not take long to find a new premier, nor many hours for him to form a new Cabinet. Now, I am not going to tell you whether the Government-General passed over Sir Hector Langevin, and called upon Sir John Thompson, who found his religion a stumbling block, for I do not know. Neither am I aware, except from reading it in the Patriot or some other equally unreliable sheet, that His Excellency threatened that if Mr. Abbott did not come to time he would call on Mr. Laurier without any further notice.

All I know is what the public know, and that is all that is necessary to be known, that Mr. Abbott was called on to form a new administration on Saturday, and that without any breach of the fourth commandment, he completed his task at an early hour on Monday; that all the members of the late cabinet consented to retain their portfolios under his premiership, and that business is being conducted at the old stand, according to the old lines and without any change of name. I am well aware that, according to the most authentic sources, Mr. Chapleau kicked so badly that he sprained his ankle and has been laid up ever since, and I know also that grit reporters manufactured and published lengthy interviews with that gentleman in which he was made to say a great many foolish things—things which are unworthy of any man in his position, and which no man of ordinary common sense would utter, to say nothing of Mr. Chapleau, who is nobody's fool. It is a favorite pastime of the Ottawa Free Press—of which our friend Gorman, formerly of the Summerside Progress, is editor—to illustrate the dissatisfaction and general unpleasantry which are said to exist in the Conservative party, by publishing interviews with (always) prominent Conservatives and leading Tories, who, having been seized with an uncontrollable desire of telling all they know, fall at Gorman's feet (where, the Lord knows, there is plenty of room for three at a time) and open their grief. Nor will they be satisfied and resigned until the said Gorman promises them forthwith to publish all they have told him, and a great deal more, in the Free Press, which he does right up to time. Then the Free Press goes abroad and the St. John Telegraph, and the Halifax Chronicle, and the Charlottetown Patriot, and last but not least (two or three weeks afterwards) the Summerside Pioneer reprint all these confessions of penitent Tories and humbug their innocent readers.

I laughed myself all into a kink this morning (22d) when I read in last Thursday's (18th) Summerside Farmer that unless Abbott completed his cabinet at once Laurier would be summoned to try his hand. The sweet creature who runs the Farmer has been asleep again! Why, Abbott had completed his cabinet-making on Monday, and THE EXAMINER had announced it three days before from which we were up to pen the paragraph from which I have made this precious extract. Need I be surprised that I am occasionally taunted with coming from an Island three days outside of civilization, when I read such "rot" in one of her leading papers.

The Patriot is very little better. It has a correspondent somewhere between here and Charlottetown who supplies it with a vast deal of "Ottawa News" that is news indeed to us when it arrives here. It was intensely amusing to read the leading article in one of its last week's issues. It had Laurier at the head of affairs, passing all necessary supplies, rushing the revision of votes, and making an appeal to the country at the earliest possible moment. Strange to say, however, it was guilty of a notable admission in Laurier's programme. It said nothing of dismissals of Tories and appointments of grits to office. Apropos of dismissals, I hear that some startling changes will soon be made among civil service and railway employees on the Island.

Mr. Laurier is not yet premier of this Dominion, and from present appearances it will be some time ere that calamity shall occur. The grits experienced much amusement over what they imagined a difficulty on the part of the Conservatives to find a chief, but it does not take much of a prophet to predict that Mr. Laurier will never be the grit premier of Canada. The party have been hard enough to please in opposition, having deposed both Mackenzie and Blake, but did victory perch on their banners there would be a great many that must be borne in mind that Mr. Laurier is Leader of the Opposition only in name, for really he is joint leader with Cartwright,

Mills and Dav'el. The leadership is really in commission.

Mr. Abbott is premier of Canada I may say for the information of the Island grits, and so far the grit party in parliament have had precious little to say about it. I put in the hottest hour I ever spent (except yesterday in church) last Tuesday in the House, anticipating some fun over the announcement of the new ministry and the arraignment of Michael Connolly at the Bar of the House for contempt. I waited long and patiently (I suspected the fun would commence. But it did not; the grits listened quietly and I was disappointed. But I thought there would be surely some fun when Michael Connolly came up. It was 25 minutes to four when he was called, but as Michael had been summoned for four o'clock he had no notion of attending a minute before that hour, so the House had to go on with other business meantime. Precisely on four the Deputy Sergeant at Arms announced that Michael was in waiting, and he walked attended by his lawyer, Mr. Ferguson. Then Sir John Thompson moved that the report of the committee detailing Michael's insolence and insubordination be read, which Mr. Rouleau occupied exactly 25 minutes in doing in his own peculiar volapuk, while I mopped my head. All this time the aforesaid Michael was standing uncomfortably before what he afterwards described as the dryest bar he ever stood up to in his life. The reading being finished, Sir John Thompson moved the House to enquire of Michael whether he would produce the books. Whereupon Michael's lawyer advanced and for another 25 minutes explained why Michael had not produced, and should not produce, and would rather not produce the books, winding up with the statement that if the House really meant what it said, and were bound to have the books, nothing would give him greater pleasure than to produce them. Michael was ordered to produce the books immediately if not sooner, after which it was six o'clock, and the maddest crowd for sometime vacated the gallery.

Mr. Laurier says he is going to move a vote of want of confidence, but as he will not have an opportunity before next week, the probability is that the government will last till that time.
