Warmest February On Record Locally

Records examined covering a period of 44 years indicate that we have just passed through the warmest February on record, according to information released yesterday by Mr. Warren Burns of the Experimental Farm Meteorological Department. The mean temperature was 26.9 or one degree higher than the previous high which was in 1951. The highest temperature during the month was 49 on February 22nd and the lowest on the 14th when ten below zero was recorded. The highest on record was in 1936 when the temperature was up to 53. The lowest recordings were in 1914, 1922 and 1934 when the temperature dropped to 2 below zero. The rain average for February is .89, or less than one inch but this year the readings indicated a fall of 3.54 inches in addition to 15 1-2 inches of snow which made the total precipitation 5.06 inches. The average snowfall is 25 inches, with a total average precipitation for 44 years of 34.4 inches. The daytime temperature averaged 33.7 and the Maximum night temperature 20.2. Over the 44 year period the day averaged 25.9 and the night low 9.9 or nine degrees above average which in the 44 year period was 17.9 and this year 26.9.

Puerto Rico Under Wing Of The U. S. Since 1898

By CARL HARTMAN WASHINGTON, (AP) — Puerto Rico, an island in the heart of the Caribbean almost the size of Cape Breton, has been under the wing of the United States since its people welcomed an American Army as liberators in the Spanish-American war of 1898. Its people, who now number 2,210,000, acquired more and more home rule as the years went on. The constitution proclaimed in July 1952 makes self-government nearly complete, and Puerto Rico became a "commonwealth" attached to the United States. Washington still runs its foreign affairs, maintains military bases and operates the postal service. Some law cases go to the U. S. Supreme Court. Puerto Ricans are U.S. citizens, and enter and leave continental United States without restriction. Representative A.L. Miller (Rep. Neb.), chairman of the House of Representatives interior and insular affairs committee, said Tuesday he is considering offering a bill to make Puerto Rico independent so the United States would have some control over the movement of Puerto Ricans to these shores. "Deeply Indignant" Governor Luis Munoz Marin of Puerto Rico rushed here by special plane today to assure the United States that the people of the island are "deeply indignant" over Monday's shooting affray in which fanatical nationalists sprayed the House of Representatives with bullets. For many years the big political issue in Puerto Rico was statehood versus independence. In 1946 Munoz Marin, formerly one of the leading advocates of independence, won an election by advocating that the issue be put aside in favor of work on the island's pressing economic problems. Munoz Marin has dominated the island's politics ever since. In the 1952 election, statehood advocates polled fewer than 85,000 votes out of more than 650,000. The independenceists were 125,000 strong. But this group favors independence by peaceful means. The nationalists boycott elections and prefer terror to achieve their ends. They probably number fewer than 5,000.
