

Increase In Oyster Catch In December

A large increase in the oyster catch during December, 1950 compared with December of the previous year is noted in the figures of the December fish catch which were released yesterday by Mr. J. Larabee, Director of Fisheries for the Province.

280,000 pounds of oysters bringing a total value to the fishermen of \$8,294. Total value of the catch was about \$2,489,567 compared with \$2,053,151 for 1949.

The bulk of the money in the fish catch was derived by the lobster fishermen. They collected \$1,935,966 for the 9,097,800 pounds of lobster they caught.

The small catch, due to poor weather conditions, showed a decrease in December 1950 as against that of December of the previous year.

Communism China has sought the U.N. representation held by the Nationalist China.

The broadcast was made this morning after two postponements of what had been heralded as an "important announcement." It was monitored in Tokyo.

In a preamble to the text of Chou's statement the Peiping radio said the "first committee" of the U.N. Assembly had rejected the appeal for a 12 Asian-Arab nations calling for a seven nation conference on Korea and other Asian issues.

It said the committee rejected amendments offered by Soviet Russia to that Asian-Arab resolution, then illegally adopted the U.S. resolution.

The General Assembly "in the same manner illegally adopted the U.S. resolution," the broadcast said.

Both Sides Found Negligent In Collision Case

The final civil jury case at the January hearings of the Supreme Court closed yesterday before Justice Mark R. MacGuigan with both the defendant and the plaintiff being found guilty of negligence in a collision which occurred on October 2, 1949, at the intersection of Rochford and Kent Streets.

Edward J. Praught, plaintiff, was found 35 percent negligent, and the defendant, Melvin Jenkins, 65 percent. After each side pays their percentage of the damages awarded to the other the plaintiff will benefit by \$215.

Members of the jury were Messrs Harold Hennessey (foreman), Louis Sherrin, Fred Buchanan, Wendell Mayhew, A. W. Wellner, Victor Livingstone and William Wheatley.

Decisions by the jury in answer to the questions submitted to them by the court were as follows:

1. Was the defendant, Melvin Jenkins, in the operation of his motor vehicle, guilty of negligence which caused or contributed to the collision? (Yes).

2. If so state the acts or omissions in which the defendant was negligent. (Did not keep a look-out for traffic).

3. Was Edward Irving Praught, in the operation of the plaintiff's motor vehicle, as servant of the said plaintiff, guilty of negligence, which caused or contributed to the collision? (Yes).

4. If so, state the acts or omissions in which the said Edward Irving Praught was negligent. (For not having proper regard for traffic).

After bringing in the above answers the jury was given four more questions which they answered as follows:

5. If the answers to 1. and 3. are yes, that is that both the defendant and the plaintiff were negligent, state in what degree or percentage you find each to be negligent. (Plaintiff 35 percent, defendant 65 percent).

6. What amount of damages did the plaintiff sustain as a result of the collision? (\$550).

7. What amount of damages did the defendant sustain as a result of the collision? (\$407).

At the conclusion of the case the court adjourned until 11 a.m. Monday morning when the first civil non jury case will be heard.

Lt. Cmdr. Bimore Reverts To Navy Retired List

Lieut. Commander C. A. Bimore has reverted to the retired list of the Royal Canadian Naval Reserve, at his own request, because of the pressure of business in his civilian occupation as accountant at the Bank of Nova Scotia.

Lt. Cmdr. R. C. MacMillan, D. S. C., and Mr. Bar, has been named Acting First Lieutenant of H. M. C. S. "Queen Charlotte" to succeed Lt. Cmdr. Bimore, who had been First Lieutenant of the local barracks for the past year and a half.

Lt. Commander Bimore joined the Supplementary Reserve of H. M. C. S. "Queen Charlotte" in the spring of 1939 when the local reserve division was under the command of J. J. Connolly, then a Lt. Commander. He was called to active service on Feb. 20, 1940 and proceeded to Kingston, Ontario, for courses at H. M. C. S. Stone Frigate, which was located at the Royal Military College. From there he proceeded to Halifax in May, 1940, for further training at the schools in H. M. C. S. Stadacona.

July of that year was appointed in charge of a signal station at Purple Head which controlled the traffic in and out of Bedford Basin.

Joins H. M. C. S. Annapolis

In September, 1940 when the Royal Canadian Navy took over six U. S. Navy destroyers, Bimore, then Sub-Lieutenant was appointed to H. M. C. S. Annapolis (the ex U. S. S. MacKenzie). He served in "Annapolis" on Convoy duty between Halifax and Newfoundland until November 1941 when he volunteered for an eight weeks group AS course in which he qualified in January 1942 and was appointed as Staff AS Officer on the convoy duty between Halifax and Newfoundland.

In July, 1942 he was appointed as Officer-in-Charge of the AS Training Barracks in Picton. In that capacity he was responsible for giving practical instruction to AS Officers and ratings who had been carrying out courses in the school in Halifax. In Dec. of the same year he was selected to take the six months AS course at the R. N. schools in England and proceeded overseas in that end.

On being qualified as an AS Officer on completion of courses at H. M. C. S. Osprey at Dunoon in Scotland and H. M. S. Nimrod at Campbellton, also in Scotland, Lt. Commander Bimore was appointed Staff AS Officer to the Thirty-Eight Escort Group, at that time on convoy duty between England and West Africa.

He was transferred in a similar capacity from Staff AS Officer 28th Escort Group to Staff Officer 40th Group in Oct. 1943 at which time he served in the Royal Navy Frigate H. M. S. Eby until the 15th day of April 1944 when he left the Royal Navy to serve as Staff AS Officer to the Senior Officer 6th Escort Group in H. M. C. S. Wasreslu.

Considerable Service

Whilst serving as Staff AS Officer of the 40th Escort Group, Lt. Commander Bimore was on convoy duty between England and Gibraltar. During his service with the 6th Escort Group he saw service in the Atlantic, North Sea, Irish Sea, English Channel and in the vicinity of the Faroe Islands.

He was relieved as Staff AS Officer of the 6th Escort Group in April, 1945 and returned to Canada following which he was attached to H. M. C. S. Stadacona and received his discharge from there. He then resumed his service at the Bank of Nova Scotia in Charlottetown.

In the fall of 1946 he joined the Active Reserve of H. M. C. S. Queen Charlotte. He has served there up until now and proceeded each year on Naval Training, on either course or training cruises. One of the latter took him to Bermuda and last spring he joined the cruise of H. M. C. S. Swansea to New York.

Condition Of Highways Now Much Improved

It was announced last evening that paved highways throughout the Province are pretty well clear of ice, except in the shaded areas. Travelling on gravel roads is also reported to be good.

Freak weather which had ranged from 16 degrees below zero three days ago to 47 above yesterday morning, however, had all modes of transportation tied up evenly yesterday.

Highways which had a thin coating of snow on their surfaces were turned to ice as one-half inch of rain fell during Thursday night. Cars and trucks travelling in and around the city yesterday morning were often abandoned when hills, too icy to traverse, were encountered. Just outside of Charlottetown, on the North River Road, cars waited for the government sander before attempting hills, rather than suffer the fate of those who had attempted to continue on their way and slipped into the ditch.

Maritime Central Airways planes had been grounded since Wednesday due to icy runways but resumed normal schedules yesterday afternoon. Island Motor Transport buses were also taken off the road, but as the temperature rose towards noon travelling conditions were greatly improved and they resumed their schedule.
