Quebec Social Crediter Makes Separatist Threat

OTTAWA (CP) — A Social Credit MP threatened Tuesday to advocate his party's conversion to Quebec separatism on the basis of the English press reports what he called a campaign of "degradation" of Social Credit proposals.

Antoine Belanger, member for Charlevoix, said his group is not separatist — "at least at present — but it might become so unless the English press "admits we should be interpreted honestly."

Speaking in the budget debate, Mr. Belanger said he was becoming impatient and that once his party lost hope of the coming election throughout the

country he would not hesitate to "suggest this (separatism) view to the party."

Mr. Belanger stressed that the views he expressed were personal and not necessarily those of the party.

He also suggested that the government, for its own good as well as for the good of the country, implement certain Social Credit proposals within the next two months.

Some of the items he mentioned were an increase in family allowances, higher old age pensions with an amendment to make them universally payable at 65, and a boost in income tax deductions to \$5,000 for

heads of families and to \$3,000 for single persons.

"These things should be done without increasing taxes or debt," he said.

NOT FUNNY MONEY

Mr. Belanger said his party's proposals could not be labelled "funny money" because the Canadian dollar was not backed by gold at present and there were "no strictly qualified for the old-fashioned funny money."

Man Hurt As Car Hits Horse

COLLISION — A car-horse collision at Tullipus Bridge, Indian River, at about 6:30 last evening, resulted in a. Stewart Carruthers, 47, Hamilton farmer and agent receiving severe head injuries which necessitated his being flown to hospital in Halifax, N.S. at midnight last night.

The accident occurred when Mr. Carruthers was travelling from Kensington toward Malbecque, and was proceeding on his own side of the highway. At the same spot John Hickey and Mrs. Mary Tynin, both of Indian River, were walking toward Kensington on the same side as the car, with the former leading a horse followed by a colt.

At the time Mr. Carruthers was accompanied by his daughter Donna, an employee at the Kensington branch of the Canadian Imperial Bank of Commerce.

Both were given medical examination at Kensington, and his daughter was found to be suffering only minor cuts and bruises. Mr. Carruthers' condition was found to be such that he was immediately moved to Prince George Hospital.

At the hospital medical authorities decided that his condition was such that arrangements should be made for his immediate transfer to Halifax.

The whole front end of the small car was extensively damaged, but it was not known if the horse had suffered any injury.

The horse is reported to have bolted immediately after the collision, and a wide search of the area by residents had failed to locate the animal at an early hour this morning.

Russians Dismantle Missile Bases

Blockade, Air War Which Are Both Suspended



WASHINGTON (CP) — A well-placed authority said Tuesday night the U.S. government has definite information that the Russians have started to dismantle their missile bases in Cuba, but that the dismantling procedure is puzzling the administration.

This authority said there is evidence that the Russians have started to move some of the missile equipment, but have not yet disconnected cables leading from power and control units to the missiles.

Officials find this puzzling since under the American disarmament procedure, disconnecting this cable is considered the first move in deactivating a ballistic missile. One view simply is that the Russians may follow a different procedure.

Authorities here are convinced, however, that the Russians are showing good faith in their pledge to withdraw the missiles and return them to the Soviet Union.

U.S. Secretary-General U. Thant of the United Nations flew to Havana Tuesday in a bid to set up machinery for specifying the dismantling of the missiles.

Meanwhile the United States (temporarily) lifted its arms blockade against Fidel Castro's island at dawn and announced suspension at noon of aerial visit to Cuba.

There also were strong indications, neither denied nor confirmed by the White House in Washington, that the U.S. had offered planes to the U.N. to conduct aerial reconnaissance during the removal of the missile sites.

Thant, expressing hope for a "speedy and peaceful settlement," flew from New York to Havana to implement the Kennedy agreement arrived at by President Kennedy and Premier Khrushchev after a week of crisis.

There were these other developments:

1. Assistant State Secretary Edwin M. Martin warned that Castro could upset the Kennedy-Khrushchev agreement with his recent demands including U.S. withdrawal from its naval base at Guantanamo, Cuba, in a Voice of America radio program, Martin said "we do not know how firmly he will insist on this condition which the country is living."

2. Havana radio said Castro would address his nation on radio and television Thursday "to analyze all the problems of the international situation in Cuba, which the country is living."

3. Republican Senators Kenneth H. Keating, New York; Joseph P. Kamp, Pennsylvania; and Barry Goldwater, Arizona, warned against any agreement which would allow the U.S. to remove the offensive weapons, had agreed these would be no U.S. property.

4. The U.S. Army issued a draft call for 6,000 men in December, the highest monthly call-up since 6,500 were announced last year.

China's Bid For UN Seat Defeated By New Margin

UNITED NATIONS (CP) — The United Nations General Assembly Tuesday turned down the latest bid to seat Communist China in the world body.

The vote was 42 in favor, 36 against and 12 abstentions, a somewhat wider margin than last year's defeat.

Several new African nations helped to vote down the Soviet resolution, but the abstention of Nationalist China and the seating of the Peking regime. Canada also voted to bar Communist China, as it has in the past.

Last year, the first year the United States was not able to put off a floor vote on the issue, the margin in a smaller General Assembly was slightly closer.

Although Britain and the Scandinavian nations again voted against the resolution, Tuesday's result was seen as a clear victory for the United States and its Allies. They strongly opposed seating Red China, citing Peking's military thrust into India as proof of its defiance of the UN charter.

India spokesman had argued that the most effective way to halt Chinese "military adventures" is to seat Peking in the U.N.
