Canadian Steel Report

OTTAWA, Nov. 13 (CP) - The Bureau of Statistics said today that production of steel in August was 25,212 tons, compared with 24,725 in August last year. In the first eight months of 1930 it aggregated 221,105 tons, against 218,920 in 1929.

Production of iron castings of all kinds in September amounted to 67,000 tons, compared with 53,200 in the preceding month.

The Bureau also reported consumption of scrap iron and steel in Canadian industry in 1929 amounted to 2,468,797 net tons, a decrease of two per cent from the preceding year's total of 2,509,702.

Steel furnaces were the largest consumers of iron and steel scrap in 1929 with a tonnage of 1,770,758 compared with 1,833,539 in 1928.

There was a very large attendance at the Remembrance Day ceremony at O'Leary. The members of the Legion, made up of the veterans of two World Wars, and marshalled by Ira Ellis and led by Dr. L. G. Dewar, paraded from the new O'Leary Legion Hall to the O'Leary school where they were joined by the school children who carried flags and by members of the Wolf Cubs led by their leader Mrs. Marie Kennedy, Cub mistress, and by the Boy Scouts under command of Emmerson Smallman, and the entire parade then proceeded to the Cenotaph in the center of the village of O'Leary. The Master of Ceremonies was William Turner of O'Leary, Principal of the school, and a veteran of World War Two. The two minutes silence was observed. Prayer was offered by Rev. C. O. Howlett of O'Leary who lost a son in the second World War. Wreaths were then laid at the Cenotaph by relatives and members of the families who had lost loved ones. The parade then marched to the Verdun Theatre in O'Leary for a further program.

The Theatre was packed. Mr. Turner was Master of Ceremonies. The program opened by singing "O Canada". Mr. Turner then gave a few remarks stressing the importance of observing Remembrance Day and mentioning the Four Principles that are our heritage because of the sacrifice of those who died in the wars. The Hon. President of the Legion Dr. L. G. Dewar was then heard in brief remarks and he was followed by the President of the O'Leary Legion, Lloyd Matthews. Dr. Dewar stated that a plaque containing the names of those who fought and those who gave their lives in World War Two will shortly be placed on the Cenotaph.

Mr. Matthews thanked the citizens for their interest and co-operation in the Remembrance Day services.

The school children then presented a few items which were well done and greatly enjoyed. Peter Pate recited "In Flanders Fields" and also was heard in a patriotic reading. There was an exercise, "Let Us Forget" by the following pupils: Calvin Carruthers, Billy Bernard, Grace Sarrath and Margaret Woodridge.

The first speaker was Rev. C. O. Howlett of O'Leary who explained the significance of Remembrance Day. He was followed by Rev. W. G. Dickson also of O'Leary who stressed the importance of morale and faith in the justice and truth of our democratic principles. The third speaker was Rev. Father M. J. Rooney of St. Anthony's Parish in Bloomfield. He stressed how great is our debt to those who died for liberty and freedom. The last and the main speaker was Capt. the Rev. J. R. Mahon of the Royal Canadian Chaplains Corps, a veteran of the last war and also a chaplain at present and is the Rector of the Church of England Parish of Alberton.

His address was timely, interesting and instructive. He told of the importance of the Chaplaincy service in two World Wars and especially in the Second War and how the king had been graciously pleased to bestow upon the chaplaincy service the coveted title of "Royal". Illions Prowse and O'Donnell to increase the salaries of the five highest civic employees", continued Coun. Johnstone. "When it was brought to my mind I thought it was a recommendation and would not sign it. I will have to check each month one month against the other to see if some big-hearted Councillor grants increases."

"I protest against the manner in which this thing was done. I cannot see why a clerk who gets \$3,500 a year should get an increase in salary while there are other employees who cannot make ends meet."

Councillor Cox stated the action was illegal and should not pass. "We should be in no big hurry to get rid of this \$1,200, it will not explode," he stated. "It has been given to the highest paid officials and not to the lowest paid. There is an employees' association from which a request for increases should come and no requests in such matters have been received."

One of the Councillors thought that it was a bonus, not an increase. There is nothing so secret that it cannot be brought before the public, he added.

There are some things that they try to keep from the public, stated Coun. Johnstone.

Coun. O'Donnell explained the situation by stating that the question arose following the retirement of a highly paid civic employee. Mr. John Butler took over the duties of the former employee and was performing his duties at a much lower salary whereupon the Council members decided that the differences in salaries should be paid out in salary increases.

Coun. Johnstone must have known about it," stated Coun. O'Donnell, as he signed the bills.

"The first I heard of it was at a meeting of the Finance Committee," replied Coun. Johnstone.

School Board Request

The City Board of School Trustees requested the Council to take some definite stand on the proposal that at least eight acres of land on the Malpeque Road be purchased for the erection of a City school.

The property is owned by Mr. George Dewar, who will not sell unless he receives \$2,000 an acre for an amount of land not less than eight acres. Mr. Dewar informed the Board of Trustees that he could not hold the land later than Nov. 15.

Councillor Cox stated that the Council had no business buying property outside the City. Councillors Keefer and Gormley did not think the City could afford to buy the property at present and Coun. O'Donnell suggested that the Council let Mr. Dewar sell the property to some one else.

Coun. Johnstone felt the City needed the school and could not lose much money by buying the property. Coun. Stewart suggested that the City take an option on the property for a month or two during which they could decide about buying it.

Mayor MacDonald asked the members if they were in favor of this suggestion but on receiving no response one way or the other stated that the Council "can not do anything tonight."

Mr. Earl Baker, from the Board of Trustees, stated that the property was on the centre line of any proposed expansion of the City and that the site must be large enough to provide playground for the children. He stated that Mr. Dewar could sell part of the property and would like to prepare the remainder for the seeding of trees.

Grant To Guild

The Council voted a sum of \$500 to be paid the Prince Edward Island Arts and Crafts Guild for 1930 following a resolution presented on behalf of the Guild by Mr. Arthur Clark and the annual grant of \$1,000 he renewed and that \$500 be made available at the earliest convenience and the remainder as soon as possible after the beginning of the year.

Mr. Turner then gave a few remarks stressing the importance of observing Remembrance Day and mentioning the Four Principles that are our heritage because of the sacrifice of those who died in the wars. The Hon. President of the Legion Dr. L. G. Dewar was then heard in brief remarks and he was followed by the President of the O'Leary Legion, Lloyd Matthews. Dr. Dewar stated that a plaque containing the names of those who fought and those who gave their lives in World War Two will shortly be placed on the Cenotaph.

Mr. Matthews thanked the citizens for their interest and co-operation in the Remembrance Day services.

The school children then presented a few items which were well done and greatly enjoyed. Peter Pate recited "In Flanders Fields" and also was heard in a patriotic reading. There was an exercise, "Let Us Forget" by the following pupils: Calvin Carruthers, Billy Bernard, Grace Sarrath and Margaret Woodridge.

The first speaker was Rev. C. O. Howlett of O'Leary who explained the significance of Remembrance Day. He was followed by Rev. W. G. Dickson also of O'Leary who stressed the importance of morale and faith in the justice and truth of our democratic principles. The third speaker was Rev. Father M. J. Rooney of St. Anthony's Parish in Bloomfield. He stressed how great is our debt to those who died for liberty and freedom. The last and the main speaker was Capt. the Rev. J. R. Mahon of the Royal Canadian Chaplains Corps, a veteran of the last war and also a chaplain at present and is the Rector of the Church of England Parish of Alberton.

His address was timely, interesting and instructive. He told of the importance of the Chaplaincy service in two World Wars and especially in the Second War and how the king had been graciously pleased to bestow upon the chaplaincy service the coveted title of "Royal". He stressed most emphatically that conditions in O'Leary were far from what they should be and made an impassioned appeal for the citizens to live lives worthy of those who died and to rally round their religious leaders and their churches to make O'Leary a better place than it is at present. He closed by leaving the large audience this searching question: "Are our lives good, true and faithful enough that we can tell our Governor that we are a 'Royal'?"

There was a banquet in the night in the new Legion Home.

Illions Prowse and O'Donnell to increase the salaries of the five highest civic employees", continued Coun. Johnstone. "When it was brought to my mind I thought it was a recommendation and would not sign it. I will have to check each month one month against the other to see if some big-hearted Councillor grants increases."

"I protest against the manner in which this thing was done. I cannot see why a clerk who gets \$3,500 a year should get an increase in salary while there are other employees who cannot make ends meet."

Councillor Cox stated the action was illegal and should not pass. "We should be in no big hurry to get rid of this \$1,200, it will not explode," he stated. "It has been given to the highest paid officials and not to the lowest paid. There is an employees' association from which a request for increases should come and no requests in such matters have been received."

One of the Councillors thought that it was a bonus, not an increase. There is nothing so secret that it cannot be brought before the public, he added.

There are some things that they try to keep from the public, stated Coun. Johnstone.

Coun. O'Donnell explained the situation by stating that the question arose following the retirement of a highly paid civic employee. Mr. John Butler took over the duties of the former employee and was performing his duties at a much lower salary whereupon the Council members decided that the differences in salaries should be paid out in salary increases.

Coun. Johnstone must have known about it," stated Coun. O'Donnell, as he signed the bills.

"The first I heard of it was at a meeting of the Finance Committee," replied Coun. Johnstone.

School Board Request

The City Board of School Trustees requested the Council to take some definite stand on the proposal that at least eight acres of land on the Malpeque Road be purchased for the erection of a City school.

The property is owned by Mr. George Dewar, who will not sell unless he receives \$2,000 an acre for an amount of land not less than eight acres. Mr. Dewar informed the Board of Trustees that he could not hold the land later than Nov. 15.

Councillor Cox stated that the Council had no business buying property outside the City. Councillors Keefer and Gormley did not think the City could afford to buy the property at present and Coun. O'Donnell suggested that the Council let Mr. Dewar sell the property to some one else.

Coun. Johnstone felt the City needed the school and could not lose much money by buying the property. Coun. Stewart suggested that the City take an option on the property for a month or two during which they could decide about buying it.

Mayor MacDonald asked the members if they were in favor of this suggestion but on receiving no response one way or the other stated that the Council "can not do anything tonight."

Mr. Earl Baker, from the Board of Trustees, stated that the property was on the centre line of any proposed expansion of the City and that the site must be large enough to provide playground for the children. He stated that Mr. Dewar could sell part of the property and would like to prepare the remainder for the seeding of trees.

Grant To Guild

The Council voted a sum of \$500 to be paid the Prince Edward Island Arts and Crafts Guild for 1930 following a resolution presented on behalf of the Guild by Mr. Arthur Clark and the annual grant of \$1,000 he renewed and that \$500 be made available at the earliest convenience and the remainder as soon as possible after the beginning of the year.
