Spear Those Appetites With A Surprise Kebob

KEBOBS can be classed as miniature foods when made of the finest meat and fish marinated, seasoned, and cooked to perfection. But whether the food is cooked on a sword or brochette, on elegant stainless steel skewers, over an indoor or terrace barbecue grill, or on a green stick over an open fire out of doors, it always remained class.

Large plates are used in doors for the service. They are bedded with hot buttered, curly or gingered fluffery, wild rice, Ceylon rice, or wheat pilaf, the kebob atop on the skewer. Measurements follow; recipes for 25:

HAM FRESH VEGETABLE KEBOBS
1/2 lb. sliced tenderloin ham (cut in 1/4 inch slices)
1/2 lb. peeled, large onion (cut in 1/4 inch slices)
1 tsp. salt
1 tsp. pepper
1/2 cup powdered ginger
1/2 lb. sliced tenderloin ham (cut in 1/4 inch cubes)
1/2 cup cherry tomatoes
1/2 cup olive oil (additional)
1/2 cup canned tomato sauce
1/2 cup mayonnaise
1/2 cup powdered orange
1/2 cup beef bouillon
Sprinkle sliced zucchini and onion with oil, salt and pepper. Stand 1/2 hr. Rub ginger and pepper on zucchini and onion. Arrange zucchini or onion and ham alternately on long skewers or brochettes, with 3 whole cherry tomatoes to each skewer. In center, others at ends.
