Suit Women's Education To Needs Of Today, Says Home Economist

Maritime Home Economists concluded a two-day conference in Amherst, N.S., with a convention dinner at the Fort Cumberland Hotel last Saturday evening. Miss Elizabeth MacMillan, Dean of Home Economics at Acadia University, presiding.

The guest speaker was Prof. Dora S. Lewis, chairman, department of Home Economics at Hunter College, New York City. "Reality in Home Economics," according to Mrs. Lewis, means suiting Home Economics education to the needs of women and girls living in the world of 1953. Skills such as cooking and sewing are a means to building better home life, not an end in themselves.

Prof. Lewis stressed the findings of a recent survey of women university graduates in the United States. These women, when asked what they felt had been lacking in their college course, answered that they need better preparation to meet the problems of marriage and family life.

Other special speakers at the convention included Dr. John B. Hardie of Pine Hill Divinity Hall who presented a lively treatment of the topic "The Woman's Place in the Home." His conclusion was that there should be no battle between the sexes. Men and women will never be equal, inasmuch as they are created different and each has a part to play in fulfilling the role of the other. Sister St. Andrew of Mount St. Bernard College, Antigonish, N.S., presided at this particular luncheon session.

Dr. Helen Abell, Rural Sociologist with the Farm Population by Home Economists can be used, Canada Department of Agriculture, was introduced by Miss Doris Runciman, Head of the Mount Allison Home Economics Department, to a public meeting in the Amherst Regional High School on Friday evening. Dr. Abell showed how the findings of rural sociologists and economists can be used.

That Body Of Yours By James W. Barton, M.D. TREATMENT OF A PATIENT AFTER AN ATTACK OF CORONARY THROMBOSIS After a student has graduated in medicine, he becomes an intern in a recognized hospital and spends several months in each department of the hospital—general medicine, surgery, psychiatry, arthritis, X-ray, skin diseases, and others.

Despite all that he learns in these various departments, in order to become an all-around physician he must learn to treat the patient while he is treating the disease. In other words, he must gradually become a psychiatrist which means treating the "behavior" of patients and learning how their minds and emotions affect their behavior.

Because emotional disturbances affect the workings of all the body processes, it is only natural that they affect the heart action, and so some valuable advice is given by Dr. Douglas Bird, Professor of Psychiatry, Western Reserve School of Medicine, Cleveland, to interns about the emotional factors involved in putting the proper estimate or evaluation on coronary artery disease (coronary thrombosis).

"So many times you rush into the hospital and ask 'What has come in?' You are told, 'A coronary.' You sit down and write out the order: complete blood count, urinalysis, salt-free diet and so on and so on.

"While this is the correct treatment for coronary thrombosis, it may not be the correct treatment for this particular patient. "In addition to writing out the medical treatment, this patient in fact, every patient, may need some particular friendly advice about how to take care of himself in the days to come. Talk to him and see if you can get him to stay in the hospital. Because one thing you can be absolutely sure of: if you don't do this, he is going to leave the hospital. You might just as well face the inevitable in such a case for you can't change the patient. Many of you know that it is not easy for some persons to sit in bed and relax just because they are ordered to do so. They stew and fret and probably do much damage to their internal organs if they are thus frustrated."

Therefore, when treating a patient who has just had a coronary attack, the thought is to find out what is on his mind, give him the assurance he needs from other cases which have entered the hospital, remained the necessary length of time for healing, and gone back to their regular work in office and factory.

C. A. C. definitely disapproves of coupons and premiums as a form of advertising! This unfair practice seems to be on the increase. What can we do about it? Coupons are thrown in the mail or delivered with the mail and even the air is full of them. It is hard to find a spot on the radio that is not blasting out some game of chance as a means of tempting you to buy some special thing.

"What's on somebody's mind?" and the like of that, with a box top from some product or other—they speak of it as "a simple question" and it surely is all of that to the thousands of simple minded people who buy the product so advertised, try to guess the answer to the stupid question and then take one chance in a million that their letter will even be drawn from the mail bag.

When we go to wake up and think seriously about what this method of selling goods is doing to our almost forgotten "honest to goodness" type of advertising.

"Take one free package of new detergent which is flooding the country just now. It is being given away with a coupon. The general attitude is "take what the gods provide and ask no questions"; well that may be alright for those of us who are lucky enough to have these coupons thrown in our door, but what about the hundreds of families living in rooms who need that gift more than most of us, who don't get a coupon (one left for the house)? What check, if any, is there that these coupons are fairly distributed? One person living outside the city complained that they have a box in the post office but they never find coupons in their mail. What's to stop a few getting a winter's supply of soap flakes free?"

The following resolution was passed at the annual meeting in Toronto last month which speaks for itself:

"Resolved that the Canadian Association of Consumers declares its belief that the apparent increasing use of coupons constitutes an unsound practice, leading in some instances to misuse in their redemption, and that the Association hereby records its disapproval of coupons and premiums as a form of advertising."

DOROTHY DIX'S COLUMN-

MARRIAGE, A PARTNERSHIP Man Asks If "Obey" Should Be In Bride's Vow At Ceremony

DEAR MISS DIX I would appreciate your views on whether the wife's promise to "obey" should be included in her marriage vows, together with the related question of whether the husband should be the boss of the wife in the marriage relationship. EUGENE E.

NO BOSS IN HOME

ANSWER: Are you marrying a wife or hiring a housekeeper? Marriage is a partnership—there's no place in it for a boss, be it man or wife. Whether or not the promise to obey should be included in the marriage ceremony is up to the rite of the church in which the wedding is held. Most religious services, I believe, omit the word, substituting for it, "cherish," or "to have and to hold," which are certainly more appropriate to a good marriage relationship than the arbitrary "obey."

If you are planning marriage with thoughts of being a boss, I think you should shelve the whole idea. Establishing a home and family is not a job for one person and an underling. It's something to be undertaken by two responsible, intelligent, conscientious individuals, each of whom is fully aware of his or her respective part. As children come, they must be taught that there's authority in the home—not dictatorship vested in one parent. There should be a head of the household, as the final court of appeals, or as judge to make a difficult decision, but the leadership is not to be exploited by a bossy husband, or a dictatorial wife.

I wouldn't want to marry a girl who had high-handed ideas of running a home, but neither would I like you to start housekeeping with the notion that you could run everything exactly your way. Aim for the middle course with the right girl, Eugene, and you won't even want to be "boss."

DEAR MISS DIX: My husband and I have been married twelve years, and have three children. For some time my husband has been having an affair with another woman, and she is now pregnant. He still professes his love for me, and I love him, too. What are his obligations to the girl?

ANSWER: The family Service Association has a representative in your city, and I suggest that you seek advice from its representative concerning your husband's legal and moral obligations to the woman. There is no doubt but that he has responsibilities toward her and his child, but they don't necessitate breaking up your home. Your own children must be considered, too. I'm sure the professional consultation I suggest will be helpful to you all.
