The Tree Question.

It is pleasing to note that public opinion has been aroused on the question of tree mutilation. As to the case in point, there are, as usual, two versions of the facts. It is stated to-day that the tree on Prince Street was split by reason of the weight of its foliage and that the cutting and pruning were, therefore, rendered necessary. We presume that the matter will be investigated. But, admitting this statement, the cutting of a tree on the street should not have taken place, except on the authority of the proper civic official. It should be understood that no private person can of his own sweet will mutilate or destroy a public tree. Private citizens may be permitted to plant and prune trees. But it would be well if one of our civic officials were directed to judiciously use the pruning knife in respect to trees, and if the interference of private citizens were prohibited. The trees growing in the city are a trust to the corporation. They should not be utterly neglected, as they have been in the past. Surely, there is in the employ of the city some man of sufficient intelligence to perform the duty of keeping them properly pruned and in the condition most favorable for growth and preservation.

Notes and Comments.

The statement of the Farmer that THE EXAMINER suppressed that part of Mr. Davey's report which condemned the protection policy is of course untrue. The Toronto Mail suggests that the political parties are in a convention of their supporters for the purpose of considering the policy of the future. The Montreal Gazette remarks that the hint ought not to be lost on Mr. Laurier whose policy is scrupulously held under pretty phrases and pleasing rhetoric whenever he rises to speak. As for the Government, its policy is mirrored in its legislation. It would, however, be profitable for the leaders of the Conservative party to organize a series of political picnics in various centres of the country during the autumn with the view of discussing public questions face to face with the electors. It is now a good many years since this effective method of education was employed, and the time is opportune for reviving the practice.

The preamble of the bill "authorizing retaliation for certain unjust demonstrations by the Dominion of Canada against the United States," introduced by Senator Higgins a few days ago, recites in substance that Canada denies to American fishermen the right to purchase bait and supplies in Canadian ports, and limits their right to shelter except upon unwarranted tribute, while the United States grant these privileges freely; that the Canadian Government imposes a discrimination toll of eighteen cents per ton on American products passing through the Welland canal and discriminating port dues upon American shipping upon the lakes; that it nullifies the operation of the anti-trust law in the case of competitive traffic between the United States and Canadian railroads by relieving Canadian railroads from all legal restraint; that it grants subsidies amounting to \$12,000,000 annually to the Canadian Pacific railway and its connecting steamship lines, thus discriminating against American railroads and steamship lines, and that it imposes discriminations on tea and coffee entering Canada from the United States.

The Saturday Review of London thus voices the almost unanimous feeling of the Liberal Unionists, who are smarting under defeat at the polls: "The extreme narrowness of the recent majorities on the Liberal side dictates a policy of opposition without mercy to every Liberal minister seeking re-election, and to every government measure which can possibly be opposed with a chance of success. There is nothing due to the present opposition, which has been utterly unscrupulous, if anything were due it would be cancelled by the principle of duty to the country. Never before has a party attained office pledged to a measure which is fraught with certain danger and possible ruin. Mr. Gladstone's party is a thing of straw and patches. Its contingents are two Irish parties which have been trying to exterminate each other at the polls, and which would gladly exterminate each other on the pavenments; and a labor party which only agrees with itself in avowedly fighting with its own hand in its coat pocket, and which is at daggers drawn with every other party and with Mr. Gladstone himself."

Against a party so constituted, every attack not dishonorable is lawful. If the Gladstone government ever get off it will start with a fighting spirit in the captain's cabin, double dealing and office seeking on the quarter deck, and greed and ignorance in the forecastle. Every mother's son among the unionists deserves flogging if he does not do his utmost to sink, burn and destroy such a craft as this. At the Congress of Chambers of Commerce of the Empire, recently held in London, Sir Charles Tupper's proposal in favor of a preferential tariff of 5 per cent, received the almost unanimous support of the Canadian Chambers of Commerce, while, with the exception of the West Indies, it was not so favorably received elsewhere. According to each chamber of commerce represented at the conference one vote, the division on Sir Charles's motion was as follows:

The London Gazette remarks that, "The representative character of the vote may well be doubted in the light of such a fact as that whereas the New South Wales delegates present voted against the proposal, the Premier of New South Wales, just fresh from the constituencies, is giving it his most cordial support. The truth probably is that the subject is a comparatively new one to the colonial public outside Canada. In Australia and South Africa the minds of statesmen and politicians are more concerned with the difficult problems connected with their own fiscal and political federation among themselves."

Fire in the Country.

HOUSES BURNED AND CROPS DESTROYED.

On Monday afternoon, at Bay Fortune Bridge, the fire, besides destroying crops, burned the following houses: Edmund Aikins' dwelling house and barn, (unoccupied); in the latter was a valuable mowing machine, belonging to Mr. William Conaghan, which was also burned; house and barn occupied by James Fuller and owned by Robert Simonsen; Dan McKie's house and barn; Joseph Burke's house—his barn was saved with difficulty. All the way from Head Rollo Bay to Red House the fire did more or less damage, and the burnt sections present a dismal appearance. Miles of fencing are destroyed and crops scorched to the ground. Several cattle lost their lives in the conflagration. Near a spring at Murphy's, Red House, 21 sheep huddled together were burned to death. At Grand River Widow Sarah McDonald's dwelling house was burned. Sault Ste. Marie Station shared the same fate. It is feared that further damage will occur if the wind rises. Farmers are on the watch day and night. Much sympathy is felt for those who have lost not only houses but most of their crops as well.

Where is Councillor Hogan?

SIR.—Notwithstanding the complaint made by a certain faction against Mr. Hogan Morris' party when in power in the City Council, there is no gainsaying the fact that he would never have allowed the old building now being removed to Dunlop Esplanade to remain at Ings' corner—a disgrace to the city and an annoyance and obstacle to everybody. There is the matter but that Councillor Morris would have had it out of that long ago. What is Councillor Hogan doing that he is not looking after the interests of the ward? Is he taking the advice of some adviser.

The Man and the Axe.

SIR.—This morning's Guardian explains that the largest branch of the tree on Prince Street referred to in my letter of yesterday, was blown down by the wind in the last of June, but admits that some of the smaller branches were cut down. That paper assures us that the matter is being engaged in. If those concerned in the enquiry take the right course, they will find that in the month of June a resident of the locality where the tree is situated was seen by the neighbors, and particularly by two civil service officials, up in the tree with an axe cutting down and lopping off the branches. When questioned by the civil service officials, the resident stated that the tree was shading the house, which was the reason he was cutting it. Whether the large branch referred to by the Guardian fell owing to the wind, or because of the heavy cuts made in it by the axe, is one of the questions that the Magistrate must decide on the evidence. My own impression is that the man and the axe were the cause of the damage, and an examination of the tree will produce the same impression on any person.

CITIZEN.

The Prince Street Tree.

SIR.—Your correspondent, "Citizen," in yesterday's issue, is in error in stating that the tree on Prince Street, recently mutilated, was planted by the late Mr. Moore. This tree, which is a Norway maple, was one of a large number planted on all the principal streets of Charlottetown, in the year 1860, by the late Hon. Thomas Heath Hayland, then Mayor of the city, and Thomas Alley, Esq., then a City Councillor. These trees were imported from Boston through Parker Merrill, Esq., an American gentleman then doing business here, and the funds for defraying the cost of purchasing and planting them were raised by private subscription. They consisted of 200 limes or lindens, 50 sycamores, 100 oaks, 50 green-barked maples, 50 Norway maples, 50 Scotch elms—in all five hundred trees—planted together with Island birches and maples. They were placed at spaces of twenty feet apart on both sides of Kent, Grafton, Queen, Prince and Hillborough Streets, and were carefully planted and boxed under the superintendence of Mr. Alley, Lieut.-Governor Dundas took a special interest in the planting of these trees.

Though a by-law was passed imposing a fine and imprisonment for injuring them, not more than twenty of these trees survive to-day. This shows how low the degree of interest taken in protecting ornamental trees in our city.

ANOTHER CITIZEN.

Let the Police do Their Duty.

SIR.—I am very glad to see that you have at last drawn attention to the extraordinary "trimming" that some weeks ago was performed on the trees near Quirk's Bakery, on Prince Street. I have been travelling that street for many years, have stood under the trees in question many times, and I felt very much annoyed when passing it one morning to observe that many of its best branches had been cut off and taken away. I am surprised that no action has been taken against the spoiler and concluded that the damage was done with the consent of the City Surveyor. This conclusion was strengthened when I heard that this officer had recommended the issue of a license for the removal of the Charlottetown Hospital building along a route studded with ornamental trees, the most of which would, of necessity, be damaged in the course of removal. It is satisfactory to know that the Mayor and Council, when they found out the result of continuing the building along Water Street, revoked the license, which should never have been issued.

But the duty of the police regarding the injury to the tree above referred to is quite clear. Let Sergeant Bradley take this matter in hand and make enquiries amongst the neighbors, and I have no doubt but that he will be able to ascertain when and by whom the injury was done. That having been ascertained, he can easily lay his information and punish the guilty parties. It is really too bad, that a tree planted years ago (in this case a tree of a variety of which there is but one more like it on the Island) should be thinned off its branches because it shaded a house.

READER.

Another Information Wanted.

SIR.—In your police court news of yesterday I read that "the police this morning laid another information against a party for an infraction of the Charlottetown Liquor Regulation No. 6." I am very glad that the police are so energetic in laying information, for it is not always that they are so prompt. There is another information which the citizens, at least those around Water Street, would like them to lay before the Magistrate, and that is one against the person or persons responsible for the "stand still" of the old hospital on Water Street. The sign on the times are that the old rookery has come to stay, and Mr. Rob Angus, the manager of the Telephone Co. must be the same opinion, for I notice that he has utilized it for his wires, and permanently attached them to it. Strangers passing cannot fail to notice that the wires are so attached, way nicely by passing along the sidewalk and tearing up the wooden platform. However, it is now going on ten days since the last blow was struck at the building and patience has ceased to be a virtue with the residents of the vicinity who are about tired of it and would like to have it carried a little further on, say to the head of Pownall wharf where the passenger from the Boston Boat could get a glimpse at it.
