He spoke firmly in reply to a question put to that effect by Thomas Johnston, Labor.

"There appears to be some misunderstanding," he said.

He also disclosed of the Marquess of Londonderry's assertion made last week that the Premier had not been misled concerning the rearmament as Mr. Baldwin had stated in the House of Commons in 1935.

Lord Londonderry said at that time he had furnished Mr. Baldwin with facts and figures which Mr. Baldwin did not relay to the Commons.

"In saying we were misled," the Prime Minister said, "I certainly intended no reflection on any department or individual. If such reflection gained credence, I am glad to correct it."

"It isn't a case of there having been any difference between the administration and myself as to German rearmament in the air. It was a case of our earlier estimates of the rate of that rearmament having been falsified by subsequent acceleration."

Lord Londonderry declared he was "quite satisfied" with the Prime Minister's explanation.

More than 50 Conservative members of the House signed a motion earlier requesting that no military or other commitments, which might be construed as leading to future armaments, be made in speeches outside Parliament by ministers or members.

The motion was taken following opposition criticism in the wake of a speech made by Secretary for War Alfred Duff Cooper in Paris in which he told the French "your trucker is our frontier."

Bannister Trial Draws To Close

DORCHESTER, N. B., July 2.—Ariston, from the brutal and sensational family murders at Pacific Junction early this year, the new trial of Daniel Bannister on a charge of murdering Philip Lake appeared to be drawing to its close tonight, with a probability of the case going to the jury tomorrow afternoon or Saturday at the latest.

This afternoon nine witnesses continued in their evidence of testimony placed on court records at least three times previously. To date at the present trial the Crown has called 31 witnesses, and very few remain to be heard.

NEW TYPEWRITER ELIMINATES DUST

NEW YORK, July 2.—Noise is reduced and dust and dirt are practically eliminated in a new typewriter with a closed keyboard. The square or rectangular keys are automatically held in vertical and horizontal positions, forming virtually four solid banks. This tends to keep type work in exact alignment.

The operation of the machine is unchanged as to touch and position of keys and all standard dimensions are retained. All mechanical adjustments are within easy reach of the operator. The design permits the entire frame, covers and other parts to be made of molded plastic, reducing the weight eight pounds, from that of conventional typewriters.

FIVE ARRAIGNED YESTERDAY IN SUPREME COURT

William E. Phillips, Charlottetown and Russell Abbott, Charlottetown, were arraigned on manslaughter charges and Alfred Cillinton, Cyrene Kelly, and Fred Phillips all of Charlottetown, were charged with robbery with violence in the Queen's County Supreme Court in Charlottetown yesterday. All five pleaded not guilty.

Major McKinnon's appeal from conviction on a charge of operating a motor vehicle while under the influence of liquor was allowed without costs. The appeal was heard by Mr. Justice A. E. Arsenault.

The appeal case the King vs. Josie P. P. was dismissed. It was an appeal from a conviction by Magistrate Martin for a breach of the Customs Act.

The case adjourned until 11 o'clock Monday morning when the preliminary jury cases will be heard. An argument took place between Hon. T. A. Campbell, attorney general, and Mr. J. J. Johnston, counsel for the accused, when William E. Phillips was arraigned on a charge of manslaughter. Appeal Allowed

In allowing the appeal in the case of the King vs. Major McKinnon, an appeal from a conviction by Stipendiary Magistrate K. M. Martin for operating a motor vehicle while under the influence of liquor Mr. Justice Arsenault pointed out that the evidence that the accused had been operating a motor car while intoxicated was very indefinite. Evidence as to his condition at some time later could not be taken into consideration because the condition when driving the car was that given by Chief of Police Birwistle and he had an opportunity to observe the accused only while he was in the car and at that time he appeared to be driving the car all right. His Lordship pointed out. In allowing the appeal the usual protection to police officers was provided for.

Hon. T. A. Campbell, attorney general, representing the Crown and Mr. J. O. C. Campbell for the appellant.

The following is a short summary of the evidence heard: Ian McKinnon operating a service station and last business in Charlottetown, was the first witness for the Crown. He said that about five o'clock on Sunday afternoon, March 8, he called Chief Birwistle about a collision in which one of the fenders of his car was damaged. He met the Chief at the station and they went to the witness car

around town looking for the car that had been in the collision. Witness did not see the collision but he had a description of the car and the driver. It was Major McKinnon who was looking for the car. When the Chief and the witness were driving east on Grafton just west of the Great George Street intersection they saw McKinnon going west. He was driving the car and seemed to be stooped over the wheel. When they got to the witness saw McKinnon about half an hour later on Kent Street. He stopped the witness and wanted to know what he was looking for. Outside of the way he was talking, the witness did not notice anything wrong with McKinnon. He could smell liquor off his breath.

Cross examined by J. O. C. Campbell the witness testified that the only time he saw McKinnon driving the car was when he was on Grafton Street. He saw him turn off Grafton onto Queen and then to Richmond Street and he made the turns all right. The language, McKinnon was using on Kent Street was not objectionable except before the little girl.

A. Birwistle, chief of police, in his evidence testified that McKinnon was drunk when he met the witness going west on Grafton Street. Chief Birwistle said that he knew McKinnon was drunk from the way he was sitting at the wheel. He was half asleep and his head was drooping. The car was running all right but from general appearances there was no doubt about it he was drunk. "He had that intoxicated expression," the Chief said. McKinnon then turned the car around and they followed McKinnon. He turned south on Queen of Kent and west on Richmond Street. The witness told McKinnon to drive to the Police Station anticipating that the police car would be there. It was not and it was some time before they located it and the witness sent Sgt. McKinnon and another officer to look for McKinnon and the car. They located the car and later the witness saw McKinnon at the Police Station. He was drunk, the witness said, he could tell from his general manner. His breath smelled of liquor and he was dragging in his walk and his speech was thick.

When examined by Mr. Campbell the witness explained that the reason they did not follow McKinnon after meeting him on Grafton street was because he wanted to find the patrol. He knew where McKinnon would be the witness stated. There was a reason for not going to certain places without another officer.

Benjamin McEachern, Charlottetown police officer, told that he had arrested Major McKinnon on the evening of March 8 on the Chief's orders. He would say that McKinnon was under the influence of liquor at the time of his arrest. He testified that he saw McKinnon on the evening of March 8. He was walking and he had a man had been drinking for some time by the smell of his breath.

That completed the case for the Crown. When the case resumed yesterday morning two young ladies who had been driving around Charlottetown with Major McKinnon and the car, more than an hour on Sunday afternoon, March 8, testified that he had not been drinking while they were with him and that they considered that he was perfectly sober. He drove them home between five and five-thirty.

Simon LaRue said he saw Major McKinnon at Alex LeClair's Sunday evening, March 8. He was eating supper. Later the witness and McKinnon's brother, Aretus, accompanied Major to Jimmie's taxi stand and to Ian McKenzie's service station and then over to the Queen of Kent and Queen Streets. Major McKinnon had been drinking some the witness thought. He had a drink or two but was not drunk. T. H. Lordship the witness said that "when Major McKinnon is drinking his face is pretty red."

By Guardian's Special Wire) MONTREAL, July 2.—Proceeding the departure of Canadian pilgrims who, on July 1 and 17, will embark here en route to the unveiling of the Canadian National Memorial on Vimy Ridge three weeks hence, Brig. General Alex. Ross, C. M. G., of Yorkton, Sask., Dominion President of the Canadian Legion, was scheduled to leave Montreal for England tomorrow on board the S. S. Ausonia.

He will be accompanied by several members of his own association and representatives of organizations of the specially disabled veterans. They will make up the official party of the Canadian Legion.

Composing the group were Rev. S. E. Lambert, Dominion President of the Amputations Association; Captain E. A. Baker, M. C. for the Sir Arthur Pearson Club for Blind Veterans; Rev. John Kelman, chairman of the tuberculosis veterans section of the Canadian Legion; Lt. Col. R. de la B. Girouard of Ottawa, and Major J. R. Bowler, General Secretary of the Canadian Legion.

The party will be joined in England by Col. W. W. Foster of Vancouver, 1st Vice President of the Legion; Col. V. S. Woods, chairman of the veterans allowance committee; Dr. R. de Martigny of Montreal, Hon. President of the Quebec Command of the Legion; Justice Fawcett G. Taylor, acting chairman of the Canadian Pension Commission, and J. A. McIsaac, Ottawa. Others expected to join the official party in London are Captain Donald Simpson, Hon. Secretary of the British Empire Service League, Col. E. R. Wayland and Col. A. Hamilton Grant, Canadian representatives of the Empire Council of the B. E. S. L.

Secretary of the British Empire Service League, Col. E. R. Wayland and Col. A. Hamilton Grant, Canadian representatives of the Empire Council of the B. E. S. L.

The official party will take part in a number of functions in France and Belgium prior to the arrival of the 6,000 Canadian war veterans, their wives and children, and the new-returned Canadian war dead who are participating in the unveiling on Vimy Ridge.
