

HEARD FROM AGAIN.

WILLIAM MILLMAN HEARS THAT THERE IS NO HOPE FOR HIM, AND MAKES A DESPERATE EFFORT TO ESCAPE FROM JAIL—HE ASSAULTS MR. HARVIE WITH A BOTTLE AND ESCAPES TO THE YARD, WHERE HE IS RECAPTURED—HE CANNOT EAT NOR SLEEP.

WILLIAM MILLMAN, the young man convicted and sentenced to death for the murder of Mary Tuplin, made a desperate attempt to escape from prison yesterday afternoon, shortly after hearing that the Governor-General had refused to interfere in his behalf.

About six o'clock, Mr. Harvie entered Millman's room for the purpose of giving him some provisions which a sympathetic lady had sent him. In one hand the jailer carried a basket, which contained some cold chicken, cakes and preserves, and in the other a five o'clock teapot full of tea. The jailer had just laid the teapot on the table, and was in the act of placing the basket on the floor preparatory to removing the provisions therefrom, when Millman, who had been standing in front of the fire with his hands behind his back, sprang forward and dealt him a terrible blow on the right side of the head, a few inches above the ear, with a large wine bottle which he held in his hand.

Fortunately for the jailer, he wore a thick fur cap at the time, and the blow did not have the desired effect, only stunning him for a few moments. As soon as Mr. Harvie realized what had happened he grappled with Millman, and in the struggle which ensued the basket containing the provisions was upset and the preserves spilled about the cell floor and upon the clothing of Mr. Harvie. Millman finally broke away from Mr. Harvie, who had not fully recovered from the effects of the blow, and getting outside into the hall, tried to shut the jailer in the room he had just left. But the jailer forced open the door, and Millman passed out through the large iron gateway across the hall (which he also tried to shut against the jailer but failed) out into the yard. By this time some of the debtors confined in the jail came to Mr. Harvie's assistance, and after a brisk chase around the yard they captured Millman and returned him to his cell.

This morning he was removed to the condemned cell—the one in which Young and Gillis were confined—where he was shackled to the wall, and where he will remain until the sentence of the law is carried out.

THE EXAMINER'S reporter accompanied Sheriff Curtis to Millman's cell this forenoon. He found the unfortunate young man seated on a bench in one corner of the cell. By his side were a few ginger cakes and a small tin pint half full of milk. He was in his shirt sleeves, hatless, and looked very penitent. He did not say anything to his visitors on their entering, and it was some little time before he even looked up.

The Sheriff, after entering the cell and surveying the prisoner and his surroundings, remarked:

"Well, Will, how are you to-day?"

Millman did not vouchsafe a reply to this.

"Why don't you answer me to-day as you have always done? How are you to-day?" again remarked the Sheriff.

The prisoner, after considerable hesitation, replied:

"I'm not very well."

"Why, what's the matter with you?"

"Can't you eat well?"

"No."

"Can't you sleep?"

"No."

"You both ate and slept well until lately, did you not?"

"Yes."

"Then what has turned up to effect the change?"

Millman did not reply to this.

"Did you hear anything yesterday which would cause the change?"

No answer.

"Have you heard any flying rumors about yourself or your case?"

"I did not," after some consideration.

"Did you not have some visitors yesterday afternoon?"

"I had; Mr. Hodgson was here."

"And you did not hear anything about your case?"

"No."

"You were not told yesterday evening that there was no hope for you, were you?"

Yes, I was," after considerable hesitation.

"I thought so; that's the cause of the assault," remarked the Sheriff as he retired from the cell.

Previous to his leaving the jail, the Sheriff gave orders to give Millman only the regulation jail allowance of food, and under no circumstances to admit visitors until hearing further from him. He also informed the reporter that during the past six or eight weeks he had been in the habit of calling upon Millman and enquiring as to the state of his health, etc., hence the questions this forenoon.

Since his sentence, Millman has been exceptionally well treated. Instead of being confined in the condemned cell, with the regulation "death watch" over him, he has been permitted to remain in one of the large rooms on the first floor, where he has been allowed every possible comfort. When asked this morning why he assaulted the jailer, who had been so kind to him, he replied that he did not know, the devil must have been in him. We understand that the death watch will be placed upon him at once, and he will probably not soon again be afforded an opportunity to do further mischief.

MYSTERIOUS DISAPPEARANCE.—About the latter part of February last a man giving his name as A. D. Gillis, of Annapolis, Antigonish, and representing himself to be a boat and shoe traveller, took lodgings at a hotel on Germain Street, St. John's. On the 2nd of March he left the hotel, leaving all his clothing behind him, and only taking a razor with him, which leads to the supposition that he has committed suicide. Gillis was 35 years of age, six feet high and clean shaven.

NOTES AND COMMENTS.

Things Said and Done on the Streets and Elsewhere.

THE weather during the past few weeks has been exceedingly mild. The snow, of which there was a bountiful supply, has almost entirely disappeared from our streets, and the sleigh is rapidly giving place to the wheeled vehicle. Around the wharves business is brushing up. The steamers and other sailing craft are being made ready for their season's work, in fact everything betokens an early spring.

The coming season promises to be a lively one for our mechanics and laborers. The waterworks are to be erected, the new city building completed, and improvements are to be made to the Provincial building, in addition to the ordinary employment afforded. This is pleasing. The more work the more money will be put in circulation, and we will have less poverty during the winter season.

Last week I noted the necessity there was for the effecting of certain improvements in the Lyceum. This week I am pleased to state that my suggestions have been considered, and there is a strong probability that they will be carried out shortly. If the other places I referred to were fitted up at the same time, I have no doubt but that they would have much larger audiences during the warm weather.

Speaking of the Lyceum reminds me that it has already been scoured by two theatrical companies who are to appear in this city as possible after the opening of navigation. And just here let me advise our people to exercise better taste in the matter of patronizing these travelling companies. Hitherto it has been too much the custom to give inferior troupes crowded houses, while the better class of performers invariably play to empty benches. Let this state of affairs be changed during the coming season.

By the way, we have a capital amateur dramatic company of our own. I refer to the Lyceum company, which has recently favored us with two very successful performances, and will give a third shortly. Some of the members of the company possess dramatic talent of a high order, and their efforts to please our citizens should be better appreciated.

Our streets are in a very bad condition just now. Some of the gullies are almost impassable, owing to the deep mud and slush. In one or two instances the City Surveyor has laid crossings of ashes with a beneficial result, but that he intends continuing the proceedings I am not in a position to say. I trust he will.

I sincerely hope that the Street Committee have ordered a good stock of planks for sidewalk purposes. The plankways are just now in a very bad state. Large holes abound on our principal streets, and during the past few weeks many of the planks have been badly mutilated by people desirous of keeping their premises dry. Then again on several of our streets the plankways were removed last year and never replaced. Let these plankways be put down as soon as possible. Some people object to wading through mud, while others are comparatively comfortable.

It is pleasing to learn that the police have been instructed to keep a close eye after corner loafers. They have a large field to work in, and the sooner they begin the better for the community at large. During the past few months the corner loafing nuisance has developed considerably. Some of the members of the fraternity, not content with standing at the corners and expectorating tobacco-juice about the sidewalks have taken to insulting passers by. If a few of the latter class were made an example of the nuisance would soon be abated.

THE THIRD PARTY.

Prohibition Etc.,

An Indignation Meeting.

TORONTO, March 21.

A convention was held here to-day for the purpose of organizing a third political party on prohibition lines. The principal planks in the platform are righteousness and truth in public affairs; equal rights for all creeds, classes and nationalities; prompt and absolute prohibition of the liquor traffic; retrenchment and economy in public expenditure; manhood suffrage, with education qualification; extension of the franchise to the women, and an elective senate.

It was decided to form a new party, and Rev. Dr. Sutherland, General Secretary of the Methodist Mission Board, was elected President. An Executive Council was appointed; but the name of the party was deferred till a future meeting. About forty delegates were present from different parts of the country. Between twenty and thirty prominent temperance men, who refused to subscribe to the platform without discussion, were ordered out of the building and held an indignation meeting.

The Ontario branch of the Dominion Alliance concluded its annual meeting here to-day. It was recommended that a national convention be held in a central locality during the coming summer. It was decided to co-operate with the Halton Alliance in testing the validity of the Halton election appeal petition in the courts.

Another Theatre Horror.

AWFUL LOSS OF LIFE

A Terrible Scramble

OPORTO, Portugal, March 21.

While a performance was in progress at the Baquet Theatre last night, an explosion of gas occurred. The theatre took fire and was destroyed. The house was full of spectators and a number of lives were lost. Eighty bodies have been taken from the ruins. Those most burned were in the third tier boxes and galleries, where whole families were suffocated. There was a terrible struggle at the doors when the spectators tried to escape, a large number being suffocated or trampled on. Many on reaching the street were so seriously injured that they vomited blood. Nearly all the victims were spectators. Many in the theatre, finding themselves unable to reach the doors, jumped from the windows. Some corpses were found in stage boxes. The gas was extinguished shortly after the fire broke out, thus adding to the confusion.

ANOTHER TORNADO.

TERRIFIC GALE.

Cattle Killed—Men Wounded

CHATANOOGA, Tenn., March 22.

A terrible wind storm occurred at Calhoun last night. It demolished the Methodist and Baptist Churches and several houses. It roofed every house in town. Numbers of cattle were killed. Four or five persons were wounded. The storm in the vicinity of Calhoun pursued a northerly direction through North Georgia, into and beyond East Tennessee, bound across to Chilhowee mountains. It was next heard from at London Town, on the East Tennessee road, eighty miles northeast of Calhoun to London Town, 100 miles in 30 minutes. The path of the tornado from Calhoun to London was through a section remote from railroads and telegraph lines. The damage cannot be known for some days, but must have been fearful.

NOVA SCOTIA.

Abolition of the Legislative Council.

HALIFAX, March 21.

The House of Assembly to-night passed a resolution by 31 for 4 against to abolish the Legislative Council.

There have been eight appointments made to that body since 1879, and these, it is said, gave a pledge that they would vote for the abolition of the House whenever required. Some of them have since changed their views, and some supporters of the Government say that there should be an appeal to the country if the Council throws out the resolution.

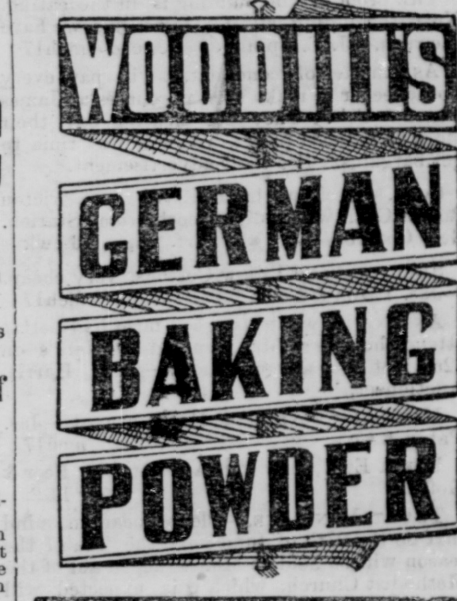
