A CRICKET MATCH will take place in Summerside to-day between the Charlottetown and Summerside clubs—weather permitting.

CHANGE OF NAME.—The settlement formerly known as "Dock Road," Prince Co., will hereafter be known as "Elmsdale," the latter name having been decided on by an unanimous vote of the inhabitants.

We understand that most of the fishing boats along those shores have been hauled up for the winter; yesterday, however, some fishermen more persistent than the rest pushed out from Nail Pond, and were rewarded by catches of from 300 to 500 mackerel per boat.—Alberton Pio.

The Pioneer reports that parties interested in the whereabouts of the schooner Break of Day have been seeking information from all quarters, by pen and otherwise, but so far nothing definite has been received respecting the unfortunate vessel. It was out of her that Captain Morrison was drowned last week.

THE TORONTO BOAT RACE.—On account of unfavorable weather and rough water, Ross did not pull over the course on the 10th. The excitement is growing greater every day, and it is said thirty thousand dollars will change hands on the result. However, less than three thousand has been invested publicly up to the present time. Hanlon is in good form. His friends are confident he will win.

At a meeting of the Marine Board in this city, on the 10th and 11th inst., Capt. R. A. Scott, R. N., Chairman, Hector Murchison, of Point Prim, Michael Sutton, of Kingston, N. B., and Montague Yates, of this city, passed very satisfactory examinations and received Master's certificates of competency. They were prepared at the Commercial College, and were the only candidates before the Board.

A MEETING was held by the inhabitants of Freetown, on Thursday last, respecting the removal of the Railway Station from that place. Messrs. Strong, Calhoun, Rogers and Wall addressed the meeting, and resolutions were passed protesting against the removal of the Station. Petitions were drawn up embodying the wishes of the meeting, and when signed will be presented to the Minister of Public Works and the Dominion Legislature. Time works wonderful changes. Some years ago people were crying loud against the curves of the railway; but now we find them protesting and petitioning against their removal.

AT LAST.—Some of our citizens have naturally been anxious to know what "terrible increase of crime" called for the large, contemplated, addition to our Police force. As will be seen by our report of yesterday's proceedings in the Stipendiary Magistrate's Court, a new field for Police labor, of vast extent, has been opened out. Loafers have actually been fined for holding up the street corners in Charlottetown. Even as we write we can scarcely believe it, but we are willing to hope for the best; and presume that the addition to the force means that the law against "corner loafing" is now to be strictly enforced. Taking this for granted, we would suggest that a sliding scale of fines be adopted. The more respectable the locality and class of loafers, the higher the fine. Having made a start with the "roughs," a course such as this, might, perhaps, tend to alarm and diminish the number of more respectable loafers, who congregate nightly to the great discomfort of passer-by, at Davies', Dodd's, McLeod's, DesBrisay's Walker's, and Hobbs' corners.

REFORM.

We had the great pleasure of being present at the largest meeting ever held in the Market Hall that we can remember of. The room was packed close to the very door, and the interest and great enthusiasm displayed by the audience we never saw equalled at any former place or time. They seemed thoroughly to realize the great importance of the subject, "Temperance Reform." It was a grand success in every way. The speeches were above the ordinary—short, pithy and thoroughly to the point. The choir singing was excellent, and the solos were well received. The Chairman, active and clear-headed, understood his business, and the indefatigable Secretary got through his work in a business-like way. The proceedings opened with a short speech from the President of the "Temperance Reform Club," introducing himself, the Reform Club, and its object to the audience in a practical manner. Next followed the choir, with that soul-stirring hymn, "Hold the Fort." Mr. A. E. McDougall delivered a very neat address to the members and others interested in the working of the Club; then the choir again with a favorite hymn, and the Rev. George Hodgson—foremost in every good work—in an eloquent and eminently practical speech, showed clearly and logically why every citizen should become a total abstainer. Mr. John Ross sang a hymn well suited to the occasion, and Mr. Regan fairly convulsed the house with his Irish comic song. The chairman then called on the Corresponding Secretary—Mr. Sydney FitzGerald—who spoke to the "boys," and exhorted them to keep their colors unstained and always over their hearts, and stated the advantages to be gained by all sections of the temperance societies pulling along together. It would have stirred the heart of the hardest-hearted to have heard the stamping and cheering with which the Hon. Senator Haviland was greeted when he walked up the room and signed the pledge and took the blue ribbon, and afterwards declared in an able speech, that it was the proudest moment in his life to stand on the platform and speak with his blue ribbon on his heart. Mr. Lathern—eloquent as usual—spoke next. Mr. A. McNeill then held the attention of the audience in a speech of humorous strain. Following him, Mr. Hales explained to the audience all about the Club House in contemplation for the members. The Rev. Mr. McDonald—the only clergyman who showed his colors on his heart as yet—then spoke elegantly and feelingly; and the Anthem of God Save the Queen dismissed the audience at five minutes after 10 o'clock. It is the intention of the Club to give entertainments in the Market Hall weekly, and no exertion and labor will be spared to get effective speakers to occupy the platform. With good music and select readings interspersed to enliven the entertainment. Due notice of the next will be given in the papers, with programme attached. Temperance has now got such a firm hold on the inclinations and feelings of the people, that the Reform club is one of the institutions of the country.

To the Editor of the Daily Examiner:

MR. EDITOR.—The Reform inaugurated here by D. Banks McKenzie, is the right sort of thing. It has accomplished much, and it will do more. Heaven further it! Mr. Hales, of this city, is a philanthropist and a philosopher. He needn't be, and he isn't, ashamed of his "hobbie"—the Coffee-house project; the institution of a Coffee-House to replace the dram-shop; the substitution of good for harmful drink and entertainment. The reform that ignores the appetites, the tastes and the instincts has no yeast in it—it will not work.

Sanitary Reform is next in order. Who will inaugurate that? Do the Board of Health know of their appointment? If so, have they any sense of responsibility? Is the pumping out and cleansing of all the wells too heavy an undertaking? If the indifferent and the unwilling, but uninfatigable, drink dirt and sicken, may not blue blood suffer? What about drainage? How many rows of dwellings are over flooded cellars? How many cellars must be pumped out sooner or later, and at tenant's expense, for what do landlords care? Something else. It took perhaps twenty minutes to empty Market Hall the other night. Fancy an alarm of fire and the Hall full. A fit public hall is a pressing need—the floor nearer the ground. Ludlow Hall, Summerside, is another cremation left. Fancy either of them full and on fire—a burning hell! They may trust in God who do their part. The Church edifices, too, suppose some of them—filled, floor and galleries, and a fire. What about facilities for escape? To all concerned. Think on these things.
