Third Party For U. S. Election?

(A. P. By Guardian's Special Wire) NEW YORK, June 16—Rev. Charles E. Coughlin projected into the United States political situation today a possible third-party nominee for President in the November election. The Detroit priest said the country would know by Friday whether that man, carefully unidentified, was to run and whether he would be considered for support by the National Union for Social Justice. As he disclosed this definite threat of a third party, Maine election results showed two candidates backed either by Father Coughlin's National Union or Dr. F. E. Townsend's old age pension group had been nominated while four others with similar support had been defeated. The fact Townsendites and Coughlin followers in Maine supported the same candidates he said was "coincidence."

HEALTH PARLEY CONCLUDES

Problems Discussed By Dominion And Provincial Officials. (C. P. by Guardian's Special Wire) OTTAWA, June 16—Canada's parliament of health, the second annual conference of provincial ministers of health with the Dominion Health Department, concluded here today with passage of resolutions asking a greater degree of Federal assistance in dealing with problems like cancer and tuberculosis. Health Ministers from the Provinces met in camera with Hon. C. C. Power, Minister of National Health, while their deputy ministers held a separate meeting. The conference resolved to ask the department of agriculture to take steps to curb undulant fever, contracted from cows, because the ailment of late constituted a considerable problem. Several deaths in Western Canada resulted by this fever. Hospitalization and care of indigent patients were considered by deputy ministers. They discussed the possibility of reciprocal arrangements between the provinces in the case of expenditure indigents moving from one province to another and entering a hospital. It was believed such an arrangement could be effected with the national health department acting as arbiter in disputes. Another problem the deputies considered was the future of Maritime quarantine in the cases of sick persons on vessels coming into Canadian ports.

LEGISLATION SPEEDED UP IN SENATE

Upper House Keeps Pace With Commons In Drive Towards Prorogation.

(C. P. by Guardian's Special Wire) OTTAWA, June 16—The Senate today travelled full steam ahead, advancing 13 Government measures and one private bill and concurred in amendments of a non-contentious nature by the Commons to the customs tariff and special war revenue act bills passed on the budget. It heard on a private members' enquiry a protest by Senator C. P. Beaubien (Cons. Montreal), against any suggestion Canada should be given the right to amend its own constitution. Senators then transferred their activities into the banking and commerce committee to consider other Government legislation. The National Harbors Board measure was put through final reading as amended by the Senate's railway committee. The bill was immediately sent back to the Commons for concurrence in amendments defining specifically the duties of port managers, placing the board staffs under the civil service commission and providing for opening of tenders at Ottawa in public. Amending legislation to the excise act covering budget changes went through second reading and committee stage with a few clarifying changes. It will come up tomorrow for third reading. The measure to provide for Dominion by-elections was accorded second reading and in committee minor amendments were made including a change in the title. It is ready for final reading tomorrow. Bill to amend the Canada Shipping Act, particularly affecting mariners' certificates, was pushed through second reading and sent to the banking and commerce committee. Another measure to set up a veterans assistance commission with a personnel of three got as far as second reading and is expected to get final reading tomorrow or Wednesday. A supply measure was rushed through the second and third reading stages. Legislation amending the pension act to facilitate handling of pension applications went through second reading and will be on the order paper tomorrow ready for third reading. The bill to establish free ports, a private bill, was given third reading and sent to the Commons. Initial reading was given to six other Government measures. These were bills to add two more judges to the Ontario Supreme Court bench; appointment of George A. Touche and Company, Montreal, as Canadian National Railway auditors in substitution for Clarksons, Dilworth and Company, Toronto; changing the income war tax act in accordance with the budget; changing the dairy industry act to legalize the practice of selling three-pound prints of butter; amendments to the juvenile act and the franchise act.

Arrest of Charles Neily Ends Three-day Search Through The Maritimes.

(C. P. By Guardian's Special Wire) HAMPTON, N. B., June 16—Charles Lambert Neily, 23, of Aylesford, N. H., was arrested late this afternoon on authority of a warrant charging him with attempted robbery while armed at Moncton last Saturday night. Acting on a tip telephoned by a farmhand, police cornered Neily as he crouched in the loft of a barn less than three miles from Hampton. He was soaked to the skin and near the point of exhaustion after plunging through rain-drenched thickets to elude police, who had thrown a net around the Hampton district. He did not resist arrest. "Come down, Neily, acting Lance Corporal E. J. Sturgeon of the Sussex R. C. M. P. detachment called to him, "and come down with your hands up. I've got you covered." The crouching figure in the dim hayloft rose. Neily swung himself down a ladder and stood with hands above his head before Sturgeon and other officers. The tall, powerfully built youth carried an immigration passport stating he is a farmer. He had been living in Moncton for two weeks. The arrest ended a three-day search throughout the Maritimes following the hold-up of Henry McCaule, Moncton service station attendant, at the point of a sawed off rifle. Holstein-Friesian Assn. Annual Meeting

A request to the federal agricultural authorities to amend the cattle breeding regulations in order to permit the use of bulls from accredited herds in "ordinary" herds will be made, it was decided by the Holstein Friesian Association at the annual meeting of the organization held in the Agricultural Hall, Charlottetown, yesterday. Present regulations had outlived their usefulness and were obsolete breeders considered since a third tuberculosis test had made the whole Province an accredited area. The "bull loosing policy" was discussed and the meeting decided that the association would support the plan to the extent of \$200.00. If the money is not used by the last of September it will be used for herd survey work the breeders provided. Steps for the eradication of the warble fly, serious pest of Prince Edward Island cattle, was recommended to the Provincial Department of Agriculture. The meeting went on record as favoring the formation of a Canadian paper in place of the Holstein Friesian World due to the fact that the Canadian edition of the paper does not go to American breeders. Mr. M. H. Haley of Springfield, Oxford County, Ontario, was recommended as the association's choice of a judge of Holstein cattle at the Provincial exhibition. The field day, under the auspices of the organization, will be held at the property of Mr. J. Walter Jones, M.L.A., Bunsbury, subject to his approval, it was decided. Troops Called To

Noisy Criticism (Continued from Page 1) PARIS, June 16—(A. P.)—Noisy criticism of Leon Blum's leftist program for social-economic changes upset the Senate of France today. The dispute, which resulted in temporary suspension of the Premier Blum mentioned President Roosevelt's "experiment" in the United States. Joseph Caillaux, former Finance Minister who has come out for devaluation of the franc, jumped up to dispute with Blum. "Mr. Roosevelt tried an experiment vaster and deeper than ours," said the Premier. "The fact is, he already has begun by raising the purchasing power." Caillaux interjected: "He first took measures of great importance." (Apparently he meant devaluation of the dollar). Blum retorted: "But President Roosevelt worked under less favorable conditions than ours. We want to make a start." The voices of other Senators drowned them out. Appeals for Confidence Later, replying to the Senate criticism, Blum appealed for confidence. He asked the Senate to "consider the expectations and hopes which have been placed on the law we ask you to vote." "Nobody wants devaluation," he added, "including the finance committee," he added. "The return to prosperity which we expect will bring back a healthy budget." Henri Lemeroy, the opposition leader, called the new government plans "a leap into the unknown" as debate was begun on Blum's labor reform measures. "Huge expenditures contemplated by the Premier, Lemeroy charged will lead to the 'ruin' of the franc. A drop in the Bank of France gold reserves to 56,000,000 francs (\$3,696,000,000). Abel Gardey, finance committee spokesman said compelled consideration of 'the minimum level essential to the national defense needs.'" Without taking into account the expenditures of the Blum government the budget deficit, Gardey told the Senators, would be 12,000,000,000 francs (\$792,000,000).
