The grand jury have returned true bills against the prisoners Kingston and Gibney, the dynamite plotters. The Pope's Circular. DUBLIN, May 17. The circular of His Holiness the Pope, denouncing Charles Stewart Parnell, causes much ill feeling in Ireland. At a meeting of the National Land League, held in this city, yesterday, Mr. Kenny, M. P., presided. He denounced the Papal circular as a shameful insult to the priests of Ireland, who were seeking justice from the British Government for their people. State Aid to Canadian Emigration. LONDON, May 17. Mr. Gladstone, in the House of Commons last night, opposed State aid to the scheme for English emigration to the Northwest. Telegraph Notes. A special from Harrodsburg says the fire consumed twenty four buildings, including the Presbyterian Church. The loss will not exceed \$45,000. The Paris Gaulois says a meeting of the Suez Canal Company is to be held June 4. Proposals will be made to construct a canal parallel with the existing one, at a cost of 125,000,000 francs. Fighting occurred, on the 15th, between Cete-way's forces and Chief Asibebu, the latter being aided by Boers. The former have been worsted with a heavy loss. Cete-way is gathering strength in anticipation of a further attack. Thomas Walsh, who whipped his wife to death with a leather strap, at Chicago, and who pleaded guilty, was sentenced, on the 15th, to thirty-five years in the penitentiary. Walsh's crime is described as one of the most brutal ever recited in court. M. Waddington has been treated with great distinction during his stay in Berlin. He also had a cordial interview with Prince Bismarck. The Emperor, while conversing with M. Waddington at Dunne, on the 15th, dwelt strongly upon the importance which he attached to good relations with France. Advice from different points in Missouri report great damage to property, and also loss of life, by the cyclone. At Macon City five persons were killed and ten or fifteen wounded. At Oranogo, the town was entirely destroyed, six persons were killed and thirty-three wounded, many seriously and perhaps fatally. A treaty of peace between Chili and Peru has been signed by Gen. Novoa and Gen. Iglesias, and is said to have been confirmed. Peru cedes Tacna and Arica for ten years. At the end of that term a plebiscite is to be taken to determine to which country those Provinces shall belong. The country acquiring them shall pay an indemnity. At the Manchester summer meeting, on the 15th, the race for the Salford borough handicap plate of 1,000 sovereigns was won by Lancaster's bay colt Middlethorpe; Roseberry's brown horse Roysterer second, and Martin's bay gelding Jovial, third. There were eighteen starters, including Keene's bay colt, Golden Gate. The London Standard has advice from Madagascar stating that war preparations in the interior are greater than those being made on the coast. A majority of Sika Lavas have joined the Sovas in defence of their independence. The French are apparently loath to begin operations, their forces being inadequate to cope with the natives. A brutal murder is reported from Williamsford, Grey County, Ontario. A farmer named George Lambert was shot in the back by his son from above, through a stove pipe hole in the ceiling. The partridge fired a second shot into the prostrate body, threatened his mother, and then dragged the body to the foot of the garden where he commenced to construct a coffin in which to bury it, keeping the neighbors at bay with his rifle. He said he was carrying out his father's instructions in committing the murder. He was subsequently arrested, and the coroner's jury returned a verdict of "wilful murder" against him. The Pope, in his circular to the Irish Bishops, says: "Whatever Parnell's object may be, his followers have often adopted a course openly against the rules of the Pope's letter to Cardinal McCabe, and instructions sent to Bishops which were accepted at their recent meeting in Dublin. While it is lawful for the Irish to seek redress for their grievances, and to strive for their rights, they should at the same time seek God's justice and remember the wickedness of illegal means for furthering even a just cause. The duty of the clergy is to curb and the excited feelings of the people, and to urge justice and moderation. The clergy are not permitted to depart from these rules and join in promiscuous meetings inconsistent with them. Collections to relieve distress are permitted—subscriptions to inflame popular passions are condemned. The clergy must hold aloof when it is plain that by such movements hatred and dissensions are aroused, distinguished persons are insulted, crimes and murders are encouraged; patriotism is measured by the amount subscribed and people are thereby intimidated.
