Land Tax, 1897

Owners of property are reminded that by the recent amendment to the Assessment Act, the system of valuing property for Land Tax has been changed, and it is necessary that new valuations and declarations be made this year. Such declarations to be made by the owner, occupier or agent, before the Provincial Treasurer or Deputy Receiver of the district.

In valuing property the value of the buildings must be included. The rate of tax for 1897 is one fifth of one per cent., or 20c on every \$100 of valuation.

The tax will be due on the 1st December. A discount of 5 per cent. will be allowed if paid on or before the 15th Nov., 1897.

THE NEWS IN SHORT METRE.

Items of Interest Balled Down For More Easy Reading.

The grand new Parliament buildings in Victoria, British Columbia, have been informally opened.

Mr. A. G. Fraser, of London, Ont., has entered suit for \$15,000 damages against the Street Railway Company because he fell or was pushed off a car on Labor Day and fell through a bridge to the ground, 30 feet below.

The minister who married a couple in a lion's cage the other day was a theological student in Boston University. This Methodist institution has no use for divinity students of Mr. Reading's style, and he has been expelled. It turns out that the young preacher is a Canadian, and that he was ordained by the Niagara conference.

The Schwarz aluminum airship, fitted with a benzoin motor, was tested last week on the Temple of Fiweld, in the presence of a number of generals and the chief of the army airship department. The airship rose a thousand feet, floated in the air for twelve minutes, and at first obeyed the man steering it, but later he was unable to steer it against the strong wind which prevailed. The experiment was considered to be partly successful.

The French are experts in the art of inventing fresh taxes. Very few possible sources of revenue escape their fiscal attention. In order to meet the deficit in the French Budget, the Budget Commission has devised a tax on motor carriages, ranging from 60 francs to 100 francs in Paris, and from 10 francs to 75 francs in the provinces. They have also raised about 26,000,000 francs by imposing taxes on foreign bonds.

The Flag-ship Imperieuse has returned to Vancouver from South America, where she went to protect British interests. En route a call was made at Cocea Island, where a hidden treasure amounting to thirty million dollars is supposed to have been buried some years ago by freebooters. Although this was the third search party it was unsuccessful, through rain filling the sandy excavations made. A party of fifty men, under an officer, were left on the island.

The New York World has collected a census of the views of the National Democratic Committee, the organization which manages the presidential conventions and campaigns, and finds that in nineteen states, chiefly in the west and south, representative men of the party regard the result of the elections of Tuesday as an endorsement of Bryan and bi-metalism, and the majority of them look on Bryan's re-election in 1900 as the proper thing to secure the prize of the presidency. Financial heresies are as hard to crush as those which have religion as their basis. The menace of the silver money movement still confronts the United States, and may again call for a union of conservative commercial forces and Republicans to avert it.
