DIRECTIONS.—Artificial Slate: Mix the powder with pure Boiled Lined Oil and a little Spirits of Turpentine, to the consistency of very thick Paint, and applying with a common Brush, being careful to keep the mixture well stirred while putting it on. One pound will cover ten square feet with two coats.

The Metallic Paints are mixed and put on like an ordinary Paint.
