

they will clearly show that they do not want to emancipate their constituents from abject slavery to the proprietary system, and that they are unworthy of retaining their present high position.

Mr. Palmer declares that it would be a breach of faith with the British Government for the local Executive to entertain the loan question pending the award of a most flagrant breach of faith. Two Estates have been purchased since the Commissioners were appointed—the Selkirk property and Lot 54. These properties have been bought with money borrowed on the credit of the Colony. If it be wrong to purchase town-ship lands under the auspices and with the credit of the Imperial Government, is it right to effect such purchases with the very slender means or the doubtful credit of the Colony? If Mr. Palmer's premises are correct, his Government have committed a great error in purchasing an acre of the properties referred to. If those premises are unsound, as we believe they are, then Mr. Secretary Pope has taken a proper view of the whole question in advocating an extension of the provisions of the Purchase Bill. For the present, we shall leave the Colonial Secretary and his leader to settle as best they can, this extraordinary difference of opinion.

The junior servant of the Executive Council has occupied a column in the last Monitor with the most vile personal abuse of the editor of this paper. He has concocted a clumsy tale about our being in Shediac in 1853—visiting the drinking saloons—in that village—getting intoxicated, there, lying down in a field, and coming home sick in the Fairy Queen. Now, if all this were true—and this is just the substance of a column of baldness—how are the Government served by having it put in print? Can Donald Curry make no better use of the Government stationery than in writing silly libels against members of the Opposition? Was the Honkety pit in the Council Office to do work for the people, or to blackguard those who cannot approve of his master's Government? It is very certain that he does not perform any necessary work in the Council Office. Mr. Desbrisay does the whole of that work, as usual. It appears to be Donald's business to lounge about the office—throw his awkward legs over the back of a chair, and invent lies so silly that an idiot might be ashamed of them, and the most abandoned wretch in the lowest sink of iniquity would blush if accused of their perpetration. His Excellency the Lieut. Governor is certainly not happy in the choice of materials for the defence of his Administration when a brazen-faced puppy like Curry has to be subsidized at the public expense, to set aside public questions, and deal in private slander. If we accuse the Government of incapacity in administering the public affairs, we are to be told that we were in Shediac seven years ago—visited the saloons, drank with the men and cracked jokes with the girls. This is an admirable answer to an attack upon the Government. If we remind Mr. Dundas that the motley crew he has around him is driving the vessel of state to destruction, Donald Curry is ready with the clinching answer—"Sir, you forgot that you drank liquor on board the Fairy Queen something less than a dozen years ago."

We have no doubt Curry supposes that this style of defence is very effective. He writes to suit the taste of his masters, and if they are not capable of appreciating any thing better than the garbage which he sets before them, it is not so much his fault as their misfortune. But we had nearly forgotten to notice, in reference to the story about our trip in the Fairy Queen and visit to Shediac, that it is false in every particular, as must be apparent to any intelligent reader who can distinguish between probable and improbable things. We never spent a whole night in Shediac at any time of our life—never entered a "saloon" there, and don't believe there is any thing of the kind in the place. We never made a trip from Shediac to Charlottetown in the Fairy Queen, and never used or saw any liquor on board that vessel. Donald Curry says he believes that his false statement will be verified on reference to the Messrs. Walsh, of Summerside. The parties referred to had a sailing packet running between Shediac and Bedouque when the Fairy Queen was on the same line. James and George Walsh were the owners and commanders of that packet. James is now in Europe, and George has been for several years in his grave. It will, therefore, be seen at a glance that the Government donkey runs a no risk in referring to these parties for a verification of his lies.

Donald thinks he is great in drawing the picture of a drunken man. He ought to be. He has had opportunities enough for studying the art in that snaky slanty at the West River, where, in his younger days, the boy Curry could contemplate the physiology of a broken-down old man, bearing his own name, whose normal condition was bestial drunkenness; and who could not dispense with his supply of "white-eyes" until painfully convinced that the darned stocking in the sooty rafter was emptied of its last barrel.

The Government party are, we understand, extremely busy in settling the Land Question. As an earnest of their good intentions, about three hundred writs against the tenantry have been issued, since the closing of the Commissioners' Court, from the offices of gentlemen holding high positions in the Administration; and several cases have come to our knowledge where the payment of one year's rent, as recommended by the Commissioners, was found to be no guarantee against harsh proceedings on the part of the landlords. Nothing short of the full pound of flesh, in the shape of arrears, will satisfy some of the proprietary Shylocks. These proceedings may put a little money in the pockets of the land agents and the lawyers; but they are sure to settle all the questions relating to the leasehold tenure in a way not desired by the proprietors; and they will settle the Government, too, that lean for support on landlords and land speculators.

A QUESTION FOR THE ORGANS. The Government organs have, for several weeks, discovered that they consider very fine music for the Government regarding their speculation in the purchase of the Selkirk Estate. We have been told that the transaction is sure to be self-sustaining, because the settlers have already paid in, on account of the purchase of their farms, the enormous sum of two thousand pounds! Why, the settlers on the Worrell Estate paid, last autumn, an instalment of fifteen hundred pounds, which was merely one out of many other instalments from the same people,—it gave them no trouble to pay it, and there was no music from the organs about it. But it seemed to be a remarkable event to get a decent instalment from the Belfast people, who, as Mr. Douce said in the House of Assembly, had paid no rent for eighteen years! It was, perhaps, quite excusable to make some noise in the newspapers about such a marvellous occurrence. But the question we want to ask the Organs is—How much money has been paid by the settlers on Lot 54 for their several holdings? That property was bought by the Government at a higher rate than was paid for the Selkirk Estate; and we understand that little or none of it has been sold or paid for since. If the Organs decline to answer our question, their silence will be regarded as an admission, that the purchase of Lot 54 was a miserable failure and a criminal waste of the public money.

We are informed by telegraph that a great fire occurred in Halifax, on Saturday, the 12th instant, by which one of the largest blocks of buildings in the centre of the city, known as Cheapside, was burned down; but though we have Halifax papers received on Saturday evening last, as late as the 14th, they give no intelligence of the fire. We can only account for it on the supposition that the papers dated Monday, the 14th, were printed late on Saturday, or at before the time the fire occurred.

The coroner of New Orleans reports 85 murders in that city during the year, 35 suicides, 109 accidental deaths, 79 deaths from intemperance, and 105 cases of drowning.

NEWS BY THE MAILS.

Colonial and United States Mails were received here on Saturday evening. The only important intelligence furnished relates to the civil discord in the neighbouring Republic. The war fever in the South appears to have become more violent than ever. The slaveholding States are following, one after another, the mad career of the South Carolinians, and the Federal Government is now in the midst of a revolution that threatens a speedy disruption of the Union. One of the most significant facts as to the breadth and intensity of the revolutionary feeling is the retirement from the Cabinet of all the leading minds that surrounded Mr. Buchanan at the commencement of his administration. We give below such portions of the news as we can find room for.

UNITED STATES.

The War spirit is fully up in the South,—and we much fear that ere long some desperate collision will take place between the Government authorities and the Secessionists. In our last issue we stated that the Steamer Star of the West had been fired into by the South Carolinians, while endeavouring to land reinforcements for Major Anderson. We anxiously wait to see what action the General Government will take in that matter.

Governor Letcher, of Virginia, in his message, refers to the trouble that threatens: calls upon all true patriots to exert themselves to save the country from impending evils; and is desirous that there should be a convention of all the States, and address—"It is monstrous to see a government like ours destroyed merely because we cannot agree about a domestic institution. It becomes our State to be mindful of her own interests. Disruption is inevitable; and if confederations are to be formed, we must have the best guarantees before we can attach Virginia to either." He condemns the hasty action of South Carolina, which has taken her Southern sisters by surprise.

The United States Arsenal at Mobile was taken possession of by the Secessionists on the 4th inst. It is said to contain a large quantity of ammunition. Fort Morgan was also taken, and is now garrisoned by 200 men.

Salutes in commemoration of the battle of New Orleans, and in honor of Major Anderson, were fired at Portland, Me. Dover, N. H., Washington, and other cities.

The President is reported to have said recently, in reply to the suggestion of apprehended difficulty in inaugurating Mr. Lincoln, "If I live until the 4th of March, I will ride to the Capitol with Old Abe, whether I am assassinated or not."

Some fears were entertained at Washington, and the Government had collected several companies of artillery there. Massachusetts and New Hampshire are ready, it is stated, to respond to a call of the Government for troops to sustain the Union.

Boston, Jan. 9, 1861. Washington, Jan. 9.—The Cabinet are debating the question, whether Senator Toombs of Georgia and Senator Wigfall of Texas shall be arrested on a charge of High Treason. A Charleston despatch has just been received at the War Department. It is expected that these despatches contain news of the arrival of the steamer "Star of the West" (which left New York on the 5th inst. with 250 troops, destination unknown) at Charleston with reinforcements.

The Speaker laid before the House a message from the President alluding to South Carolina. The President says he has no alternative but to collect the revenue and protect the public property. His duty is to execute the law, and the right to use the military and naval force in their execution is indisputably set forth by the law. He says that the present state of things is beyond the control of the Executive, and we are in the midst of a revolution, and he recommends Congress to act in the present emergency.

The steamer "Star of the West" was spoken on the 7th of Cape Hatteras, bound South. Secretary Thompson of the Interior, resigned yesterday.

Washington, Jan. 3.—President Buchanan was informed last night that Ex-Governor Wise of Virginia, and his nephew Mon, principally located in his old Congressional District of Norfolk and Accomack, intend to capture Fort Mifflin at Old Point Comfort, and the Arsenal at Harper's Ferry, immediately, for the purpose of holding them for the moment, until Virginia shall put hands in the secession movement. The President says there are ten companies of soldiers at Fort Mifflin, who, he doubts not, will properly receive the Ex-Governor.

At Harper's Ferry they were not prepared to receive him should he make the attempt to capture the place.

New York, Jan. 3.—A special dispatch from Richmond says that the Governor of North Carolina has sent troops to seize Fort Mifflin at Beaufort, the forts at Wilmington, and the Arsenal at Fayetteville.

The New York Evening Post of Wednesday, says—"In financial circles there is quite a cheerful feeling, and the news from Washington is received with much satisfaction. Prime paper is in demand at 9 a 12 per cent.

Oregon Dates are to Dec. 11th, and North Carolina to Dec. 8th. Ship John Marshall and bark Newry, are reported wrecked in the Strait of Fuca. Attempts have been made to burn Victoria. Forty thousand dollars worth of gold had arrived at Victoria from Fraser River.

WRECK.—We regret to learn that the Brig J. H. Harmon, owned by parties in Pictou, after being twenty three days at sea, loaded with produce from P. E. Island for England, has been wrecked at Ship Harbour. The continuance of Easterly winds which the packets crossing the Atlantic have experienced for some weeks past, will account for her having been driven back. Particulars have not yet been received, but she is likely to be a total wreck.

MURDER AT TRACADIE.—Michael Potty, Way Office Keeper at Tracadie, was lodged in the county jail this morning, charged with murdering one of his neighbors, a young man named John Delory, by stabbing him in the back with a knife at a late hour last night. We have not yet heard the particulars of this sad tragedy, but understand that Delory gave very little or no provocation for the murderous thrust made on him, from the effect of which he died in a moment. Potty denies that he is the murderer.—Antigonish Casket.

SHOCKING SUICIDE IN KING'S COUNTY.—We learn from a person residing in the neighborhood where the deed was committed, that on Monday last a man named John McGinness deliberately cut his throat with a razor, near his residence in Smithville, Parish of Hampton, K. C. About 9 o'clock, A. M., he left his dwelling and proceeded a short distance in an adjoining field, where he was observed kicking off his coat and vest, after which he made the attempt upon his life. A neighbor in the vicinity immediately ran and seized the unhappy man, took him in the house, and sent for a physician. It was with difficulty that the unfortunate man could be restrained from finishing the deed he had commenced. The physician upon his arrival found that the wind pipe was cut through, but the jugular not severed. The surgeon sewed up the wind pipe, and the suicide lingered until 4 o'clock the same day, when he died. A Coroner's Inquest was held and a verdict in accordance with the above rendered. Financial troubles in which the deceased was involved are said to have led to the commission of the rash act.—St. John, N. B., Globe.

FIRE.—Woodstock, Jan. 8.—The Canadian Literary, Institute and the Baptist College in this place, were burned to-day. Loss \$25,000. Insurance \$2,000.

MASCRE BY PIRATES.—Macao, Oct. 6.—A communication received by the Fre. ch consul at Shanghai from a priest in the district of Halimer, near the mouth of the Yangtze, states that an American barque had been chased by pirates, was supposed to have been captured and all the crew murdered, excepting one man, who was lying at the above place badly wounded; five bodies had been found and buried.

The Queen vs. Sarah Mountain.—Indicted for concealing the birth of her child, and a bastard; and upon being brought up for judgment, the Court considering the case to be shrouded in doubt and many difficulties, suggested to the Attorney General the propriety of entering a "nolle prosequi" upon the indictment, which was accordingly done, and the prisoner discharged.
