Tignish Says Catch Of Cod Is Very Good

A wide disparity in the size of catches of cod have been reported from the various fishing areas of the province, according to department of fisheries officials.

Great success is being met in the Tignish district where some two and three man boats are reporting catches running as high as two to three thousand pounds per day. While no estimate of the value of the catch is available, last season cod fishermen were receiving approximately 5 1/2 cents per pound. Earlier good catches were reported from Tignish with trolls but recently most of the fish have been taken on hand lines. The situation is different in Rustico where small or no catches are being taken. It is the same along the shore to Souris and down the coast to Murray Harbour.

Penal Reform Wave Needed In American Prison System

NEW YORK (AP)—American prisons, beset by frequent bloody riots and moral dry rot, stand in need of another great wave of penal reform such as swept the country more than 150 years ago. That, at least, is the emphatic consensus of many leading penologists and prison officials. In an era of growing enlightenment, experts say, too many United States prisons are out-moded snaretraps of human despair—grim, sour-smelling bastilles where thousands of men are entombed year after year in a grey steel world. Even hard-headed critics who scoff at any pit-the-poor-prisoner approach, "nobody invited them to a picnic"—are slowly beginning to realize that some U.S. prisons amount to virtually a national disgrace. Then, too, recent comments by American visitors to Russia, unfavorably comparing U.S. penal methods with Soviet prisons, have set off fresh demands for a searching re-examination of the American custodial system. "More than 40 years as a prison official have led me to question not only the place but the effectiveness and the validity of the prison system in our society," says Dr. Frederick S. Baldi, former warden of Pennsylvania prisons. Harry Elmer Barnes, noted sociologist and long-time advocate of penal reform, declares: "We shall ultimately come to admit that society has been as unfortunate in handling our criminals to lawyers and judges as it once was in entrusting surgery to barbers. A hundred years ago we allowed lawyers and judges to have the same control of the insane as they still exert over the criminal, but we now recognize that insanity is a complex medical problem which we entrust to properly trained experts in the field of neurology and psychiatry. We may hope that in another 100 years the treatment of the criminal will be submitted to medical and sociological experts." Some authorities contend that about half the country's prisoners could and should be turned out of prison—either shifted to open-air correctional camps and farms or released on parole. The day of the high-walled Big House, they say, should be ended for all but the toughest, most vicious and unregenerate offenders. **REFORMS IMPENDING?** The feeling among most leading officials today is that widespread reforms are impending—though progress will vary from region to region, state to state. Farmers Advised To Kill Vines Now

Unless the potato vines are destroyed by frost, most fields should be sprayed with a chemical vine killer before the end of September advises Weekly Potato Bulletin No. 12. The date on which this treatment should be given will vary from one farm to another depending on date of planting, size of tubers, and variety of potatoes. Varieties having a tendency to over-size, such as Canso and Keswick, should be examined and the tops destroyed when it is estimated that the maximum volume of Number 1's has been produced. In no case should a field be harvested until all of the tops have been dead for at least ten days. When harvesting is delayed until after mid-October the risk of damage to the tubers through low night temperatures is always present. The crop should be dug before this danger arises.

Kensington Asking Estimate For Paving Mile Of Streets

KENSINGTON—The Town of Kensington will call in a contractor to supply estimates of the cost of paving one mile of streets in the town, the chairman of the street committee reported at the regular monthly meeting of the town council Monday evening. The meeting was presided over by Mayor Everett Champion and all councillors were present. Bills for the sewerage system to the amount of \$5,504.43 were voted to be paid as well as the current bills amounting to \$737.16. A report submitted by policeman Vernon Reeves showed fines amounting to \$223.40 collected for the past month.

Kings Recount Is Postponed

Residents of the fifth electoral district of Kings will not know until Friday who will represent them as Councillor in the next provincial general assembly, Liberal George E. Saville of Annandale or PC Leslie Hunter of Bridgetown. Both candidates received 675 votes in the provincial general election held September 1. On Declaration Day, one week later Mr. Saville was declared elected by virtue of a tie-breaking vote cast by Sheriff J.B. Edwin Reid, country returning officer. Mr. Hunter then made application for a recount. Solicitors appearing for the candidates concerned are J.O.C. Campbell, Q.C., Charlottetown, representing Mr. Saville; and Melvin J. McQuaid, Souris, representing Mr. Hunter. Yesterday Kings County Judge J.S. DesRoches acceded to the solicitors' request and adjourned until Friday the recount proceedings which had been scheduled to commence in the Georgetown Courthouse at 10:00 a.m. REASONS Commenting on his decision Judge DesRoches stated that he did not think that it was practicable to proceed with the recount application yesterday for various reasons. These reasons included the short time available for the candidates' solicitors to prepare for the hearing; Mr. MacQuaid's desire to be present at the government change-over which takes place today; and Mr. Campbell's prior commitment to represent another candidate at another recount scheduled to take place in Charlottetown today. Judge DesRoches stated that he was not quite clear on the interpretation of Section 119, subsection (4) of the local Election Act which reads as follows: "The judge shall appoint a time within four days after the receipt of the said application and affidavit to count the votes and to make the final addition thereof." However in order to certain of the interpretation he had set September 15 as the day on which the recount should be held though he realized that the time was short.
