

OUR CHURCHES.

THE METHODIST BRICK CHURCH.

The Rev. Mr. Lathern preached on Sunday night last from the words, "Jesus saith unto him, 'If I will that he tarry till I come, what is that to thee? Follow thou me.'" 21st chapter and 22nd verse of St. John's Gospel. The Lord showed himself alive after his resurrection by many infallible proofs. The first case of his appearance is recorded in the previous chapter, when he showed himself to Mary Magdalen. The second appearance was in the evening of the same day, when some of his disciples were assembled in a chamber with closed doors. He gave them an infallible proof that it was the same Jesus who was crucified, by showing the scars of the cross. Then he exclaimed, "Peace be unto you." What a blessed manifestation of his love to those who had been his followers, but when the day of severe trial came deserted him. The next appearance was when Thomas was with the disciples, and Christ satisfied his incredulity by asking him to thrust his finger into the wounds of his side. The next manifestation is closely connected with the text. The disciples had gone fishing, but had been unsuccessful till the Saviour commended them to cast their net on the right side of the ship. The principal interest connected with this manifestation of Christ to his Disciples, is the conversation held with Peter. The words of the Saviour: "Lovest thou me?" would come home to Peter, because of the denial of Him before the crucifixion. Our English translation does not convey the full force of Peter's answer, when Jesus had asked him the third time, "Lovest thou me?" Simon knew the allusion, and seems to have been grieved when the Lord continued to question him concerning his love. It is a blessed thing when Christ says to us, in our moments of solitude, of quiet, when in the closet, "Lovest thou me?" and we can reply, "Yea Lord, thou knowest that I love thee." The injunction will come to us, as it did to Peter, "Feed my sheep."

My theme to-night is discipleship. "Follow thou me." Discipleship of the same kind as Christ as Christ demanded of the men to whom he said "Let the dead bury their dead. Follow thou me." What is implied in following Christ literally we know. Andrew and Peter, James and John, left their fishing boats and followed Christ. But even at that time discipleship implied more than accompanying Christ from place to place. The fundamental teaching was faith in Him as the Messiah. When Peter on one occasion was asked by our Saviour the question, "Whom think ye that I am?" the reply was, "Thou art Christ the Son of God." For this exhibition of faith in Jesus the Messiah the Lord pronounces a blessing upon him, "Blessed art thou, Peter." Then followed the statement, "Upon this Rock I will build my Church." That is upon the testimony given by "Peter" that Christ was the Son of God did He build His Church. As in the days of the Disciples faith was necessary for true discipleship, so in our day we look upon faith as one of the fundamental doctrines of our noble Christianity. When we remember the incarnation and the transfiguration of Christ; when we read the record of His miracles, the healing of the sick, the raising of the dead, His walking upon the sea, of His sepulchre, and when we learn that He was the King of Glory, the brightness of His Father's Glory, and the express image of His person, then our faith is confirmed. The question may be asked: Why are so many gospels written about His life and death? These gospels are the testimony of those who believed in Him as the God whose throne is for ever and ever, and they give their reasons for their belief in Him. When we exercise faith in Christ we have not to look back to the cross, but to believe that He is enthroned on high. Discipleship must be a practical thing. Not only faith in the God-head of Christ, but the merits of his death as well. This is strikingly set forth in Ephesians. The Apostle, in writing to the Church at Ephesus, employs these words: "That we should be to the praise of his glory who first trusted in Christ." I like that word trust; it implies something upon which we can rely. If there is a chasm between us and a point which we wish to reach, the chasm can, by mechanical skill, be bridged; and if the bridge be properly constructed, we can trust to its strength to bear us. Christ has bridged the chasm which intervenes between us sinful mortals and our Father in heaven. We cannot trust in our works of righteousness. An eminent divine has said, "All my theology is contained in the words, 'Just as I am without one plea,' &c. Discipleship not only implies faith, but the profession of that faith. The Saviour said to Simon, "Lovest thou me?" He knew Simon's heart; but there must be testimony from Simon's lips. The testimony is often the crucial test in the believers Christian life. It frequently costs a good deal of effort to make a confession of Christ. We should have Christ inscribed upon the heart prompting us to outward confession. "Probe a little deeper," said an old veteran of Napoleon's army to a surgeon who was probing a wound made by a ball in the vicinity of the heart. "Probe a little deeper and you will find the Emperor's image inscribed there." Christ should be inscribed upon our hearts. Love of country, love of friends, valuable as they may be, are of minor importance when compared with attachment to Christ. We should be His witnesses. If we confess Him He will confess us before His Father and the Holy Angels. Another thing involved in discipleship is conformity to His life; walking in His footsteps. We must be baptized in the same mind. It was said of some of the followers of Christ in His day that men took knowledge of them that they had been with Jesus. A great missionary once said, when a companion read to him from a magazine in which his labors had been compared to the work of some of the apostles, "I want to be like Christ, and not a follower of His apostles." The inconsistencies of church members are often pointed out. Men go through life with

some good works and loud professions emblazoned upon their religious life, but there are weaknesses also manifest. Christ says to us when we are inclined to point out these weaknesses, "What is that to thee? Follow thou me." Discipleship also involves self-denial; "If any man will be my disciple let him take up his cross and follow me." There will be compensation for self-denial and faithful service. They that endure the cross shall wear the crown.

More Molly Maguires.

PITTSBURGH, Feb. 28.—Sheriff Duffy, of Westmoreland County, has succeeded in unearthing a gang of Molly Maguires, who have been operating for three years past near Irwin's Station, on the Pennsylvania Central. Up to the time these men began work the relations between the miners and employers were of the most amicable character, but shortly after their appearance the men became dissatisfied, and this feeling increased until it culminated in an open outbreak. The miners struck, and during the strike many cases of violence occurred. The town of Irwin's has been fired several times, and once more than half of it was laid in ruins. These fires were attributed to carelessness at the time. The Sheriff obtained a clue last week, and succeeded in interviewing one of the suspected men, who made a full confession. This man, Parfitt, says the gang numbered about twelve or fifteen men; they were well regularly organized and held periodical meetings in a hotel near Irwin's. They organized and conducted the strikes, and during one of them a crowd of Mollies attacked a miner named Fowler who was at work in the mines, but were driven off after an exchange of shots. On the same night they burned the tippie check-houses and wagons of the Bald Eagle mines. They have caused all the fires, and during the July riots in this city they burned hay stacks, cut the telegraph wires, and killed a young man named Carroll, whose body they placed on the railroad track, where it was discovered at daylight mangled and torn. Parfitt also brought to the Sheriff another of the gang who corroborated Parfitt's story. The rest of the Mollies hearing of the disclosure fled precipitately, and detectives at once started in pursuit, and were close on them at last accounts. Great excitement prevails in the village and surrounding country.


