 WHEREAS it has been intimated to me, through the British Minister at Washington, by communication addressed to His Excellency from the State and Treasury Department of the United States—that when assurance is given that American Vessels are admitted into all the Ports of Prince Edward Island, on the same footing as British Vessels, the Treasury Department of the United States will cheerfully and promptly issue the needful instruction to grant similar privileges to Vessels from that Colony in all the Ports of the United States, agreeably to the authority granted by Congress in the law of September 26, 1850:

I have, therefore, with the advice and consent of the Executive Council, thought fit to declare, and I do hereby declare, that American Vessels now are, and shall continue to be, admitted in all the Ports of Prince Edward Island, on the same footing as British Vessels. When the Act of Congress, of the date of September 26, 1850, together with the United States Treasury Circular, of the 15th June, 1851, are received, they will be published for the information of all concerned.
