

Canadian National Workers To Have Two Pension Plans

TORONTO (CP) — Canadian National Railways will implement the Canada Pension Plan for most of its employees with one reducing their company pensions. It was learned Wednesday.

The CNR released its decision last Friday in a letter to non-union employees but made no public announcement.

The move was learned when a copy of the letter to 11,000 non-union employees fell into the hands of an officer of the Brotherhood of Locomotive Engineers (Ind.) who reported it to the brotherhood's convention here.

Union officials believed the decision would influence how the Canadian Pacific Railway deals with the pension plan.

SEES NEW PATTERN

"I believe it will establish a pattern in the railway industry," Jack Walter, assistant grand chief of the brotherhood, said in an interview. "I think it will definitely establish a pattern for other Canadian industries."

Benefits under the Canada plan will accrue gradually starting Jan. 1 and will affect about 70,000 hourly-rated union members in the CNR as well as salaried non-union employees. The return will reach a maximum \$104.17 a month after 10 years of contributions.

For a 700-a-month CNR employee retiring in 1976 with more than 30 years' service, it would mean a pension of about \$350 a month plus \$104. The Canada plan also includes disability, widow's, dependents' and death benefits.

CNR President Donald Gordon spoke in favor of a blended plan when he appeared recently before a parliamentary committee.

Denis Hearing Due On Nov. 4

OTTAWA (CP) — Raymond Denis' preliminary hearing on charges of attempted bribery and obstructing justice, in the Lucien Rivard affair was fixed Thursday for Nov. 4.

Magistrate Glenn Strike continued Denis' \$1,000 bail and also the \$5,000 bail of Mrs. Marie Rivard whom he instructed to appear Nov. 4 as a witness in the case.

Rivard is before the courts in Texas on charges of being the kingpin in a huge narcotics smuggling conspiracy.

Defence counsel Louis Assaly informed the court he still is wading through the volumes of evidence taken in the Rivard affair during the inquiry of Chief Justice Frederic Dorian of the Quebec Superior Court.

Department Store Sales Increase

OTTAWA (CP) — Department store sales in the last week of July this year were 5.5 per cent above the volume of sales in the same week last year, the bureau of statistics reported Thursday.

Sales in Ontario were up 16.3 per cent. They were 9.1 per cent higher in Saskatchewan, 9.8 per cent higher in Alberta and 6.9 per cent higher in British Columbia.

These more than offset declines of 4.8 per cent in the Atlantic provinces, 4.3 per cent in Quebec, and 0.2 per cent in Manitoba.

Immigration Increases

OTTAWA (CP) — Immigration to Canada totalled 62,898 persons in the first six months of this year compared to 51,323 in the same period last year, the immigration department reported Thursday.

Following the pattern of recent years, Britain and Italy combined to account for almost half of the new arrivals. There were 16,739 from Britain and 12,467 from Italy.

Ontario took most of the newcomers, 35,190, with Quebec getting 12,492.

Figures for the other provinces: Newfoundland 197, Prince Edward Island 92, Nova Scotia 620, New Brunswick 381, Manitoba 1,698, Saskatchewan 1,064, Alberta 3,481 and British Columbia 7,578. The Yukon and Northwest Territories accounted for 65.

In addition to Britain and France, nine other countries provided more than 1,000 immigrants during the period. They were the United States 5,629, Germany 4,454, Portugal 2,557, France 2,191, Hong Kong 2,085, Greece 1,822, The Netherlands 1,521, West Indies 1,036 and Switzerland 1,028.

Australia and New Zealand combined provided 1,238 new Canadians. Forty came from Russia.

Retention Of Hanging Requested

EDMONTON (CP) — The Canadian Police Association ended its annual convention here with a resolution asking the minister of justice to retain capital punishment in Canada.

The 3,500-member association of municipal policemen from five provinces said it favored death as a penalty for capital murder, as defined in the criminal code.

Discussions of resolutions were closed to the press, as were other business sessions.

But Staff Sgt. S. L. Stevens, president of the Edmonton Police Association, said later that police had rejected the alternative of life imprisonment as a sentence for capital murder "because we had ample opportunity to see that life imprisonment in this country doesn't mean what it says."

He said the association was concerned most with protecting the public from convicted murderers returning to society. It did not support capital punishment as a deterrent for those who might be thinking of committing capital crimes.

The meeting also passed a resolution asking the minister of justice and provincial attorneys-general to have "crimes of violence" dealt with more severely by the courts.

Sgt. Les Skeys of Calgary was re-elected president of the association.

Secretary-treasurer is Det. Fitzgerald Fry of Halifax. Constable Joseph Ross of Halifax was among provincial vice-presidents named.

Customs, Excise Officers Vote For Right To Strike

OTTAWA (CP) — If Canadian customs and excise workers have their way, the 80,000-member Civil Service Federation will seek the right to strike in new federal bargaining legislation promised this fall.

The 6,600-member Customs and Excise Officers Association Thursday announced the results of a referendum on the strike issue.

In a complete turnaround of the association's no-strike policy, 3,194 members favored inclusion of the right to strike as the "enforcement instrument" in new bargaining legislation. Supporting the present no-strike policy were 1,917.

The vote means the association's delegation at the triennial Civil Service Federation convention opening Monday in Windsor will press to have the convention seek a strike clause in the collective bargaining legislation.

Prime Minister Pearson has said the government cannot tolerate work stoppages in the public service. The recent postal strike is believed to have hardened his view on the subject.

finally left out any mention of strikes because:

"We concluded also that, if a strike should ever occur, the government would not be without the means to cope with it."

NO RIGHT TO STRIKE

The committee's report noted that civil servants do not have a "right to strike" and would be subject to disciplinary action if they were to participate in a strike.

Two weeks later some 12,000 postal workers—all civil servants—went on strike.

The customs and excise decision is a likely indication that others among the 200 delegates gathering in Windsor next week also have been reviewing their no-strike position.

The federation, largest employee organization in the federal government with 15 national departmental affiliates, has maintained its no-strike position for many years. But a convention vote can quickly change that.

Adding further spice to the convention is the report of Judge J. C. Anderson, appointed by the government during the postal strike to review the wages of all employees in the Group D pay cycle. His report is expected to be approved by cabinet Friday.

Judge Anderson's pay recommendations affecting some 22,000 postal workers were approved by the government two weeks ago and annual increases of \$510 to \$550 implemented. His final report concerns the remaining 35,000 employees in Group D—customs, excise, immigration, technical and maintenance employees.

PREVIEWED FEELINGS

The same strike, said Doug Paterson, association executive vice-president, obviously made a lot of our members review their feelings on the strike question."

In October, 1964, the association's national convention voted overwhelmingly in favor of arbitration as the means to back up bargaining.

The vote means the association will add its weight to that of the Federation of Association of Letter Carriers and Canadian Railway, mail Clerks Federation, other civil service federation affiliates who want strike clauses in any new bargaining process.

The preparatory committee on collective bargaining, a body appointed by the government to recommend new legislation, recently submitted its report to the government.

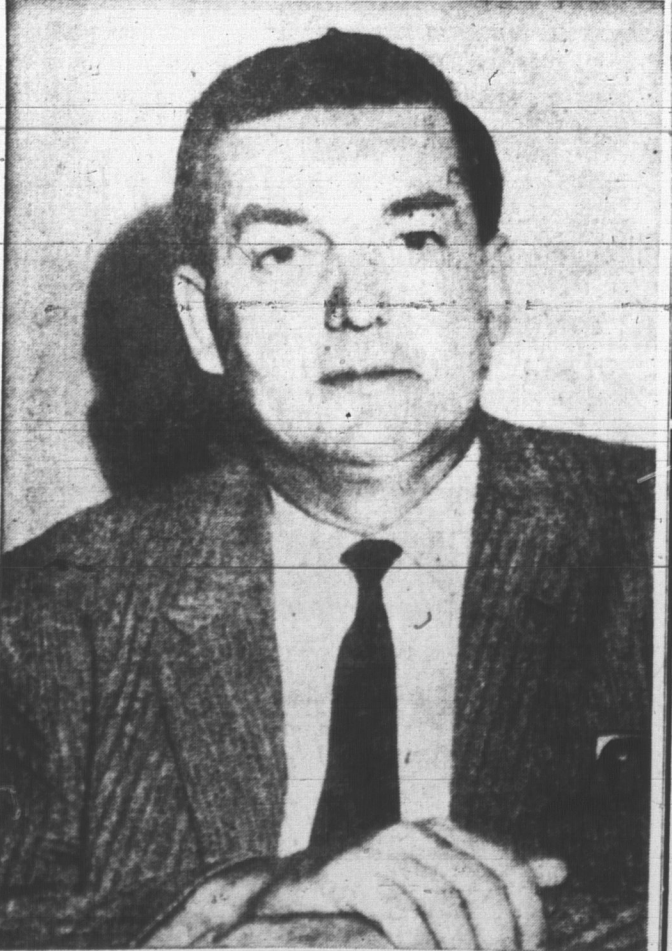

Three Oil Holes Are Scheduled Off Sable Island

CALGARY (CP) — Socony Mobile Oil of Canada Ltd. says it plans to drill three coreholes this month in an Atlantic petroleum exploration program about 40 miles east of Sable Island and 180 miles east of Halifax.

Socony Mobil has held exploration permits off the coast of Nova Scotia since 1959. Other oil companies such as Shell Canada Ltd. and Pan American Petroleum Corp. have already carried out exploratory drilling work.

A Socony spokesman says the coreholes, to gain samples of the ocean floor, will be drilled from boats.

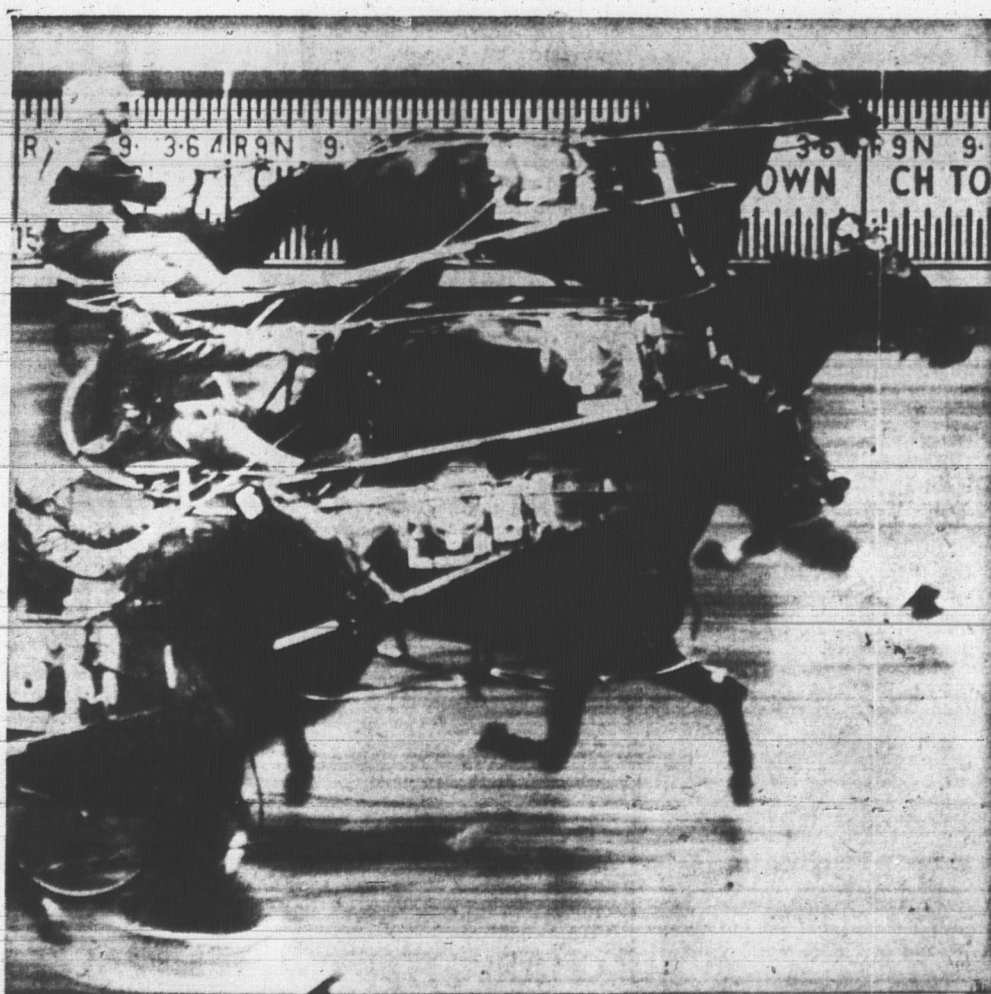
