well as the rich, and I cannot see any reasonable objection to it. I think, however, that there should be a little more time given to the Sheriff to get in the poll. Hon. Mr. HENDERSON: I do not wish to protract the discussion, though I am glad to hear the subject well discussed. It is our duty to discuss it well; but, calmly listening to your experienced honours, I must say that my vote is in favor of the present law. Yea, 10. Nays, 10. Hon. Messrs. McDonald, Dingwell and Walker—3. Non-Contents—Hon. Messrs. Attorney General, Anderson, Ramsay and Beer—4. So the amendment was lost, and the question was put on the main motion which passed in the affirmative.

APPROPRIATION BILL. The appropriation bill was then read a second time and committed—Hon. Mr. Walker proposed an amendment that a grant of £80 for wharfage for the mail steamers at Brule, but, after some desultory debate, it was agreed to.

Respecting a grant of £234 for Poplar Island Bridge, Hon. Attorney General remarked that it was contemplated to construct a new bridge at the North River, in substitution of the one for which this grant was given; therefore the impolicy of giving large grants to the present bridge was evident. A bridge, said his honor, at the North River River would be an almost incalculable advantage to the people on the South side of the Island between Charlottetown and Bonaventure.
