Hotel Inquiry Concluded—Judge Sedgewick's Estate Entere For Probated.

OTTAWA, Sept. 21—(Special)—Sir Wilfrid this evening was the guest of Adelle Frechette, when he met the distinguished American man of letters William Dean Howells. Inquiry into the Gilmore Hotel fire has been completed. Only three bodies were found. One was identified as Miss O'Neil, Ottawa, another Miss Loveloy, Peterboro, while the third body was that of a woman burned beyond the possibility of identification. It is believed to be that Mrs. Brechet, milliner, Ottawa, who has been missing since the fire and who made her home at the Gilmore. The estate of the late Judge Sedgewick of the Supreme Court has been entered for probate at \$17,000.

EXPRESS ROBBED ON THE TRAIN

Trust Absorption and a Rake-off Before the Insurance Commission.

TORONTO, Sept. 21—(Special)—A robbery of express packages containing \$1,600 reported by the Dominion Express Co. took place Wednesday night on the Canadian express Owen Sound to Toronto. The rake off in connection with the absorption of the Provincial Trust Co. by the Union Trust Co. were brought out by Mr. Shepley in his inquiry into Foresters affairs before the Insurance Commission this morning. MEIKLE'S DEATH MAY BE MURDER

BORSTON, Sept. 21—(Special)—The death of Charles S. G. Meikle, of Lynn, formerly of Charlottetown, Nov. 7, 1905, is to be investigated by the grand jury. Meikle was shot and killed in his home by his own hand apparently, but the state police and his brother in P. E. Island were not satisfied that the case was not one of murder, and after some agitation the District Attorney of Essex Co. has decided to lay the evidence before the grand jury. The only person in the house at the time of the shooting was Edgar, the 14 year old son of the dead man. The Lynn police declare that it is a clear case of suicide.

CAPTAIN SHOTS MATE, AMHERST

AMHERST, N. S., Sept. 20.—Amherst has been somewhat elated of late, considering herself quite an important shipping point, several vessels have discharged at the new pier—Fort Lawrence. Word comes from there today of a serious row afloat on the schooner Ann L. Lockwood, in which the captain drew a revolver, shooting the mate in the breast about two inches from the heart. Although not a serious wound the mate had an unusually close call. No arrests were made, the matter having been settled among themselves.

NEW JUDGE TO BE WESTERN MAN

And Must Be Appointed Before Supreme Court Meets, Oct. 2.

OTTAWA, September 21—(Special)—The Minister of Justice will be in the city tomorrow to attend a meeting of the Cabinet. It will be necessary to appoint at once a judge for the Supreme Court in place of the late Judge Sedgewick. The court meets on Oct. 2nd and it is possible Chief Justice Fitzpatrick may not be able to sit on some cases. It is almost certain that the new judge will come from British Columbia. Justice Duff, of the Supreme Court of British Columbia is said to be the first choice of the province, and he is therefore likely to get the position. There are some applicants from the eastern provin as but it is said the West will have the first call. There is also a vacancy in Ontario to take the place of the late Judge Street which will have to be filled soon.

CARGO OF RAILS FOR G.T. PACIFIC

QUEBEC, Sept. 20—The first cargo comprising 1,500 tons of eighty pound steel rails for the transcontinental railway has arrived from Sydney N. S., by the steamer Fos are being landed on the Quebec and Lake St. John Railway dock. It is said that 20,000 tons of rails destined for the construction of the eastern section of the new transcontinental railway from the Quebec bridge site at Cape Rouge to La Tague will arrive at this port from Sydney before the close of navigation. In the meantime satisfactory progress is being made by the contractors on the construction, especially on the section in charge of M. P. Davis, who has all the labor he needs and expects to complete his contract of fifty miles and have trains running in two years time. The Transcontinental Railway Commission is using every effort to have the whole line under their control from Winnipeg to Moncton under way as soon as possible in order that the whole of the eastern section will be completed within the prescribed time and all the sections that they are interested in will be completed and trains running four years hence.

DOINGS OF THE CONFERENCE

Some Difficulties Settled and Officers Elected Delegations Received From Baptist and Congregational—A Minister Who Was Not Born in Sin, as He Affirms.

MONTREAL, Sept. 21—(Special)—Rev. Wm. Dobson conducted the opening exercises last night. Delegations were received from the Lord's Day Alliance and Baptist and Congregational bodies. Dr. Potts and Rev. T. A. Moore spoke strongly in favour of the Lord's Day Alliance Act and gave Sir Wilfrid and his supporters great credit for what they had done. Chancellor Burwash introduced Rev. Gordon, representing Baptist churches and Hugh Hedley, Congregational Union who conveyed the good wishes of their churches. The Conference adopted the suggestion of Dr. Sutherland to the relief of everybody by a special meeting of the committee last night. A resolution was moved and seconded by the leaders of opposing parties of yesterday.

The compromise is this, that there be one board and one fund; that the work have two departments, home and foreign; that there be two general secretaries of equal authority; that there be two field secretaries and that the treasurer be a layman; that the office be honorary and that a sub-treasurer have control of office detail. At the election of General Conference officers for Clerical Treasurer of the superannuation fund Dr. Griffin, (Rev. J. T. Ritcher refused to run,) Lay Treasurer, Mr. Gurney. The Treasurer of the supernumerary fund are Drs. Evans, and Paisley; Western Book Steward, Dr. Briggs; Eastern Book Steward, Dr. Huestis. Prof. Workman, known as the author of many works, said that the phrase, "all men are born in sin" is false. He was not born in sin, and the ritual as it stands teaches baptismal regeneration.

JAPAN THANKS THE DOMINION

OTTAWA, Sept. 20—The expression of Japan's gratitude for Canada's contribution of twenty thousand dollars worth of flour has arrived at Ottawa. It was forwarded by Sir Clouston O'Connell, who received it from Prefecture Fukuoka. The message was drawn up and signed by the heads of sixteen Japanese villages. It is as follows: "The great amount of cereal flour which the Canadian Government has in such a generous manner contributed towards the relief of the sufferers by famine in the northeastern districts of Japan, has been from time to time distributed amongst the wards and villages and the recipients of relief have at each occasion expressed their feeling of deep gratitude towards the generous donors. Owing to our duties, but we now beg on behalf of the wards and villages to express the most heartfelt thanks. We have the honor to request that your excellency will be kind enough to convey this expression of our feelings to the Canadian Government. The Canadian Government has been invited to make a showing at an exhibition to be held in the agricultural hall, Westminster next spring.

THREE KILLED BY EXPLOSION

FORT WILLIAM, Ont., Sept. 20—Three men are dead and eight injured as a result of an explosion of a dynamite cap yesterday in the Grand Trunk Pacific tunnel at Finmark. The dead are Peter Venttilanen, thirty-three years, Henry Parviainen, twenty-two years, Nestor Rajala, forty-eight years. The injured men have been taken to the private hospital of Foley Bros., at Kamistiquia, and all will recover. The laborers employed at the tunnel were engaged in removing debris that had been blasted from a cut on the previous day when the cartridge went off. Charles J. Johnston, foreman, had his left arm blown completely from his body.

PALMA WILL NOT COMPROMISE

HAVANA, September 19.—In the course of the conversation of the American secretaries with President Palma at the palace this morning, Messrs. Taft and Bacon subscribed to the sentiments set forth in President Roosevelt's letter and expressed the hope that their visit would contribute to the establishment of peace. In reply to the question by Messrs. Taft and Bacon, President Palma reviewed the various aspects of the electoral problem in Cuba. Asked whether the government had taken steps to effect a compromise the president replied in the negative, saying that the government had limited itself to assisting the efforts of the veterans without taking an active part in the negotiations. Secretary Taft then asked if any revolutionary demands had been directly affected by these negotiations? President Palma said in reply that the programme of the revolutionists included the absolute annulment of the last elections and that, if by compromise it should be agreed to hold partially new elections, he (Palma) would no longer continue as executive because his prestige would suffer, and to do so would be a drawback to a constitutional form of government. Referring to the efforts being made to bring about peace, President Palma said he had left that matter to the political parties. On receipt of President Roosevelt's letter the government had limited itself to suspension of hostilities. The president added that in his judgment congress should pass an electoral law which would amply guarantee both parties, also a municipal election law under which elections would be held next January, the government to preserve strict impartiality.
