# Union Bucks Arbitration Plans Sign SEATO Pact; Is Aimed At Reds

MONTREAL (CP)—Union chiefs of 145,000 railwaymen Wednesday bucked against government suggestions as to the method of arbitration in their multi-million dollar contract dispute with Canadian carriers.

The top representatives of the non-operating employees — those who do not actually run the trains — met in a day-long session and then sent a telegram to Labor Minister Gregg asking for another

## Prospects Good For Protection Against Polio

ROME, (AP)—Three American leaders in the war on polio Wednesday reported prospects are good for a vaccine that eventually may give long protection against the disease.

Dr. Jonas E. Salk, whose vaccine already has been given to 425,000 U. S. school children in a massive field trial, said long-term immunity may soon be possible with a few injections.

Another, Dr. Albert B. Sabin, said some possibly remote days—but not yet—a doctor may give a baby a few drops of vaccine and thereby immunize him for life.

The third, Dr. John F. Enders, said new techniques are helping science make rapid advances toward the development of specific prophylactics for the control of the disease.

## Reject Protests

MOSCOW, (Reuters)—Russia Wednesday night rejected United States protests about the shooting down of a U. S. Navy patrol bomber by Soviet fighters off the Siberian coast Saturday, and hinted that the plane deliberately violated Russian territory on orders from "the American military command."

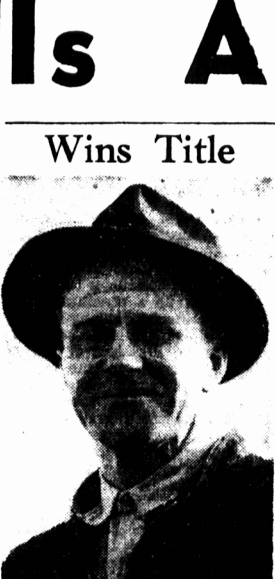
