

Infantrymen Slog In Heavy Rain In Exercise Closing

CAMP GAGETOWN, N.B. (CP)—The infantrymen, as usual, led a dog's life here Thursday. It was raining hard in the Canadian Infantry Division pushed off on the final phase of Exercise Rising Star.

Without ponchos or any protection except their bush uniforms, the footsloggers tramped through soaking fogs and hedges. And weapon pits were partly filled with water.

Inquest At Georgetown In Recent Highway Death

A coroner's jury last night found that "Leo Douglas Sheppard" came to his death on the evening of July 26, 1955, as the result of injuries received by the overturning of a truck at Mitchell River, Kings County, and that the said truck was driven by Roderick Jeremiah Steele of Cardigan, P. E. I.

The inquest was held at the Georgetown Court House with Coroner Dr. G. S. A. Roman of Montague presiding. Mr. J. Nicholson, crown prosecutor for King's, represented the Crown, and Mr. Somerville, trainer represented Mr. Steele.

Dr. Lemuel Prowse, the first witness, stated that he had performed the post mortem, and that he had found burns on the chest, back, thighs and arms of the deceased. The body was about 40 per cent burned. There was blood in the abdominal cavity caused from lacerations of the spleen. There was also hemorrhage outside the abdominal cavity. A fracture of the pelvis. Multiple areas of contusions on the lungs. Death, he said, was due to internal hemorrhage and shock.

Constable Gordon Humphrey, R. C. M. P. in charge of the identification branch, stated he had been called to the scene of the accident on July 29. He took photos and measurements. He identified the photos he had taken and explained them. He also introduced a sketch of the area and explained it.

Charles Herman McLellan, Cardigan, said he was with Steele at the time of the accident. He saw him about 10 a.m. of that day. He was at Jack Sullivan's forge. He and Steele went to the village of Cardigan in Steele's truck, and Steele went to the vendor's and bought a quart of wine. Steele drank it, and he (McLellan) went home. He said that he saw Steele again about 2 p.m. at Acorn's garage at Cardigan. Steele was with Carl Cronin. He and Steele went to Steele's truck and drove to Vendor's, where Steele got two quarts of wine. The three of them drank some of the wine. The had supper at Cronin's, the witness said, and then left for Cardigan. They went to Michael Sullivan's at Rosemeath, drank some wine there, and the four then left for Adrian Sullivan's at Cardigan. They picked up Adrian Sullivan and went to a restaurant at Cardigan where they picked up three girls, and all eight seated in the cab. They left for the dance between 9:30 and 10 p.m. Douglas Sheppard and Urban McLellan were on the back of the truck, that Steele was driving the truck to the dance. On the way, he said, they picked up Joseph Campbell.

After picking him up, and then going a short distance, the truck went in the ditch and rolled over. On questioning by the prosecutor, the witness said that the truck was being driven "good" and that he did not notice any slewing. He said he was knocked out when he came to the others were putting the truck up on its wheels. He saw Douglas Sheppard under the cab. Someone he said, went to the telephone to get police. A truck driven by George MacPhee came along and they put Sheppard on the truck and he was taken to Father O'Hanley's at Cardigan who took the boy to the hospital at Montague.

The witness said that he did not come to the hospital but had come back to the scene of the accident. He said that the weather was foggy but he did not know if it was enough to obstruct the view. He said that three bottles of wine had been consumed during the day.

Michael Sullivan, Rosemeath, said that on July 28, Steele, McLellan and Cronin had come to his house. They had stayed about a half hour and had a bottle of wine. They went to Poole Garvine for gas, then they went to pick up Adrian Sullivan at Cardigan. He said that he drove the truck to Adrian's house. Later the five of them went to Peter MacAnlay's home where they remained for some time, and then they went to the restaurant where they met three girls.

They all got in the cab, and Douglas Sheppard and Urban McLellan got in the back of the truck. They then left for the dance and on the way picked up Joseph Campbell.

The witness said that he had two girls sitting on his knee, but that he could see by looking around the two of them. His first intimation of the

accident, he said, was when he heard bushes brushing going by the window, and he knew they were near the ditch. The truck then went in the ditch and rolled over. He had seen no other traffic, the witness said.

When the truck stopped, he was the first out and assisted the others to get out. He saw Sheppard after he had rolled back the truck. He (Sheppard) was between the door and the rear fender, and would be partly under the truck. He said that he stayed until help came, and accompanied George MacPhee with Douglas Sheppard back to Cardigan. He went to the hospital with Father O'Hanley, and was present when Dr. MacIntyre pronounced Sheppard dead. Sheppard was alive, he said, just after the accident, and he had felt his pulse.

Don Davis, Charlottetown, R. C. M. P., who was stationed at Montague at the time of the accident, stated that as a result of a phone call from Dr. MacIntyre he learned of the death of a young man at the hospital, Rev. J. P. O'Hanley, who was in his office, he said, and told him that the body of young Sheppard was in his car. Cpl. Davis said that he instructed him to take the body to the Montague Funeral Parlor. He stated that he asked who was driving the vehicle, and that Steele had said that he had driven it. He and Steele went to the office on the detachment and on arrival there the witness said that he could detect a strong odor of liquor from Steele's breath, and that he was unsteady on his feet and not normal. He called Const. Pettitt and Const. Fischel to come in as witnesses. That night, he said, he took only a verbal statement from Steele.

Const. Albert Fischel, RCMP, Charlottetown, stated that on July 26 he saw Steele at the office of the Montague detachment. He said that Steele's eyes were bloodshot, that he could smell a strong odor of liquor from his breath, and that he was unsteady on his feet. He and Const. Pettitt drove Steele to his home and on the way could smell the strong odor of liquor from his breath.

Beatrice Publicover, Georgetown, stated that she worked in Cardigan. She said that she saw Steele at 9 p.m. on July 28, when they came to the restaurant. MAY HAVE FALLEN ASLEEP
