The work requires a great deal of mental concentration and now he is wondering about the effects of his biological constitution and sex life (potentially). Just what is the same and what is different in this type of social imbalance?

As a practicing member of an orthodox Christian faith, he has lived according to the prescribed moral code, but he is plagued by increasing doubts as to the health insurance value of this course. Your cooperation, S.P. is much appreciated.

DEAR S.P.: As I get the pitch, this bachelor has a problem of emotional isolation from human relationships and social fellowship.

He probably has been committed, for as long as he can remember, to a narrow, unexciting life, but more recently has begun to take disturbing toll in the sense of well being.

As he of his allegedly very demanding type of work, I would surmise that he has drifted, by neurotic preference, into a line of work that seemed to compensate for his lack of friends - a job into which he could pour so much of his time, interest, effort and fancy that it added up to great satisfaction.

I wasn't, I think, that the job necessarily stood in the way of his making or keeping friends and having a normally active social life. Rather, it was a kind of work that helped him conceal from himself and others his tendency to be a timid, solitary character in a social sense, compared to the average gregarious fellow.

But now, as middle age draws his long, dormant, long camouflaged neurotic bias has begun to reassert itself as a sort of progressive emotionally crippling, that properly troubles him.
