## High Winds Hit Province; Montague Rink Wall Lost

Winds which oldtimers estimated at 70 to 85 miles per hour in gusts caused the south wall of the new Montague hockey and skating rink to collapse early Sunday morning.

High winds and snow flurries were prevalent in the area over the weekend and caused minor damage to shrubs, limbs of trees, and also caused considerable damage to the tri-amaran built and owned by John Williams of Beach Point. It was reported the wind caught the boat, flipped it onto wires and then fell to the ground upside down. Mr. Williams was not available for a report.

The rink wall which is insured will be replaced immediately and it is felt this will not hinder progress with the exception of a day or so.

### TWO ACCIDENTS

## Four Witnesses Called; Assault Hearing Opens

**SUMMERSIDE** — The preliminary hearing for Roy Sonier, Summerside, charged with the assault of Mrs. George Arsenault, causing her bodily harm, was begun in Town Police Court Saturday morning before Magistrate R.S. Hinton, Q.C. Accused, represented by G. Bruce MacDonaid, pleaded not guilty.

Crown prosecutor George R. McMillan, assisted by Town Police Chief Wannamaker, called four witnesses.

Summerside Police Cpl. Keith Chapman testified that he and Constable Ralph Hardy had answered a call to a Second Street home on the evening of Dec. 2, and on reaching the house had been told that Mrs. Arsenault was taken to hospital. They had returned to the police station and found Roy Sonier making a complaint. Mr. Sonier had stated that he had been driving Mrs. Arsenault home and that some third party had reached into his car and struck Mrs. Arsenault.

**FOUND STAINS** — The clothing of Sonier was stained with what appeared to Cpl. Chapman to be blood. The coroner then examined the car driven by Mr. Sonier and found on the window of the passenger side red smears which also, in the opinion of Cpl. Chapman, were blood stains.

Following this Cpl. Chapman had seen Mrs. Arsenault in hospital but had not questioned her extensively because she was injured and undergone medical treatment. On returning to the police station he had called Police Chief Wannamaker and then taken a statement from Sonier.

Dr. James L. Saunders, Summerside, stated he had been called to the Prince County Hospital on the night in question and had examined and treated Mrs. Arsenault for multiple scalp lacerations and a hand injury. X-rays later showed the hand injuries to be a broken fore-finger and a broken bone in the hand. Mrs. Arsenault had been conscious and calm. It had taken 30 stitches to repair the wound to the scalp.

**TRACES OF BLOOD** — Ruth Eileen Bell, on the staff of the RCMP Crime Detection Laboratory in Sackville in the serology department stated that the detection and determining origin of stains. She testified she had received several items of clothing from Chief Wannamaker on Dec. 9, and had examined them for traces of blood. She had detected traces of human blood of Group A on a t-shirt and several other clothing items,

and human blood of indeterminate origin on a pair of man's trousers.

Daisy Reid, R.N., of Summerside, stated that a blood specimen introduced into evidence by the Crown was one she had taken from Mrs. George Arsenault and given to Town Police Sergeant Harry MacKay.

The case was adjourned to Tuesday, Jan. 11.

## Angus Breeders May Employ Fieldman For Promotion Work

The Maritime Angus cattle breeders are examining the possibility of employing a part-time fieldman to promote the breed in the Maritime area. The effort was suggested by the Prince Edward Island breeders who attended the annual meeting in Amherst, N.S. Saturday, and enthusiastically received by the representatives from the other two provinces. The idea originated at the annual meeting of the P.E.I. Angus breeders association here on Thursday night.

The resolution noted the fact that promotion is now a basic business requirement, and suggested the services of a fieldman, should be acquired to better enable Maritime breeders to produce and display the best animals possible for sale purposes.

The meeting was presided over by Alex Lamond, Lower Sackville, N.S., who is the Canadian Angus Association president at the present time. Mr. Lamond was named Maritime director on the national association for the next three years.

A Mr. MacIntosh, Bath, Charlottetown, N.B., was named president; John N. (Jack) Kenny, Charlottetown, was named vice-president and Mrs. Flora MacEachern, Maugeville, N.B., was re-elected as secretary-treasurer.

Island Angus breeders attending the meeting in addition to Mr. Kenny included Andrew Johnstone and Clair Mayhew, Margate; Boyd Dixon, Clyde River; Frank Mutch, Cherry Valley and Mrs. George A. Campbell, Fortune.

Mr. Kenny said last night that the meeting decided that the provincial representatives would consult with their several executives to ascertain how much money they can contribute to the promotional effort, and then report back to the Maritime Angus executive.

Mr. Clair Mayhew and Mrs. Andrew Johnstone also attended the meeting with their husbands.

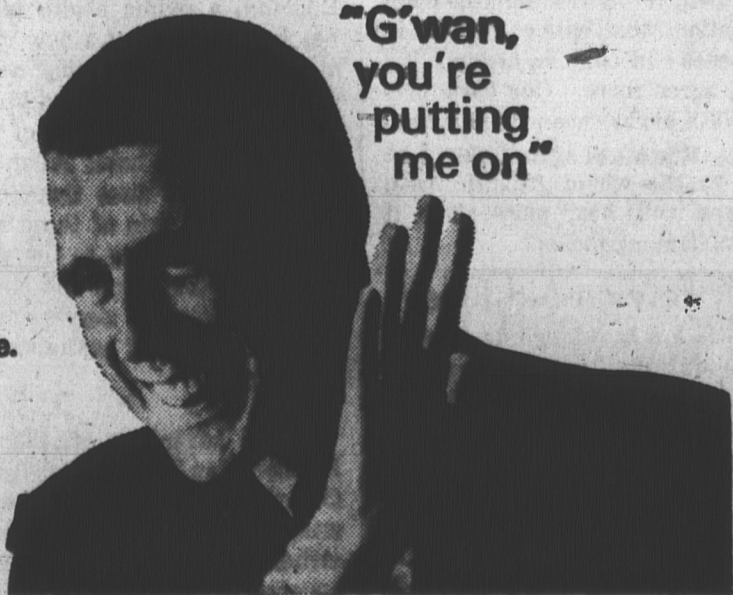

## Grits Must Find A 'Talker-Outer'

**OTTAWA** — Elevation of J.J. Greene to the post of agriculture minister means the Liberal party must find a new "talker-outer" among its back-bench MPs. A "talker-outer" is parliamentary parlance, is one of a small group of government members who are charged with talking-out private members' bills and resolutions when they come up for debate in the Commons. Mr. Greene was the government's chief debater in this role in the last session but will no longer be available in the new parliament opening Jan. 18.

Under parliamentary rules, certain hours are set aside each week as private members' hours when bills, resolutions and notices of motion sponsored by back-bench MPs are debated for a set period of time. If debate on a private bill concludes before the allotted time is up, the Speaker has no choice but to call for a vote. Rather than run the risk of a favorable vote on one sponsored by an opposition MP, the government quietly appoints a few of its members to keep the debate going until the adjournment hour is reached. Once this happens, the bill drops to the bottom of a long list and is unlikely to come up for debate again in the session.

**SUGGESTS UNFAIRNESS** — While the tactic suggests ruthless unfairness by the government, both Liberal and Conservative parties have adopted the measure of talking-out such bills.
