An Enlightened Protestant Opinion.

No Objection to Sir John Thompson Because He is a Roman Catholic.

TORONTO, Dec. 29.

The following interview with the Rev. Dr. Shaw, Professor in the Wesleyan Theological College and ex-President of the Montreal Methodist Conference, one of the leading divines in Canada, appears in the Empire:

"Have you any objection to stating your opinion of Dr. Douglas's attack on Sir John Thompson?"

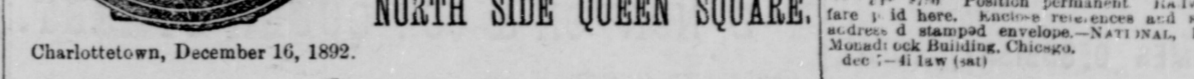
