

SAYS GOV'TS NEED MORE POWER

Original Members Resign From Potato Marketing Bd.

Three producer members of the newly formed Potato Marketing Board announced yesterday that they had resigned from the Board with resignations to become effective today. September 2, Mr. Donald A. MacDonald, former chairman of the Board along with Mr. Allie MacNeill of O'Leary and David Wright of Lower Montague have called it quits after serving for five years.

Mr. MacDonald said yesterday he felt that some of the resignations should be made known to the public. "It is our considered opinion that we cannot remain members of the new Potato Board and at the same time remain true to those principles to which we have always subscribed," he said.

After the plebiscite of November 10, 1954, the former Potato Board accepted the majority decision and proceeded to wind up the Selling Agency which had been established to merchandize the previous year's crop. The Board activities since that time have been confined to ordinary promotional work.

By-election In Toronto Spadina

OTTAWA (CP)—A by-election in Toronto Spadina will be held Oct. 24, a spokesman for the prime minister's office announced Friday.

The by-election will be held to fill the Commons vacancy caused by the appointment of David Croll, Liberal, to the Senate last July 28. Mr. Croll represented the constituency 10 years.

Prime Minister Sees Demands Increasing

OTTAWA, (CP)—Prime Minister St. Laurent says that if governments are to meet the growing demands made of them then it follows that the necessary powers must be made available.

"I think you will agree that there is a general tendency on the part of the citizens in all societies similar to ours to expect more and more of their governments, and particularly on the central government in the case of a federal system such as ours," he told a dinner meeting of the Canadian Bar Association Friday night.

"If those demands are to be met it naturally follows that the government has to be endowed with the necessary powers and financial means to make that possible."

The statements were included in a text of notes on his address issued to the press before delivery.

Mr. St. Laurent, a corporation lawyer and a former president of the CBA, said there seems to be an increasing body of opinion that feels the state should become directly involved in assuring the welfare of its individual citizens.

"Or at least," he added, "of those who do not seem to be able to look after themselves adequately."

"And when such a body of opinion in a democratic society represents the will of the majority of the population, the governments, if they are to remain democratic, have to take practical steps within the bounds of the constitution to carry out that will."

Taking note of a CBA section's motion criticizing the federal immigration department as holding undue powers, the prime minister said "we in the government have often been accused of concentrating power in our own hands."

There were those — "especially when they are in the opposition" — who felt it was the government's duty to curb any tendency toward centralization. But governments to day were increasingly called upon to increase services in the national interest.

Mr. St. Laurent made his remarks in the course of presenting, on behalf of the CBA, an honorary life membership to Lord Justice Sir Alfred Thompson Denning of the English appeal court.

He added: "It is generally agreed that this situation has brought about a tendency of increasing, with the dangers that ensue, the powers of the executive to act vigorously and expeditiously."

But he told some 1,000 lawyers and their wives at the white tie and evening gown gathering: "If we apply the spiritual treasures which we have inherited by the preservation and the development of the free enlightened society into which we have been born, we can be confident of meeting both the external and internal challenges to our continued freedom."

Seek Chinese In Conspiracy To Crash Plane

HONG KONG (AP)—Police announced today they are seeking a Chinese for conspiracy to cause the crash of a plane carrying Communist delegates to the Bandung conference last April.

A warrant charging a murder conspiracy was issued here but police said the Chinese had fled to Formosa, the Nationalist China base.

Communist China at the time charged the plane was sabotaged with a time bomb put aboard here in a misfired effort to murder Premier Chou En-lai.

British colonial police after long investigation identified the wanted Chinese as a man who worked as a coolie cleaning man in airlines stopping here.

Russian Experts Learn How To Become Wealthy

CHATHAM, Ont. (CP)—The Soviet farm leaders sat under a weeping willow tree on the spacious lawns of the Lawrence Kerr farm Friday and learned how a poor farmer, with scientific knowledge and initiative, could become wealthy under the free enterprise system.

It was a quiet day. RCMP, provincial and local police were on guard when the Russians entered the city in the morning and returned later for lunch. But there were only a handful of curious spectators and no demonstrations.

WANT TO STAY LONGER S. J. Chagnon, chief federal conducting officer, said later the Russians were so fascinated with the developments on the Kerr farm, two miles south of here, that they wanted to arrange to remain in the area to get further details on his farming methods.

Mr. Chagnon, in the past, had bowed to their wishes and changed plans at the last minute, but he suggested the nine delegates keep to their travel schedule so that they may spend the weekend in the Niagara peninsula and see the falls.

They leave for Niagara today to rejoin three companions they left behind in the United States when they first started on their Canadian tour Aug. 25.

STORY OF PROGRESS The 46-year-old Mr. Kerr, father of two children, told the Russians he first purchased 140 acres of land in 1935 and worked it with the help of one hired man. Now he has 1,050 acres and employs 12 men the year round, along with an additional five in the summer.

He grows wheat, sugar beets, soybeans, carrots and other vegetables for canning and raising some 300 to 500 head of cattle.

Immigration Down This Year, Figures Indicate

OTTAWA (CP)—Firm indication that immigration this year will be lower than in 1954 was given Friday as the government reported a drop of 27,000 in arrivals in the first half of the year.

The immigration department reported big reductions in three major sources of immigrants—the United Kingdom, Germany and the Netherlands—as immigration fell to 58,417 for the half-year, compared with 85,765 in the corresponding period in 1954.

Immigration officials said publicity abroad about Canada's seasonal unemployment last winter and the economic recovery of war-ravaged countries were the main causes for the lower number of immigrants.

There isn't as much economic urgency including immigrants to leave their homelands for Canada, an official said. Many now can find jobs and homes in their own countries.

BRITISH GROUP SLUMPS Arrivals from England, Ireland, Scotland and Wales dropped by almost 10,000, to 16,170. German arrivals declined to 8,112 from 14,119 and immigrants from the Netherlands skidded to 4,552 from 10,724.

The drop from Italy was less emphatic, as arrivals eased to 12,026 from 13,903.

The United States sent 4,531 immigrants to Canada, a slight increase from 4,558 last year. Ontario took the largest number of immigrants with 30,949, down from 47,101 last year, followed by Quebec with 11,488 down from 15,412.

Seat Belts For 1956 Chevrolet

DETROIT (AP)—Chevrolet Motors announced Friday it will make seat belts and shoulder harness optional accessories with its 1956 model cars.

Special kits containing factory-approved seat belt components will be made available through dealers. The kits will offer the belts or belt and shoulder harness combinations.

Anglicans Dispose Of One Major Topic, Start Second

EDMONTON (CP)—The "parliament" of the Anglican Church of Canada this week dealt with one and started on the second of some of the major topics on the agenda before it.

The 19th triennial session of the general synod approved almost unanimously a change of name for the body.

Tuesday the Church of England in Canada officially became the Anglican Church of Canada, when both the upper and lower houses of the synod approved the resolution almost unanimously.

Friday the synod started discussions on what is called by some delegates the major task before it—the revised Canadian Anglican Prayer Book.

EASTERNERS OPPOSED Approval of the change of name ended a 35-year conflict on the topic in the church. The change was opposed by delegates from Nova Scotia, Fredericton, Montreal and Newfoundland.

These delegates asked that the name be changed to the Episcopal Church of Canada to correspond with the name of the church's counterpart in the United States. A delegate from Victoria urged retention of the original name to give English immigrants a feeling "of home" when they arrived in Canada.
