HENRY CLARKE, Esq., manager of the Dunk River Hatchery, is in the city. He reports the recent freshet on Dunk River to have done a great deal of damage. All the mills are more or less injured. The hatchery was flooded with water four and a-half feet deep. Clear of slight injuries to the building, Mr. Clarke says the establishment escaped wonderfully.

OVER \$500 has been subscribed to the testimonial to Rev. W. G. Lane, who was fined \$200 in Halifax for performing a marriage ceremony before the issuance of a license. It will be presented at a mass meeting this week. The prosecution of Mr. Lane by J. W. Longley, on behalf of the Local Government, and has correspondingly decreased the popularity of his persecutors.

THREE survivors of the bark "Ada Barton," from St. John, N. B., for Glasgow, who were landed at Queenstown, Ireland, on the 22nd inst. by the steamer "Parkland," state that they clung to the masts five days and nights without food. On the third day a dog tried to devour one of them. When they were rescued they were casting lots to decide which of them should die to furnish food for the other two.

DROWNING ACCIDENT.—Two little girls, daughters of Richard Raymond and Captain Pearl Durfee, of Milton, Yarmouth County, N. S., met with their death in a most distressing manner on Saturday last. They were on the Milton pond, from which ice had been taken, and fell through a hole which had been left unmarked. One of the girls was partially suspended in the water by the cord of her sled through which her arm was drawn.

THE funeral of the late Miss Hettie Lewis took place from the residence of her grandfather—John Yeo, Esq.—to-day. It was attended by a large concourse of people. Miss Lewis' death was sudden and sudden. She contracted a cold while witnessing the fire on Wednesday morning, the 20th instant, and inflammation set in with fatal results. Miss Lewis was a general favorite, and was dearly beloved by all with whom she was acquainted. To her bereaved parent and family we tender our heartfelt sympathy.

FAILURE.—Business men, and the public generally, will be sorry to hear of the failure of the old and honorable firm of "Wm. Ives & Sons," Pictou, of which, for some years, Mr. C. W. Ives has been the sole member. The cause of the failure is, no doubt, the large amount which he lost by the Campbell Tannery smash, some fifteen months ago, and some wonder that he managed to avert the disaster so long. We have every reason to believe that Mr. Ives' conduct was strictly honorable, and that he fails without a cent in his pocket. His assignment is made to J. D. McLeod, Esq., Barrister, and bears date the 15th inst. The total liabilities are between \$50,000 and \$60,000 of which all but \$21,000 is due to the Banks. They hold an equity in a conveyance of all the real estate made to Mr. Watson Manager of the Pictou Bank, in trust, about a month or so after the Campbell failure. His assets, other than real estate, reach \$23,000, only about \$5,000 being book debts. The proceeds of the estate are to be applied as follows: 1st, expenses of winding up estate, 2nd, to pay in full in the order named the following persons, namely: His mother, Christiana Ives, his sister, Mrs. J. S. Harris, his brother, Geo. D. Ives, Isaac A. Grant, Edward McPhail, A. C. McDonald, Daniel Sutherland and Thomas Watson, claims amounting in all to \$11,000. 3rd, to pay in full, or as far as possible in equal proportion, all other creditors who sign, other than the banks. 4th, To pay any balance due the banks after realizing upon the realty.—Pictou News.

TELEGRAPHIC NEWS.

[SPECIAL DISPATCHES TO THE EXAMINER.]

The "Thunderer" on the Victoria Station Explosion.

LONDON, Feb. 27. The Times, referring to the explosion at the Victoria Railway Station, says: "It is clear that we have to deal with one of those cowardly outrages when by Irishmen arising that they are furthering the cause of Irish independence. We have in our midst a set of cowardly desperadoes who are not ashamed to abuse their freedom by reckless attacks upon life and property. The leaders of the Land League will do all to exert their influence with the dynamites to repress the outrages, since the British, however long suffering, will not tolerate the murder of innocent persons, but may supplement imperfection of legal machinery with exceedingly unpleasant reprisals upon Irishmen whose presence they now tolerate." The other papers animadvert strongly upon the supposed outrage in articles of practically the same tenor.

The Advance upon the Rebels.

CAIRO, Feb. 27. The advance of English troops on Tebe commenced before daylight to-day. Two hundred and fifty men were left to garrison Trinkital, and a force of 3,500 men advanced on the attack. It was expected that the battle would be fought about 9 o'clock in the morning. The naval brigade has joined General Graham with two nine-pounders. There is a growing anxiety in Cairo, about the result of the expedition, and less confidence is felt that the English will be the victors. The Black Troops at Saakin were found to be in communication with Ahmed Farcardi, second in command under Osman Digma and Admiral Hewitt, has forbidden them to leave camp, and has stationed the gunboats "Decco" and "Sphinx" so that their guns can command the camp with orders to open fire if any symptoms of mutiny are manifested.

The British Advancing.

TRINKITAL, Feb. 27. The beach presents a very lively appearance. The blue jackets up to their necks in water are landing stores and carrying soldiers ashore through the surf. The Gordon Highlanders and the Irish Fusiliers are advancing to occupy the fort erected by Baker Pasha. The distance to the fort is about four miles. It was built February 2nd to protect the guns while crossing morasses.

What the Rebels Intend.

TRINKITAL, Feb. 27. Arabi Bey, who was sent with a letter to Tokar, has returned. He says he was taken prisoner at Tokar. That the rebels intended last Friday, and that the rebels intend to fight in their lines closing on the rear of the British troops advance.

A Prey for the Rebels.

TRINKITAL, Feb. 27. The rebels regard with exultation the landing of the forces. They are convinced that Allah has sent all as a prey for them.

Massey was appointed Chief Inspector which carries with it the position of Secretary-Treasurer of the Board, and Mr. John H. Henry received the appointment of Sub-Inspector. Other appointments were postponed until the next meeting of the Board. Meeting at Murray Harbor South.

A meeting of the electors of Murray Harbor South and vicinity was held in the Public Hall, on the 4th inst., for the purpose of taking into consideration steam communication between this Island and the Mainland. The meeting was opened by appointing John Kelly, Esq., chairman, and the undersigned secretary.

The meeting was addressed by the Hon. Samuel Proves, Thos. Annear, and James Clow; also Messrs. Duncan Mann, Abraham Cook, James Cuddy, James Haberin, A. J. McInnis, Chas. Senabough, and Capt. J. W. Horton, in favor of the object of the meeting. After which the following resolutions were unanimously adopted:

Resolved, By the terms of Union, whereby this Island became part of the Dominion of Canada, it was stipulated that the Dominion Government should provide for the following service, viz: efficient steam service for the conveyance of mails and passengers to be established and maintained between Prince Edward Island and the Dominion, winter and summer, thus placing the Island in continuous communication with the Intercolonial Railway and the Railway system of the Dominion; Therefore Resolved, That those present pledge themselves to adopt any and every lawful means to enforce the fulfillment of the terms of Union.

Resolved, That in the opinion of this meeting some temporary communication with the Mainland must be provided for this Province by the Dominion Government, until the service as stipulated for by the Terms of Union are fully carried out, and that some means should be adopted to examine the route lying between Pictou and White Sands, as we believe the advantages of this route has only to be known to be appreciated.

He battled with the duties and temptations of life as a good soldier, and finally obtained a blessed victory, passing through all with an untarnished character. Mr. Holm has been for many years an elder in the Presbyterian congregations of Tryon and Bonshaw. Much and deservedly beloved by the people; highly respected by the whole community; and by his amiable disposition, true piety, and unostentatious manner, endeared himself to all who had the pleasure of his acquaintance.
