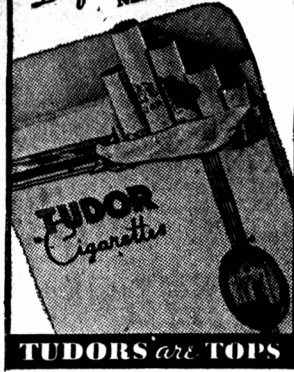

Lampeo Most Feared of Bandits

RIO DE JANEIRO, April 20—(A.P.)—Lampeo... Mention of the name strikes fear to the hearts of thousands of Brazilians who know, either first hand or by authenticated hearsay of him—perhaps the most terrible, ruthless bandit-killer of the western world.

Lampeo—His murders are so many they are unnumbered. His name is enough to send entire communities into hiding, for fear of their lives. His deeds shadow the most lurid gang crimes of Chicago and New York.

He is 36 years old now; a swarthy, sweaty, bespectacled dwarf. He was born in Villa Bella as Virgolino Ferreira da Silva; but today he signs his boasts, his threats and warnings simply "Virgolino Lampeo."

He rides over the arid wastes of Brazil's north-eastern hinterland at the head of a band of cut-throats, each as ruthless as he. For 20 years he and his men have lived behind the muzzles of their rifles, and for 20 years they have shouted challenge to the law. Sometimes Lampeo—swift on the tongues of women—cuts knife strokes which are the penalty for hasty words or are: sometimes the little brown man applies the whip to men, delighting in this practice, especially in the presence of his victims' wives.

Another typical Lampeo devilry is to raid a town, robbing and burning, and then compelling the leading citizens, women as well as men, to dance nude before him as the lash cracks and the guns of his men blaze.

The authorities would like to destroy Lampeo and smash his band, but the cost of an expedition large enough to track them down has always seemed too great.

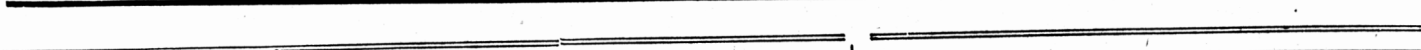

The Paradox Of Recovery

(The New York Times) The great paradox of American recovery is the rise of relief expenditures in the face of consistent and continuing improvement of the economic situation. Consider the changes of the last two years. Using in each case Government figures for the latest date available, and comparing them with corresponding figures of two years ago, we find:

- Industrial production up 26 per cent.
 - Construction contracts up 24 per cent.
 - Factory employment up 14 per cent.
 - Factory payrolls up 33 per cent.
 - National bank deposits up 41 per cent.
- Yet, despite these striking gains, the estimated expenditures of F.E.R.A., C.W.A., C.C.C. and W.P.A. for the first nine months of the current fiscal year have increased by approximately 40 per cent. over the same period two years ago. Business, employment, payrolls, bank deposits, all are rising—and relief costs are rising, too. The situation is precisely the opposite of what, by all rules of logic, it ought to be.

Farmers Refuse

Potato Prices

SARNIA, Ont., April 20—(C.P.)—Truckers were reported Saturday to be bidding \$1.25 wholesale for potatoes held by Sarnia district farmers. Most of the farmers are refusing the offers, it was said, hoping for higher prices. According to George French, manager of the St. Clair Vegetable Association, Detroit prices Saturday were \$1.75 a hundredweight for Michigan potatoes and \$2.84 for those grown in Maine.

The company is rushing work on this structure, which will increase its manufacturing facilities, and plans for a new storage unit are about complete. Engineers have designed a new power plant, for which boilers have been bought, and an additional stack is under contract. A new water system of magnitude is contemplated. Even without these additions, the establishment has for years been the world's largest Tomato Ketchup plant.
